NOTE 1 – DESCRIPTION OF PLAN

Orion Engineered Carbons 401(k) Savings Plan (the Plan) is a qualified retirement plan adopted by Orion Engineered Carbons (the Company) to enable eligible employees to save for retirement. The Plan was originally effective August 1, 2011, and amended effective January 1, 2024, to remove age and eligibility requirements as coverage in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the plan's provisions.

Eligibility: All full-time employees of the Company, excluding residents of Puerto Rico, leased employees, and nonresident aliens, are eligible to participate in the Plan as of the first day of employment.

Contributions: Participants may elect to defer a percentage of their eligible compensation into the Plan not to exceed an annual limit set by law. Participants may increase, decrease, suspend, or resume their contributions at any time. Participants who are projected to be age 50 or older by the end of the calendar year may defer additional amounts as catch-up contributions. The Plan also contains an automatic enrollment feature. The Plan's automatic enrollment contribution feature will begin for newly eligible participants 30 days after a participant's date of hire. A participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an increase of 1% each year until it reaches a maximum 10%. Participants may stop or change this automatic contribution at any time.

The Company has elected to make safe harbor matching contributions to the Plan in an amount equal to 100% of the first 2% of a participant's eligible compensation plus 75% of the next 4% of participant's eligible compensation that has been contributed to the Plan as deferral contributions. The Company may also make a discretionary nonelective contribution in an amount to be determined by the Company each plan year. For 2024, the Company did not make any discretionary nonelective contributions to the Plan.

Participants can also roll over part or all of an eligible distribution they received from an eligible retirement plan into this Plan as rollover contributions.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer discretionary nonelective contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: A participant is immediately fully vested with respect to the portion of their account attributable to their contributions, rollovers, and any plan earnings thereon. Employer matching contributions are subject to a two-year vesting schedule with participants becoming fully vested after completing two years of service. Employer discretionary nonelective contributions are subject to a five-year graded vesting schedule with participants becoming fully vested after completing five years of service.

Payment of Benefits: Participants are eligible to receive a distribution of the vested portion of their account in the Plan upon disability, retirement, or termination of employment. Participants may defer the receipt of their distribution if the vested account balance is greater than \$5,000. If the vested account balance is \$5,000 or less, the Company will direct the service provider that any amount exceeding \$1,000 be distributed to an IRA for their benefit. If the vested account balance is \$1,000 or less, the Company will direct the service provider to distribute it as a lump sum distribution.

In addition, upon reaching age 59½, participants may elect to withdraw all or a portion of their vested account balance while still employed by the Company as an in-service withdrawal. Hardship withdrawals may be made to satisfy certain specific and heavy financial needs that a participant may have.

Notes Receivable From Participants: Loans will be allowed for any purpose. The minimum loan is \$1,000 and the maximum amount is the lesser of one-half of a participant's vested account balance or \$50,000 reduced by the highest outstanding loan balance in a participant's account during the prior twelve-month period. Loans are adequately secured by the vested balance in the participant's account and bear a reasonable rate of interest. Loans are repaid in level payments through after-tax payroll deductions on at least a quarterly basis over a five-year period unless the loan is for the purchase of a principal residence in which case the loan repayment period may extend longer than five years.

Forfeitures: The non-vested portion of a terminated participant's account balance is retained in the Plan as a forfeiture. Forfeitures may first be used to pay administrative expenses. Any remaining amounts may be used to reduce future employer contributions payable under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$197,810 and \$136,086, respectively. During 2024, administrative expenses totaling \$39,211 were paid from forfeited non-vested accounts.

Plan Termination: The Company has no legal or contractual obligation to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%. The Company will facilitate the distribution of participants' account balances in single lump sum payments to each participant in accordance with Plan provisions until all assets have been distributed by the trustee.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through August 27, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks resulting from global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefit.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments. For the years ended December 31, 2024 and 2023, there were no transfers between Level 1 and Level 2, or between Level 2 and Level 3 fair value measurements.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Self-Directed Brokerage Account: Account primarily consists of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is a subsidiary of Fidelity Investments and is a service provider as defined by the Plan, and, therefore, these transactions and the Plan's payment of fees to the service provider qualify as party-in-interest investments. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
