**DECEMBER 31, 2024 AND 2023**

**1. Description of plan**

The following description of the **Ridewell Corporation 401(k) Plan** (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Ridewell Corporation (the Company) who have completed three months of service with the Company. For temporary employees, the service requirement is met upon the completion of the three-month period worked as a temporary employee for the Company.

The Plan was originally established on October 1, 1980. The Plan was amended and restated as of November 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company currently serves as the Plan trustee.

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) was enacted and was effective beginning on January 1, 2020. The SECURE Act provisions included, among other things, an increase in the age limit for required minimum distributions from age 70 ½ to 72. The Plan is in the process of operationally being amended to implement certain changes related to the SECURE Act. Written amendments to the Plan to reflect this operational change was adopted into the volume submitter profit sharing plan basic document from Fidelity as of September 29, 2022.

On March 27, 2020, the Coronavirus Aid, Relief and Economic Security (CARES) Act was enacted. The CARES Act provides immediate and temporary relief for eligible retirement plans and their participants who were adversely impacted by COVID-19. Effective for the 2020 Plan year, required minimum distributions may be waived temporarily for the 2020 calendar year under the CARES Act. Written amendments to the Plan to reflect this operational change was adopted into the volume submitter profit sharing plan basic document from Fidelity as of September 29, 2022.

Contributions

Each year, participants may contribute up to 75 percent of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Employee contributions are subject to certain limitations as limited by IRS regulations.

The Company also provided the following employer contributions:

Union employees covered by collective bargaining agreement

*Fixed rate contributions* - For eligible union participants covered by a collective bargaining agreement, the Company makes a fixed rate contribution based on a per hour basis as determined by the current collective bargaining agreement. The current collective bargaining agreement dated February 2, 2020, allows for a rate of \$2.00 per straight-time hour-paid for regular work, holiday, vacation, PTO, jury duty, and funeral leave.

Other employees not covered by collective bargaining agreement

*Safe harbor matching contributions* - The Company makes a matching contribution to all participants who are not covered by a collective bargaining agreement in an amount equal to 100 percent of the first 4 percent of compensation.

*Discretionary profit-sharing contribution* - The Company can elect to make a profit-sharing contribution to participants who have completed at least 1,000 hours of service and are employed on the last day of the year. Contributions shall be allocated based upon the ratio that eligible participant compensation bears to the compensation of all eligible employees within pre-established groups.

Participant accounts

Each participant's account is credited with the participant's contribution and Company matching contributions, as well as allocations of the Company's discretionary profit-sharing contribution and Plan earnings. Each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and their safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's fixed rate and discretionary profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five full years of credited service. Vesting begins at 20 percent after two full years of service.

Payments of benefits

On termination of service due to death, disability, retirement, or termination of service due to other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments, or partial withdrawals of his or her account. In addition, if a participant's account balance is less than \$1,000 then the account will be automatically cashed out and paid to the participant. If a participant's account balance is more than \$1,000 but less than \$5,000 then the account balance will be automatically rolled over to an individual retirement plan designated by the Plan Administrator.

The Plan allows participants to make in-service withdrawals at age 59 1/2, withdrawals for participants performing military service, and allows withdrawals of rollover contributions. Participants are allowed to make financial hardship withdrawals for all or part of their participant deferral account, including earnings on elective contributions, for immediate and severe financial need. Effective January 1, 2019, elective deferral contributions will not be suspended for six months following the date of the withdrawal.

Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$170,288 and \$158,283, respectively. These accounts will be used to reduce or add to future employer contributions. In 2024, \$148,197 from the forfeited non-vested accounts was used to fund a portion of the 2024 employer profit sharing contribution and employer fixed rate contributions. In 2023, \$140,000 from the forfeited non-vested accounts was used to fund a portion of the 2023 employer profit sharing contribution and employer fixed rate contributions.

**2. Summary of significant accounting policies**

This summary of significant accounting policies is presented to assist in understanding the Plan Administrator's financial statements. The financial statements and notes are representations of the Plan Administrator's management, which is responsible for their integrity and objectivity. In preparing financial statements, the Plan Administrator makes estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Some investment related expenses are included in net appreciation of fair value of investments

Subsequent events

The Plan has evaluated subsequent events through July 7, 2025, the date the financial statements were available to be issued.

**3. Fair value measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Observable inputs other than Level 1 process, such as quoted prices for similar assets or liabilities; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**4. Summary of certified information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Fidelity Management Trust Company for the years ended December 31, 2024 and 2023, that all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Plan's trustee.

**5. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

**6. Tax status**

The Plan was designed under a volume submitter profit sharing plan accepted by the Internal Revenue Service by a letter dated June 30, 2020, in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended and restated since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**7. Related party transactions and party-in-interest transactions**

Certain Plan investments are shares of funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

**8. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
