INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
Wisconsin Vision Associates, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Wisconsin Vision Associates, Inc. 401(k) Profit Sharing Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Wisconsin Vision Associates, Inc. 401(k) Profit Sharing Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 13, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Wisconsin Vision Associates, Inc. is the plan sponsor, employer and the plan administrator. Family Vision & Contact Lens Center, S.C. is a participating employer in the plan. Newport Trust Company is the plan trustee and agent that has custody of plan assets. Newport Group, Inc. is the third party administrator and recordkeeper that maintains participant records and tax counsel that performs various compliance tests. The two Newport entities are collectively referred to as "Newport". Wealth Enhancement Group is the plan's investment advisor.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. The net appreciation (depreciation) in fair value of investments bought, sold and held during the years is reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Self-directed brokerage accounts - The plan invests in self-directed brokerage accounts which consist of common stocks and exchange traded funds that are valued at the closing price reported in the active market in which the individual securities are traded, and mutual funds that are valued at the daily closing price as reported by the funds. Self-directed brokerage accounts held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Mutual funds - The plan invests in mutual funds that are valued at the daily closing price as reported by the funds. The funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily NAV and are deemed to be actively traded.

Common/collective trust - The plan invests in the Reliance Trust Company Stable Value Collective Investment Trust ("the fund") which is a direct filing entity. The fund invests entirely in the MetLife Group Annuity Contract. The primary objective of the common/collective trust is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The common/collective trust is valued at NAV based on the underlying unit value as reported by the common/collective trust. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the common/collective trust will sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan documents for more complete information.

General - The plan was established as a defined contribution plan on January 1, 1989. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees are eligible once they have completed one year of service and have reached age twenty-one. An employee can enter the plan on the first day of the quarter immediately following the date the plan's eligibility requirements are met.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (employee elective deferral contributions). The plan also permits Roth elective deferral contributions.
- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. The employer makes matching contributions equal to 50% of the first 20% of the employee's compensation contributed to the plan as employee elective deferral contributions. The contributions are funding coinciding with each payroll.
- d. The employer may also make additional nonelective contributions at its discretion. No such contributions were made in 2024 or 2023.

Participant accounts - Each participant's account is credited with the employee's elective deferral contributions, rollover contributions and an allocation of the employer's contributions. Earnings, including the appreciation or depreciation, are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Participants are allowed to transfer funds between the various investment options daily and change their deferral percentage on a monthly basis.

Vesting - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon two full years of service, at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Upon death, disability or attainment of qualified retirement age while employed participants become 100% vested.

Forfeitures - Forfeited nonvested accounts are allocated to the remaining participants or are used to reduce the amount of the employer's contributions or pay plan expenses. There were \$30,000 of forfeitures used in 2024 and \$39,000 used in 2023 to offset administrative expenses. Unapplied forfeitures were \$16,000 and \$21,000 as of December 31, 2024 and 2023.

Payment of benefits - Benefit payments are recorded when paid and may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions may be in the form of a single lump sum or installment payments. In addition, hardship withdrawals are permitted under the plan. In-service withdrawals of fully vested accounts may commence upon attaining age 59½.

Administrative fees - Certain administrative fees of the plan are paid by the employer. Certain other administrative fees are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution fees and nonparticipant directed charges for service, administrative and advisory fees. Nonparticipant directed charges, not paid using forfeitures, are allocated to the participants on an account value basis.

Notes receivable from participants - Loans to participants are not permitted under the plan.

3. PARTY-IN-INTEREST TRANSACTIONS

Newport is the trustee that holds custody of the plan's investments and maintains investment and participant records. As such, transactions with Newport qualify as party-in-interest transactions. The plan has an administrative services agreement with Newport in which Newport provides certain administrative services to the plan. Newport also receives revenue from the mutual fund service providers for services Newport provides to the funds. This revenue is used to offset certain amounts that would otherwise be owed to Newport for its administrative services to the plan. The plan pays Newport direct for certain other service fees that are not covered by the revenue sharing provisions of the administrative service agreement. These direct fees paid to Newport were \$46,000 and \$29,000 in 2024 and 2023.

All of these party-in-interest transactions are exempt from prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

5. INCOME TAX STATUS

The plan is operating under a Newport Group Inc. non-standardized pre-approved defined contribution plan that received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan. However, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain positions taken that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

6. INFORMATION CERTIFIED BY THE TRUSTEE

Management has obtained certifications from Newport, a qualified institution under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate:

- a. Investments held and the fair values of such as of December 31, 2024 and 2023;
- b. Dividends from mutual funds, net appreciation (depreciation) in fair value of investments and income from self-directed brokerage accounts for the years ended December 31, 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases and sales of investments, and interfund transfers between accounts during December 31, 2024 and 2023.
