## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
Swisslog Savings Plan for Salaried Employees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Swisslog Savings Plan for Salaried Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Swisslog Savings Plan for Salaried Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements Section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Swisslog Savings Plan for Salaried Employees and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Swisslog Savings Plan for Salaried Employees' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the 2024 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



#### 1. Description of Plan

---

The following description of the Swisslog Savings Plan for Salaried Employees (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

##### **General**

The Plan was established on January 1, 1990, and is a defined contribution plan covering all salaried employees of Translogic Corporation and Swisslog Logistics, Inc. (the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The administrative committee, as provided in the Plan agreement, is the Plan Administrator and has responsibility for the administration of the Plan. Principal Life Insurance Company (Principal Life); Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust); and Principal Life, on behalf of Principal Global Investors Trust Company (Principal Global), function as custodian and recordkeeper.

##### **Eligibility**

Employees are eligible to make elective deferrals and receive employer matching contributions on the earliest quarterly entry date after their date of hire.

##### **Contributions**

The Plan allows for Internal Revenue Code (IRC) Section 401(k) employee salary deferral contributions and basic safe harbor employer matching contributions. Participants may contribute up to 100% of eligible compensation on a pre-tax and/or Roth after-tax basis during the Plan year or the maximum allowed by the IRC (\$23,000 for the Plan year ended December 31, 2024). In addition, eligible employees age 50 and over may contribute “catch-up” contributions of \$7,500 in 2024. The Plan Sponsor implemented an automatic enrollment of 5%, and the contributions are automatically invested in the Principal Lifetime Portfolio accounts.

For the year ended December 31, 2024, the Plan Sponsor contributed a basic safe harbor match of 100% of participant contributions up to 3% of eligible compensation, and 50% of participant contributions over 3%, not to exceed 5% of the participant’s eligible compensation. The Plan Sponsor can also make additional discretionary contributions of up to 4% of active employee’s eligible compensation beginning on the first of the month following one year of service in which an employee is credited with at least 1,000 hours of service. For the year ended December 31, 2024, the total safe harbor match and 4% discretionary contributions amounted to \$2,031,442 and \$2,023,459, respectively.

Total annual additions under the Plan and all other savings plans sponsored by the Plan Sponsor are limited to the lesser of 100% of eligible compensation or \$76,500, including the catch-up provisions, per participant. Annual additions are defined as employee deferral contributions, employer matching contributions and additional employer discretionary contributions.

#### 1. Description of Plan (continued)

---

Under certain circumstances, participants may roll over an amount from another qualified retirement plan to the Plan. Rollover contributions made to the Plan for the year ended December 31, 2024 include total rollovers of \$164,902.

Hourly employees who become salaried employees may transfer their account balances into the Plan from the Plan Sponsor's Swisslog Savings Plan for Hourly Factory Employees.

#### **Participant Accounts**

Participant accounts are credited with participant elective contributions, matching employer contributions, discretionary employer contributions, and Plan earnings or losses on an account-by-account basis. Participants may choose how their elective deferral contributions, the employer matching contributions and the employer discretionary contributions are invested. Income or loss from each investment is allocated to each participant's account, based on the participant's account balance.

#### **Investment Options**

Participants may direct their accounts in various investment options including pooled separate accounts, a common collective trust and guaranteed interest accounts offered by the Plan's trustee, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal"), and registered investment companies.

#### **Vesting**

Participants are vested immediately in their elective deferral contributions, employer matching contributions and employer discretionary contributions plus actual earnings thereon.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear an interest rate based on commercial lending rates. Principal and interest is paid ratably through payroll deductions. These loans are subject to certain restrictions, as defined by the Plan document, and applicable restrictions under the IRC.

#### **Payment of Benefits**

A participant's entire balance in the Plan is payable upon death of the participant, upon attainment of normal retirement age or upon termination of service. A participant's benefit will be distributed as a single life payment or joint survivor payment. A participant can also elect to receive a lump-sum or direct rollover to a qualified IRA or another qualified plan.

#### **Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions and to terminate the Plan subject to provisions set forth in the Employee Retirement Income Security Act of 1974. Upon termination of the Plan, amounts credited to the individual participants' accounts are 100% vested.

## 2. Significant Accounting Policies

---

### **Basis of Presentation**

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with generally accepted accounting principles requires the Plan's administrators to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements, and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

The Plan's investments in pooled separate accounts, the common collective trust and registered investment companies are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The guaranteed interest accounts are not fully benefit-responsive and therefore are reported at fair value which is the value paid when funds are withdrawn prior to their maturity.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned on an accrual basis. Dividend income is recognized on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

The Plan's expenses are paid by either the Plan or the Plan Sponsor, as provided by the Plan Document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in the net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for the benefits.

### Risks and Uncertainties

The Plan provides for various investment options in pooled separate accounts, a common collective trust, guaranteed interest accounts, and registered investment companies. Investments, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risk.

Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## 3. Information Certified by the Trustee and Recordkeeper

---

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee and recordkeeper have certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments at fair value as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- The Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the Supplemental Schedule

## 4. Fair Value Measurements

---

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Inputs other than quoted prices that are observable for the asset or liability

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Guaranteed interest accounts:* valued at fair value using a discounted cash flow model, which considers the present value of future cash flows based on current market interest rates for similar-duration investments and the contract's crediting rate. Because the valuation is based on significant unobservable inputs, the contract is classified as a Level 3 investment in the fair value hierarchy.

*Pooled Separate Accounts and Common Collective Trust:* Valued at unit value which is calculated based on the net assets of the underlying investment or pool of securities.

*Investments in registered investment companies (mutual funds):* Valued at quoted market prices which represent the net asset value of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

---

**5. Guaranteed Investment Contract with Insurance Company**

---

The Plan invests in a group annuity contract with Principal Life Insurance Company that provides a guaranteed interest rate for a specified period of time. The contract is backed by the general account of the insurance company and provides for a guarantee of principal and a specified interest rate that is credited to participant accounts. The contract is considered non-benefit-responsive because withdrawals or transfers from the contract prior to the end of the guarantee period may be subject to a market value adjustment or surrender charge.

The fair value of the guaranteed investment contract represents the amount the Plan would receive if the contract were liquidated at year end, which may differ from contract value. Fair value is determined using a discounted cash flow model that considers current market interest rates for investments of similar duration and the contract's crediting rate. Because these valuations use significant unobservable inputs, the investment is classified within Level 3 of the fair value hierarchy.

#### **6. Related Party/Party-in-Interest Transactions**

---

Principal serves as the recordkeeper and trustee for the Plan and is considered a party-in-interest as defined by the Employee Retirement Income Security Act of 1974 (ERISA). Certain Plan investments are shares of pooled separate accounts and guaranteed interest accounts managed by Principal. There are no fees paid directly by the Plan for investment management services. Any management fees for the pooled separate and guaranteed interest accounts have been netted into the investment earnings for the Plan.

During December 31, 2024, the Plan incurred expenses related to general administration, including recordkeeping, trustee services, and participant support. These administrative expenses were deducted from Plan assets and remitted to Principal in accordance with the service agreement.

Total administrative expenses paid from Plan assets to Principal during the year amounted to \$137,691. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **7. Tax Status Events**

---

The Plan and its related trust were established under a prototype standardized agreement which has received a determination from the Internal Revenue Service that it qualified under section 401(a) of the IRC. A determination letter has been received dated June 20, 2020, stating the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, it is the opinion of the Plan administrator that the Plan as presently amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Subsequent Events**

---

The Plan Sponsor has evaluated events subsequent to December 31, 2024, through October 15, 2025, which is the date the financial statements were available to be issued. There have been no material events noted in this period which would impact the results reflected in this report, the Plan's results going forward or require additional disclosure.
