Opinion

Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Description of the Plan

Dakotas Areawide IBEW/NECA Vacation and Holiday Trust Fund (the Plan) was established effective January 1, 1978, pursuant to collective bargaining agreements between various affiliated local unions and the contractors' association. The Plan is a defined contribution vacation and holiday savings (welfare) plan subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is managed by a board of trustees consisting of an equal number of representatives from the local unions and the contractors' association.

The Plan covers members of the local unions employed under the terms of collective bargaining agreements with participating employers. Participants become eligible when their employer begins to make contributions to the Plan on their behalf under the terms of any applicable collective bargaining agreement.

Under current provisions of the Plan, an individual account is established for each participant. Participants' accounts are credited with contributions made on their behalf and are charged a monthly service fee. Participants are immediately 100% vested in all contributions to the Plan. The benefit to which a participant is entitled is the amount that can be provided from the participant's account.

Under current provisions of the Plan, participants are entitled to an annual vacation benefit payment on April 1 and a holiday benefit payment on November 1. During the year ended December 31, 2024, the Trustees approved a change in the payment of holiday benefits. Whereas previously, the amount of the holiday benefit was equal to one-third of the employer contributions received for the current Plan year, less administrative fees, under current provisions, the amount of the holiday check is equal to the participant's balance as of the October 15 preceding the November 1 payout. During the year ended December 31, 2024, the Trustees also approved a change in the payment of vacation benefits. Previously, on April 1 following the Plan year, the vacation benefit was equal to the amount of employer contributions made on their behalf during the previous Plan year, less administrative fees and holiday payments, plus any dividend determined by the Trustees. Under current provisions, the amount of the vacation check is equal to the participant's balance as of the March 15 preceding the April 1 payout. In addition, participants may receive hardship withdrawals, early distributions and weekly unemployment benefits, subject to the Plan's design for such distributions, less a service fee of \$5. Participants may withdraw the funds held in their account monthly, without regard to whether they are planning to take a vacation at the time that they withdraw the funds. Participants may request a distribution once per month in any amount up to the balance of their account at the time the distribution is requested.

Note 1. Description of the Plan (continued)

Dividends, as set at the discretion of the Trustees, are included in the vacation benefit checks issued in April of each year. Dividends are allocated based on an average of the participant's pro-rata account balance at the end of each calendar month during the preceding Plan year. Dividends allocated to participant accounts totaled \$70,525 and \$19,783 for the years ended December 31, 2024 and 2023, respectively.

A monthly service fee equal to \$2 per participant is charged to participants who have an account balance of \$25 or greater. This fee is used to pay administrative expenses of the Plan and amounted to \$43,224 and \$48,558 for the years ended December 31, 2024 and 2023, respectively. Net assets available for benefits include unallocated amounts totaling \$116,969 and \$71,265 at December 31, 2024 and 2023, respectively, which are available to pay administrative expenses of the Plan.

Participants should refer to the summary plan description for more complete information.

Note 2. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting.

Investments - Investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales of investments are reflected on a trade-date basis.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex dividend date.

Contributions Receivable - Employer contributions due and not paid at year end are recorded as contributions receivable. Employer contributions owed as a result of payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on wages earned or the number of hours worked in covered employment and the contribution rates currently in effect, as set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. Covered employment is primarily derived in the electrical industry within a jurisdiction primarily located in North Dakota and South Dakota.

Payment of Benefits - Benefit payments to participants are recorded upon distribution. Amounts allocated to participants who elected a withdrawal from the Plan but were not yet paid as of December 31, 2024 and 2023 amounted to \$96,109 and \$0, respectively.

Note 2. Summary of Significant Accounting Policies (continued)

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan.

Note 4. Tax Status

The Internal Revenue Service has advised that the trust established under the Plan is exempt under Section 501(c)(9) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. The Plan has been amended since receiving its notice of exemption. The Plan's administrator and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the Financial Accounting Standards Board Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The following describes the three levels of the fair value hierarchy.

Note 5. Fair Value Measurements (continued)

Basis of Fair Value Measurement

Level 1	Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities
Level 2	Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly
Level 3	Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

The Plan's investment in a mutual fund is classified within Level 1 of the fair value measurements hierarchy. The fair value of the mutual fund is determined by reference to the fund's underlying assets, which are principally short-term marketable fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Note 6. Concentrations

The Plan places its cash with financial institutions deemed to be creditworthy. Balances are insured by the Federal Deposit Insurance Corporation up to \$250,000 per financial institution. Although balances may at times exceed insured limits, the Plan believes its credit risk to be minimal.

The Plan has a significant portion of its assets invested in a short-term fixed income mutual fund, which represented approximately 55% and 80% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively. Because money market mutual funds aim to maintain a stable net asset value, typically pegged at \$1 per share, Plan management believes that the risk of changes in the fair value of this investment fund is minimal.

Note 7. Funding Policy

The Plan is primarily funded by employer contributions. Employer contributions are based on either a percentage of gross earnings or hours worked, as specified in the collective bargaining agreement. The percentage of gross earnings in effect during the years ended December 31, 2024 and 2023 ranged from 3% to 10%. The hourly contribution rates in effect during the years ended December 31, 2024 and 2023 ranged from \$1.38 to \$2.84.

Note 8. Related Organizations

The Plan is related to several local unions, a joint apprenticeship and training trust fund, a defined contribution retirement plan and a health care plan, all of which are tax-exempt.
