NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the Velocitor Solutions, LLC 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering essentially all employees of Velocitor Solutions, LLC (the “Company” or “Plan Sponsor”). The Plan was established on January 1, 2005 and was most recently amended and restated effective January 1, 2022 to comply with current laws and regulations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the Company, which serves without compensation. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The Company has outsourced the recordkeeping function of the Plan to John Hancock Life Insurance Company (U.S.A.) (the “qualified institution”).

Eligibility – All employees, excluding union employees, nonresident aliens, and leased employees are eligible to participate in the Plan when they have attained 18 years of age and have completed one month of eligibility service. Participants may enter the Plan immediately upon completing the eligibility requirements.

Contributions – Upon meeting eligibility requirements, eligible participants may elect to contribute up to 100% of their eligible compensation, as defined by the Plan, up to the maximum limits provided under the Internal Revenue Code (“IRC”) limitations within the Plan. The Plan allows participants to contribute to the Plan through pre-tax elective deferrals. Participants are permitted to make rollover contributions to the Plan.

The Plan has an automatic enrollment feature. Participants who do not state otherwise in writing automatically have three percent of eligible compensation deferred into the Plan each payroll period.

The Company may make a discretionary matching contribution, determined periodically by the Company, not to exceed a discretionary percentage of compensation or a discretionary dollar amount. The percentage or dollar amount will be determined by the Company on a uniform basis for all participants. For the year ended December 31, 2024, the Company elected to match 25% of the first 6% of elective deferrals. In addition to the discretionary matching contribution, the Company may contribute an additional profit-sharing amount. In order for an employee to receive the profit sharing contribution, they must be employed as of year-end. No discretionary profit-sharing contributions were made for the year ended December 31, 2024.

Catch-Up Contributions – For the year ended December 31, 2024, if a participant is eligible to make a deferral and turns 50 before the end of the calendar year, the participant may defer an additional \$7,500 into the Plan as a contribution subject to certain IRC limitations.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and charged with benefit payments, and allocations of Plan earnings or losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants are immediately vested in their elective deferrals plus actual earnings (losses) thereon. Vesting in the Company’s discretionary matching contribution and profit-sharing contribution, plus actual earnings (losses) is based on years of continuous service. Participants become vested in discretionary matching contributions and discretionary profit-sharing contributions at a rate of 20% per year after the second year of service and are 100% vested after six years of service. Participants become fully vested if employment terminates as a result of death or disability.

Note 1—Description of the Plan (continued)

Investment Options – Participants direct the investment of contributions into various investment options offered by the Plan. As of December 31, 2024, the Plan offers pooled separate accounts as investment options for participants. Participants may change or transfer their investment options at any time via telephone or the Internet.

Benefit Payments – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount, equal to the value of the participant's vested interest in their account, or in fixed payment installments. For termination of service for other reasons, distribution of the value of the participant's vested interest in their account will begin as soon as possible after the participant's request. If the value of the participant's vested account does not exceed \$5,000 at termination, the entire vested account shall be distributed as soon as administratively feasible following severance of employment. Withdrawals prior to attaining age 59½ are not permitted, except in the event of retirement, disability, or as a hardship distribution. Upon proof, to the satisfaction of the Plan Sponsor, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeited Accounts – As of December 31, 2024 and 2023, the balance of forfeited balances was \$3,009 and \$4,039, respectively. Forfeitures are retained in the Plan and may be applied to the payment of the Plan's administrative expenses or Company contributions to the Plan. During 2024, \$-0- was used to pay administrative expenses and \$18,167 was used to reduce Company contributions to the Plan.

Note 2—Significant accounting policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Benefit Payments – Benefit payments to participants are recorded upon distribution.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Certain fees related to loans and benefit payments are charged directly to the participant's account and are included in administrative expenses.

Investment Valuation and Income Recognition – Investments in the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP describes three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Pooled Separate Accounts – Pooled separate accounts invest mainly in domestic stocks. These assets are not available in an exchange or an active market; however, the fair value is determined based on the net asset value ("NAV") of the underlying assets as traded in an exchange or active market. The fair value of the pooled separate accounts is stated at NAV as a practical expedient.

Money Market Funds – Money market funds are short-term, United States dollar-dominated obligations issued or guaranteed by the U.S. Treasury. The money market funds are valued based on the amount of cash balances on deposit, which approximates fair value. Accordingly, the money market funds are classified within Level 2 of the valuation hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There was no change in valuation methodologies during the year ended December 31, 2024.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

Risks and Uncertainties – Investment securities, in general, are subject to various risks, such as interest rate, credit, and overall market volatility. Due to the levels of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Note 5—Party-in-interest transactions

Certain Plan assets are invested in funds managed by the qualified institution. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL's Rules and Regulations. Fees incurred by the Plan for investment management services are paid directly by the Plan and, therefore, also qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid by the Plan and deducted from participant accounts for contract administrative expenses amounted to \$66,100 for the year then ended December 31, 2024 and are included in administrative expenses on the accompanying statement of changes in net assets available for benefits.

Note 6—Tax status

The Company adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the IRS on June 30, 2020, which stated the Plan is designed in accordance with applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan has not received a determination letter specific to the Plan itself and the Plan has been amended since the prototype plan received the opinion letter; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Company believes the Plan has no income subject to unrelated business income tax and, therefore, continues to be tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
