NOTE 1: DESCRIPTION OF PLAN

Wellscope Insurance Group, Inc. (the Company) sponsors the Wellscope Insurance Group Employer Welfare Arrangement (the Plan) on behalf of the employees of the participating employers (the Employers). The following brief description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a multiple employer welfare arrangement (MEWA) which provides health benefits to eligible employees of the Employers and covered dependents, except for leased employees, independent contractors, temporary employees, casual employees, and employees covered under a collective bargaining agreement.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Nonexcluded full-time employees who are regularly scheduled to work an average of at least 30 hours per week are eligible to participate in the Plan. Eligible employees may enter the Plan on the first day of the month after completing 30 days of continuous service.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections determined annually by the individual employers. The employers may contribute toward the premium payments due pursuant to the insurance contract. The amount of premium contributions shall be determined by the employers, in their complete discretion, annually through their agreement entered into with the Company.

Insured Benefits

The Plan's medical, prescription drug, dental, vision and ancillary benefits are fully insured. The Company purchases annual insurance contracts for these benefits and premiums for these policies are paid by the Plan as funded by participant and employer contributions. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to insurance brokers and professional service providers.

Termination of the Plan

Although they have not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

Termination of the Plan (Continued)

In the event of termination of the Plan, assets held in the trust established under the Plan will be applied in a uniform and nondiscriminatory manner toward the provision of the benefits for or on account of the participants. No assets of the Plan may revert to the Employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Benefit Payments

Premiums paid by the Plan for fully insured benefits are recorded as premiums paid in the accompanying statement of changes in net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3: CONCENTRATION OF CREDIT RISK

The Plan maintains bank deposits in a commercial bank account which at times may be in excess of the Federal Deposit Insurance Corporation's insured limits. The Plan has not experienced any losses in such account. Plan management believes that it is not exposed to any significant credit risk on noninterest bearing cash.
