Independent Auditors' Report

Board of Directors
New England Automobile Dealers Insurance Trust

Opinion

We have audited the accompanying consolidated financial statements of New England Automobile Dealers Insurance Trust (the "Trust"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA") which comprise the consolidated statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related consolidated statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the consolidated financial statements.

In our opinion, the consolidated financial statements referred to above present fairly, in all material respects, the net assets available for benefits of New England Automobile Dealers Insurance Trust as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with the modified cash basis of accounting as described in Note 1 to the consolidated financial statements.


Auditors' Responsibilities for the Audit of the Consolidated Financial Statements

Note 1 – Organization and Activities

The New England Automobile Dealers Insurance Trust is a not-for-profit organization providing insurance coverage for the employees of participating automobile dealers and other related businesses throughout New England. The Trust contracts with insurance companies to provide life and dental insurance at a favorable group rate, not otherwise available to the individual companies. The Trust also serves as a liaison between participating members and the insurance companies in the daily administration of their benefit plans.

The New England Automobile Dealers Insurance Trust, a health and welfare benefit plan (the “Plan”) is subject to provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code, established in 1950. The Plan is administered by the Trust.

Note 2 – Summary of Significant Accounting Policies

Reporting Entity and Basis of Presentation – The accompanying consolidated financial statements include the accounts of New England Automobile Dealers Insurance Trust and its wholly-owned subsidiary, New England Automobile Dealers Insurance, LLC (the “LLC”), together herein referred to as the (“Trust”). The LLC was organized in May of 2005 for the principal purpose of purchasing, acquiring and obtaining insurance for the Trust. All significant intercompany balances and transactions have been eliminated in consolidation.

Basis of Accounting - The Trust prepares its consolidated financial statements in accordance with the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. The primary differences relate to the recognition of commission receipts which are recognized when received rather than when earned and recognition of right-of-use assets and lease liability, which are required by Generally Accepted Accounting Principles.

Accounting Estimates – The preparation of consolidated financial statements in conformity with the modified cash basis of accounting may require management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein: at the date of the consolidated financial statements. Actual results could differ from those estimates.

Eligibility Requirements – Life Insurance: Participants must work at least 20 hours per week for an employer that is a member of the Trust’s qualified affiliation group as well as work in the automotive industry as determined by the insurance carrier in order to be eligible for insurance coverage.

Dental Insurance: All full-time and part-time participant employees are eligible to enroll in dental insurance coverage.

Other than the requirements mentioned above, eligibility is dependent on each employer’s terms of employment.

Cash and Cash Equivalents – For purposes of presentation in the consolidated statements of net assets available for benefits – modified cash basis, the Trust considers all highly-liquid investments with maturities of three months or less when purchased to be cash equivalents.

Note 2 – Summary of Significant Accounting Policies (Cont.)

Contribution Receivables - Represent amounts due from participating companies for insurance premiums purchased through the Trust. Receivables are stated at the amount the Trust expects to collect from outstanding balances. On a periodic basis, the Trust evaluates its contributions receivable and establishes an allowance for doubtful accounts, when deemed necessary. As of December 31, 2024 and 2023, the Trust did not have an allowance for doubtful accounts.

Property and Equipment – Property and equipment is recorded at cost at the time such assets are obtained. Depreciation is provided on the straight-line basis over the estimated useful lives of the assets, five years. It is the Trust’s policy to expense all purchases with useful lives not exceeding one year.

Insurance Premiums Payable – Insurance premiums payable represent premiums and any other outstanding billing adjustments due to the Trust’s insurance providers.

Advance Premiums Received – Represent insurance premiums collected in advance from participants.

Revenue and Expense Recognition -The Trust is responsible for billing and collecting insurance premiums from participating dealers and remitting premiums to the insurers. Premium revenue is recognized when billed to participants based on the premium payable to the insurance companies and includes an additional fee to cover the operating expenses of the Trust. Premiums on insurance policies are billed and collected on a monthly basis. The Trust receives commissions from the insurance carriers and, where applicable, pays a commission to insurance agents.

Advertising – The Trust charges the cost of advertising to expense as incurred. There were no such expenses for the years ended December 31, 2024 and 2023.

Income Tax Status – The Trust is exempt from federal income taxes in accordance with section 501(c)(9) of the Internal Revenue Code. The Trust is also exempt from Massachusetts state income taxes and, therefore, has made no provisions for federal or state income taxes in the accompanying consolidated financial statements.

Evaluation of Subsequent Events – Management evaluates subsequent events involving the Trust for potential recognition or disclosure in the accompanying consolidated financial statements – modified cash basis. Subsequent events are events or transactions that occurred after December 31, 2024 through October 15, 2025, the date these consolidated financial statements were available to be issued.

Note 3 – Property and Equipment

For the years ended December 31, 2024 depreciation expense was \$5,837 (there were no such expense for the year ended December 31, 2023).

Note 4 – Lease Commitment

The Trust leased its company vehicle under a non-cancelable operating lease. The lease began in May of 2022 requiring monthly rental payments of \$511 through April of 2024. Upon maturity in April of 2024 the vehicle was turned in.

Note 5 – Notes Payable

In April of 2024, the Trust entered into a three-year loan agreement with Ford Motor Credit Company for the purchase of a new vehicle. The loan is collateralized by the vehicle, and it requires monthly payments of \$1,342 through March of 2027.

Note 6 – Party-in-Interest

Under ERISA, parties-in-interest are defined to include the Plan sponsor, officers, directors and employees of the sponsor; direct and indirect owners of the sponsor and their relatives, if they have combined voting power of 50% or more; the Plan custodian or Trustees and the Plan administrator; other parties with fiduciary responsibilities; and a person and their relatives, or an organization that provides services to the Plan such as the Plan actuary, auditors, lawyers, investment advisors, etc. As disclosed in Note 7, the Plan has agreements with a Trustee and a third party who have fiduciary responsibilities, and therefore these transactions qualify as party-in-interest transactions. All of the party-in-interest transactions are exempt from the prohibited transactions Rules of ERISA

Note 7 – Financial Instruments, Credit Risk and Other Concentrations

Cash and Equivalents - The Trust maintains its cash and cash equivalents in a high-quality financial institution. At times during the year, cash balances may exceed the insured limits. At December 31, 2024, based on bank balances, the Trust's cash accounts exceeded FDIC insured limits by approximately \$45,300.

Concentration of Suppliers - The Trust is dependent on third-party insurance carries for its life and dental insurance policies. For the year ended December 31, 2024, dental and life insurance policies purchased from two insurance carries accounted for 98% (74% and 24%, respectively) of insurance premiums expense (for the year ended December 31, 2023 insurance purchased from the same two carries accounted for 98% of total insurance premiums). The Trust is dependent on the ability of its insurance carriers to provide insurance products on favorable pricing terms. The loss of certain principal carriers or a significant reduction in product availability from its principal carriers could have a material adverse effect on the Trust.

Administrative Services - The Trust received administrative services for premium billings, collections and remittance to the insurance carrier from an unrelated third party. Currently, the agreement, which is at will, provides for the service provider to receive a monthly fee plus an additional fee based on the number of participants covered by each insurance policy. Costs under this agreement for the years ended December 31, 2024 and 2023 were approximately \$111,300 and \$113,500, respectively.

Note 7 – Financial Instruments, Credit Risk and Other Concentrations (Cont.)

Employment Agreement - The Trust has an informal employment agreement with the managing trustee that provides for the managing trustee to receive 60% of select commission revenues earned. Compensation under this agreement, including wages, cost of health insurance and related taxes, for the years ended December 31, 2024 and 2023 were approximately \$55,100 and \$59,200, respectively.

Note 8 – Availability and Liquidity
