

### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of NV Energy Comprehensive Welfare Benefit and Cafeteria Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits and changes in benefit obligations for the years then ended and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and of benefit obligations of NV Energy Comprehensive Welfare Benefit and Cafeteria Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and the changes in benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### ***Basis for Opinion***

#### **Note 1 – Description of Plan**

The following description of the NV Energy Comprehensive Welfare Benefit and Cafeteria Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** – The Plan was established on March 1, 1979, and is a contributory plan, which provides health and other benefits to eligible employees, retirees, and covered dependents of NV Energy and its subsidiaries (the Company). The Employee Benefits Plans Administrative Committee has the overall responsibility for the operation and administration of the Plan. The Berkshire Hathaway Energy (BHE) Investment Committee is responsible for investment offerings and fund performance. Certain Plan assets are held in voluntary employees' beneficiary association (VEBA) trusts. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (the ERISA).

**Eligibility and Entry Date** – Management, professional, administrative, and technical (MPAT) employees, exclusive of those individuals employed on a temporary basis, who work at least 20 hours per week, are eligible for benefits at the time of commencement of their employment with the Company. Bargaining unit employees, exclusive of those individuals employed on a temporary basis, were covered by the Plan beginning January 1, 2001. Employees under the Local 1245 and Local 396 collective bargaining agreements, who work at least 20 hours per week, are eligible for benefits on the first day of the month following their hire date. Retiree benefits are provided for those retiring from the Company that have met certain age and years of service requirements as defined in the Company's defined benefit pension plan, NV Energy Retirement Plan. Eligibility varies further based on date of hire by the Company as well as employment class. MPAT employees hired prior to April 1, 2008, are eligible for retiree benefits; however, those hired subsequent to this date are not eligible for retiree benefits. For Local 396 and Local 1245 employees hired after October 13, 2008, and August 16, 2010, respectively, retiree benefit coverage is available only to age 65; whereas prior to these dates coverage extends beyond age 65.

**Benefits** – The Plan is a welfare benefit plan, which provides health and other benefits for participants and their dependents as specified in the plan document. Benefits include medical, prescription drug, vision, dental, life, accidental death and dismemberment (AD&D), short-term disability, long-term disability (LTD), health care and dependent care flexible spending accounts (FSA), and an employee assistance program (EAP). Amounts of coverage and deductibles vary among Plan options available.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

**Insured Benefits** – The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), AD&D (basic and supplemental), LTD benefits, and vision benefits (excluding safety glasses). The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life, basic AD&D, and LTD benefits are paid from the general assets of the Company. Premiums for vision benefits are paid from Plan assets. Premiums for all other insured benefits are paid from contributions received from participants.

**Stop Loss Coverage** – The Company has entered into a stop loss insurance arrangement in an effort to limit the Plan's exposure for self-insured medical and prescription drug benefits (for individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Self-Insured Benefits** – The claims for self-insured benefits, except short-term disability, are processed by the Plan's third-party claims processors. The claims processors, except the processor for EAP claims, pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trusts, the 401(h) account or the general assets of the Company under an administrative service only (ASO) arrangement. EAP claims are not paid by the claims processors on a reimbursement basis. Despite the use of claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Short-term disability payments are processed through the Company's payroll system.

The Plan utilizes a pharmacy benefits manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

The Plan has flexible spending account (FSA) arrangements for health care and dependent care reimbursements that are funded solely by active employee contributions. The FSAs allow eligible participants to be reimbursed tax-free for qualified health care and dependent care expenses subject to annual limitations established under the Plan. The Company is not permitted to refund any part of the FSA balances to the employees; the accounts cannot be used for anything other than qualified health care and dependent care expenses; remaining amounts are not portable upon termination once the employee leaves the Company; and any unused amount is forfeited back to the Company. Residual FSA amounts unused at the end of the year can be carried over for two and one-half months into the next year to allow qualified expenses incurred during that period to be reimbursed from the account. Any residual FSA amounts remaining after the two and one-half month extension are immediately forfeited.

The Plan offers health reimbursement arrangements (HRA) to active and retiree MPAT, Local 1245, and Local 396 participants that are funded solely through Company contributions. The HRAs allow eligible participants to be reimbursed tax-free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The Company is not permitted to refund any part of the balance to the participants; the accounts cannot be used for anything other than reimbursements of qualified medical expenses; remaining amounts are not portable upon termination once the employee leaves the Company for reasons other than retirement or when the retiree reaches age 65.

The Plan also offers active and retiree MPAT, Local 1245, and Local 396 participants a health savings account (HSA) option for their medical benefits. The Company provides contributions to the HSA accounts for active participants only. Active and retiree participants can elect to make additional contributions to their account subject to Internal Revenue Service (IRS) limits. The contributions made to the HSA can be used on a tax-free basis to pay or reimburse for qualifying health care expenses. An HSA is established and owned by the individual participant.

**401(h)** – The Plan includes a health and welfare component, in addition to normal retirement benefits, to fund a portion of the postretirement obligations for MPAT retirees and their beneficiaries in accordance with Section 401(h) of the Internal Revenue Code (IRC). A separate account has been established and maintained in the NV Energy Retirement Plan for the net assets related to the medical benefit component (the 401(h) account).

In accordance with IRC Section 401(h), the Plan's investments of the 401(h) Account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. The related obligations for the welfare benefits are not included in the Company's pension plan obligations but are reported as obligations in the accompanying financial statements of the Plan.

**Contributions** – In addition to deductibles and copayments, and as adjusted periodically by the Company, employees currently contribute a portion of the cost of benefits they elect under the Plan.

For selected benefits such as supplemental life, supplemental AD&D insurance, and LTD (Local 396) employees contribute 100% of the cost of insurance premiums. The amount of employee contribution varies among the Plan options available and elections for various benefits.

The Company pays the full cost of basic life insurance, basic AD&D insurance, short-term disability, LTD (MPAT and Local 1245), and stop loss insurance. In addition, Company contributions are provided under the HRA options at \$500–\$750 for participant only coverage and \$1,000–\$1,500 for participant plus dependent coverage to reimburse the participant for qualified medical expenses.

The costs of postretirement benefits are shared by the Company and retirees. Prior to January 1, 2010, there were no retiree contributions for those who retired before 1993. Also, for 1993 and later retirees, contribution rates varied based on factors such: as (1) employment class (MPAT, Local 396, and Local 1245), (2) date of hire, (3) date of retirement, and (4) the Plan options available. The Company's retiree medical subsidy is a percentage of the Plan's cost based on retirement date and years of service or a flat dollar amount based on years of service. Effective January 1, 2010, the Company capped its retiree medical subsidy for 2010 and future years at 2009 levels. However, certain Local 1245 retirees received a 3% increase to their subsidy for 2013 and an additional 3% increase in 2014. For the years ended December 31, 2024 and 2023, retiree contributions were (in thousands) \$2,155 and \$2,067, respectively, and are reflected in participants' contributions on the statements of changes in net assets available for benefits. The Company's obligations related to retired participants are funded through contributions to the Company's defined benefit pension plan in accordance with IRC Section 401(h).

The Company contributes to the Plan such additional amounts as necessary to fund payment of claims and premiums in excess of participant contributions and administrative expenses. The Company's contributions for active participants for the years ended December 31 were as follows (in thousands):

Under COBRA, the Company is required to offer participants and their families' continuation of coverage for certain benefits in certain instances where coverage under the Plan would otherwise end. Premiums collected under this arrangement are included in the participants' contributions in the statements of changes in net assets available for benefits and totaled (in thousands) \$110 and \$146 for the years ended December 31, 2024 and 2023, respectively.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

**Payment of Benefits** – Premiums paid by either the general assets of the Company or the VEBA trusts are recorded in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processors. Amounts due to the claims processor under the ASO arrangement that have yet to be reimbursed by the Plan are recorded as a liability to claims processors in the accompanying statements of net assets available for benefits. Short-term disability payments are processed through the Company's payroll system and recorded when paid from the general assets of the Company. These payments are recorded in claims paid in the accompanying statements of changes in net assets available for benefits.

**Stop Loss** – Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss refunds due, if any, as of the financial statement date have been reported as a receivable in the statements of net assets available for benefits. Total stop loss refunds for the years ended December 31, 2024 and 2023, totaling (in thousands) \$1,795 and \$1,641, respectively, are netted against claims paid in the accompanying statements of changes in net assets available for benefits.

**Pharmacy Rebates** – Refunds from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been recorded as a receivable in the statements of net assets available for benefits. Pharmacy rebates totaling (in thousands) \$6,495 and \$4,094 for the years ended December 31, 2024 and 2023, respectively, are netted against claims paid in the accompanying statements of changes in net assets available for benefits.

**Flexible Spending and Health Savings Accounts** – Employee contributions received during the Plan year for health care and dependent care reimbursement FSA are reflected in participant contributions in the accompanying statements of changes in net assets available for benefits.

HSA's are not considered Plan assets as they belong to the individual participants; therefore, there is no reporting in the accompanying financial statements as there is no obligation of the Plan to pay the benefits.

**Investment Valuation and Income Recognition** – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

**Administrative Expenses** – Administrative expenses incurred in the administration of the Plan that are paid by the Plan include trustee, investment advisory, and claims administration fees. These expenses are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for benefits. Expenses that are directly paid by the Company, such as professional fees, are excluded from these financial statements.

**Subsequent Events** – The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Postretirement and Postemployment Benefit Obligations**

A postretirement benefit obligation has been recognized for retiree medical, dental, vision, and life insurance benefits for eligible participants and their dependents. The postretirement benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligation represents the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for: (a) currently retired or terminated employees, and their beneficiaries and dependents, and (b) active employees, and their beneficiaries and dependents after retirement from service with the Company.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate the future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The weighted-average health care cost trend rate assumption had an effect on the amounts reported as postretirement benefit obligations for the year ended December 31, 2023. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2023 by approximately \$0.5 million. In 2024, the health care cost trend was no longer applicable, as there were few traditional benefit participants in the plan and the majority of the benefit obligation relates to defined dollar benefits.

In 2024, the discount rate assumption was increased from 5.45% to 5.75%, which increased the benefit obligation. The following represents other significant assumptions used in the benefit obligation valuations as of December 31:

The foregoing assumptions are based on the presumption the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The Plan's postretirement benefit obligations and the changes in the postretirement benefit obligations do not reflect an amount associated with the Medicare subsidy provided by the Medicare Prescription Drug, Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy.

The Plan "self-funds" the majority of the benefits provided to participants but insures life, accidental death and dismemberment, standard and computer vision coverage, and long-term disability benefits. As of each December 31, there are many self-funded claims that have been incurred on which benefit payments will be made subsequent to that date. The liability for claims payable and claims incurred but not reported (IBNR) was estimated by Plan Management using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan or by the Plan's actuary in accordance with accepted actuarial principals based on claims data provided by the Plan's third-party administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

The Plan's deficiency of net assets over benefit obligations will be funded through future increases in employee and employer contributions.

**Claims Incurred but Not Reported** – Plan obligations at December 31, for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based upon claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

### **Note 4 – Fair Value of Investments**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies (RIC):* Valued at the closing price reported on the active market on which the individual securities are traded or based upon pricing models maximizing the use of observable inputs for similar securities. Certain RICs are valued at the closing price reported on the active market on which the individual securities are traded or based upon pricing models maximizing the use of observable inputs for similar securities. Other RICs are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value and to transact at that price. For certain RIC funds, the net asset value as provided by the trustee is used as a practical expedient to estimate fair value, in accordance with ASC 820-10-35-59. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

*Interest Bearing Cash:* Primarily comprised of cash collateral valued at cost which approximates market.

The BHE Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and other third parties.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, (in thousands). The following table does not include the 401(h) account, as information related to it is disclosed in the NV Energy Retirement Plan's financial statements.

#### Note 5 – Tax Status

The VEBA trusts, that fund certain benefits of the Plan, have each received an exemption letter from the IRS dated April 29, 2011 and February 25, 1980, stating that the trusts are tax-exempt under the provisions of Section 501(c)(9) of the IRC.

The Plan and the trusts are required to operate in conformity with the IRC to maintain the tax-exempt status of each trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trusts are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for an account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

#### Note 8 – Party-in-Interest Transactions

The Plan contracts with the Company's wholly-owned subsidiary, a captive insurance company, for its stop loss medical insurance policy. The premium for the policy totaled (in thousands) \$850 for each of the years ended December 31, 2024 and 2023, and was paid from the general assets of the Company. These transactions qualify as exempt party-in-interest transactions.

#### Note 9 – Health Reimbursement Arrangements (HRA) Commitment

The Company is required to annually contribute amounts to the HRA accounts of eligible participants. The Company funds the accounts on a pay as you go basis, such that at December 31, 2024 and 2023, amounts available from the Company to reimburse HRA participants for their qualifying medical expenses totaled (in thousands), \$6,835 and \$6,747, respectively.

#### Note 10 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, currency, liquidity, inflation, horizon, and credit risks. Due to the level of risk associated with certain investment securities, near-term changes in the values of the investment securities are reasonably possible and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care trends, and employee demographics, all of which are subject to change. Due to uncertainties inherent within these estimations and assumptions, near-term changes in these estimates and assumptions are reasonably possible and such changes could be material to the financial statements.
