INDEPENDENT AUDITOR'S REPORT

Child and Family Service 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Child and Family Service 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B to the financial statements.
- The information in the accompanying financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B of the financial statements, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



Auditor's Responsibilities for the Audit of the Financial Statements (continued)

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedules Required by ERISA

NOTE A – DESCRIPTION OF PLAN

The Child and Family Service 401(k) Plan (Plan) was established by Child and Family Service (Organization) on January 1, 2012. The following is a description of the Plan that provides only general information. Participants should refer to the plan agreement for a complete description of the Plan's provisions. The Plan was amended and restated effective January 1, 2022.

General

The Plan is a profit sharing and salary deferral plan, also known as a 401(k) plan covering substantially all employees of the Organization (excluding nonresident aliens, leased employees, part-time/temporary/seasonal employees, and practicum students). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Employees become eligible to participate in the Plan after completion of one month of service. Long-Term Part-Time employees who are not regular participants and who are credited with at least three consecutive years of service beginning after December 31, 2020, with at least 500 hours of service each year are eligible to make salary deferrals and Roth 401(k) deferrals to the Plan. Employees of the Organization are automatically enrolled in the Plan upon meeting the eligibility requirements. The salary deferral will be equal to 3% of compensation unless a different deferral amount is elected.

Contributions

Participants may make employee salary deferral contributions to the Plan up to the lesser of 100% of their eligible compensation or \$23,000 in 2024 and \$22,500 in 2023, adjusted annually for the cost of living, plus an additional \$7,500 in 2024 and 2023, for employees age 50 and over. Participants are eligible for employer matching contributions after 12 months of credited service with the Organization. The Organization contributes matching contributions equal to 50% of the participant's contribution (100% for participants hired before January 1, 2012) up to two percent of the participant's compensation. Total contributions to each employee's account may not exceed the lesser of \$69,000 (\$76,500 with the catch-up contribution) in 2024 and \$66,000 (\$73,500 with the catch-up contribution) in 2023, or 100% of annual compensation, as defined. Excess contributions are refunded in accordance with provisions of the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's contributions and matching employer contribution, plus an allocation of the Plan's net earnings; less an allocation for plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are 100% vested in employer matching contributions and earnings thereon after three years of continuous service. Participant voluntary contributions and earnings thereon are always 100% vested.

Forfeitures

Forfeitures may be used to pay administrative expenses and to reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. For the year ended December 31, 2024, there was \$0 in forfeited amounts and interest earned, and \$0 of forfeitures were used to reduce employer contributions. For the year ended December 31, 2023, there was \$10,055 in forfeited amounts and interest earned, and \$44,268 of forfeitures were used to pay administrative expenses or reduce employer contributions.

Payment of Benefits and Withdrawals

The vested amount in each participant's account is payable upon normal retirement (age 65), disability, death, or termination of employment. Participants may receive the entire value of their accounts in a single lump-sum payment or partial withdrawal or installments over the participant's or beneficiary's life expectancy. Account balances of \$5,000 or less at the time of separation may be automatically disbursed to the participant. Active participants may withdraw all or a portion of their vested account balances as in-service distributions after attaining the age of 59 ½. Participants are eligible to make hardship withdrawals from the vested portion of their salary deferral and Roth 401(k) accounts to satisfy a financial hardship, as defined, subject to the approval of the plan administrator. Hardship withdrawals are strictly regulated by the Internal Revenue Service.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 (reduced by outstanding loan balances) or 50% of the vested portion of their account balance. The minimum loan amount is \$1,000. Participants may only have one loan outstanding at any one time. The notes receivable must be repaid in five years unless the note is used to acquire a principal residence. The notes receivable are secured by a lien on the participant's interest in the Plan and are repaid through payroll deductions. Interest rates are set at the prime rate plus 1%, which ranged from 4.25% to 9.50% for the years ended December 31, 2024 and 2023. The notes mature at various dates through October 2029.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Except for investments, which are accounted for on a fair value basis, the Plan has prepared its financial statements on the basis of cash receipts and disbursements; consequently, certain additions to net assets available for benefits are recognized when received rather than when earned, and certain deductions from net assets available for benefits are recognized when paid rather than when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to be presented in accordance with accounting principles generally accepted in the United States of America.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates, it is reasonably possible that such estimates may change within the near term, and such differences could be material to the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Net investment earnings include the Plan's gains and losses on investments bought and sold as well as held during the year. The Organization determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note D for discussion of fair value measurements.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance. Interest income is recorded when it is received. Related expenses are recorded as administrative expenses and are expensed when paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Expenses are recognized when the related liability is paid. Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Expenses that are paid by the Organization are excluded from these financial statements.

NOTE C – CERTIFICATION FROM QUALIFIED INSTITUTIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus Trust Company, as of and for the year ended December 31, 2024, and as of December 31, 2023 and for the period from June 26, 2023 to December 31, 2023; and Newport Trust Company, for the period from January 1, 2023 to June 26, 2023. Ascensus Trust Company and Newport Trust Company are the qualified institutions of the Plan.

NOTE D – FAIR VALUE MEASUREMENTS

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation methodologies used to measure fair value. There are three levels of the fair value hierarchy. Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 inputs are unobservable and significant to the fair value measurement. The fair value measurement level of an asset or liability within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation methodologies used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments in registered investment companies are valued using quoted market prices, a Level 1 input. There were no investments requiring the use of Level 2 or Level 3 inputs. The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

At December 31, 2024 and 2023, total investments at fair value, consisting solely of investments in registered investment companies, amounted to \$11,192,828 and \$9,533,852, respectively.

NOTE E – TAX STATUS

In a letter dated July 17, 2012, the Internal Revenue Service indicated that the volume submitter profit sharing plan adopted by the Organization is acceptable and may be relied on with respect to qualifying under Section 401(a) of the IRC. The Plan has been amended since the determination letter. However, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Management is required to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The plan administrator evaluated the Plan's tax positions as of December 31, 2024 and 2023 and for the years then ended, and determined that the Plan had no uncertain tax positions required to be reported. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods in progress.

NOTE F – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan's assets are held by Ascensus Trust Company and Newport Trust Company, and therefore, these transactions qualify as party in interest transactions. Certain administrative functions are performed by officers or employees of the Organization, who receive no compensation from the Plan. Fees and other administrative expenses are paid by either by the Plan or by the Organization, as provided by the plan document.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants become 100% vested in their accounts.

NOTE H – RISK AND UNCERTAINTIES

The Plan invests in various investment securities, including investments in shares of registered investment companies. In general, investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.

The Plan and Organization operate in the State of Hawaii. Local, national, and international events can have severe, adverse effects on economic conditions in Hawaii. These financial statements do not include the adjustments that would result if the Plan were to account for future losses or asset impairments, as the effects on the financial statements of the Plan from such changes in economic conditions, are not presently determinable.

NOTE I – PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Organization made late submissions of participant contributions totaling \$38,754. The Organization deposited the late submissions during the year ended December 31, 2024 and expects to correct the lost earnings during the year ending December 31, 2025. During the year ended December 31, 2023, the Organization made late payments of participant contributions totaling \$75,396. The Organization deposited the late payments during the year ended December 31, 2023 and corrected the lost earnings during the year ended December 31, 2024.

NOTE J – SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued, and determined that the Plan did not have any subsequent events requiring adjustment to the financial statements or disclosure in the notes to the financial statements.
