INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
United Workers Pension Fund

Opinion on the 2024 Financial Statements

We have audited the financial statements of the United Workers Pension Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Report on 2024 Supplemental Information

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The 2024 supplemental Schedule of Assets Held at End of Year and Schedule of Delinquent Participant Contributions, together referred to as “supplemental information,” are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

2023 Financial Statements

The financial statements of the Plan as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated May 2, 2025 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedules related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the United Workers Pension Fund (the Plan) provides only general information. Participants should refer to their Summary Plan Description for a more complete description of the Plan's provisions.

General - The Plan was established on August 26, 2004. The Plan is a collectively bargained multiemployer defined contribution 401(k) profit sharing plan. The Plan provides retirement benefits to participants, who, during active employment, were covered employees of contributing employers having collectively bargained agreements with United Workers of America Local 621 (the Union) and the various employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Vesting - A participant may acquire vested rights to their account in one of three ways: First, a participant has a 100% vested right to their account balance when they make a salary reduction contribution on their own behalf. Second, a participant acquires a 100% vested right to that portion of their account balance contributed by the employer on behalf of the participant when the participant has completed five years of vesting service. Third, the accrued benefit of all affected participants will become 100% vested on the termination or partial termination of the Plan. Eligible employees will be credited with one year of vesting service for each plan year in which the employee completes 1,000 hours of service.

Contributions - Employers make contributions to the Plan at rates determined by collective bargaining agreements. The amount of employer contributions is determined from time worked, as reported by participating employers, and the contractual employer contribution rates pursuant to the collective bargaining agreement in effect. In addition, participants may contribute through a salary reduction contribution in an amount between 1% and 15% of pre-tax wages, up to the maximum allowed under the provisions of the Internal Revenue Code (IRC).

Participant Accounts - An individual becomes a participant in the Plan the first day their employer, subject to a collective bargaining agreement or a participant agreement, is required to make contributions to the Plan or when the individual elects to have a salary reduction made on their behalf.

Each participant's account is credited with contributions made on their behalf from contributing employers, the participant's contributions and allocations of the Plan's net investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF THE PLAN (continued)

Benefits - Benefit payments must begin no later than April 1 after the calendar year in which the participant reaches 73 years of age in 2024 and 2023, or if later and elected by the participant, the first day of the month after they retire. The Plan may, in the sole discretion of the Board of Trustees, pay any account with an actuarial equivalent of \$1,000 or less on the date of distribution in a lump sum.

Normal Retirement Absent the consent of a participant, payment of benefits will begin no later than the 60th day after the close of the plan year, including the latest of:

- (a) the date the participant attains age 65,
- (b) the fifth anniversary of a participant's entry date, or
- (c) separation from service from the contributing employer

Disability Retirement A participant may elect to receive payment of their account if they become disabled. The participant must be entitled to receive and be receiving a social security disability pension.

The account of an unmarried participant will be paid to the participant in the form of a life annuity. The account of a married participant will be paid in the form of a joint and survivor annuity. After the death of a participant, the monthly payment to their spouse equals 50% of the amount paid during the life of the participant.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

Investments - Investments in the mutual funds are carried at fair value which generally represents quoted market prices or the net asset value of the funds as of the last business day of the fiscal year as provided by the investment company. Short-term investments are carried at cost, which approximates fair value.

Purchases and sales are recorded on a trade-date basis. Interest and dividends are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions due and not paid at year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded. Employer and participant contributions are accounted for as exchange transactions.

Benefit Payments - Benefit payments to participants are recorded when paid.

Administrative Expenses - Administrative expenses are paid by the Plan and are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Forfeited Accounts – Generally, when a participant terminates from the Plan, the non-vested portion of the participant’s account, as defined by the Plan, represents a forfeiture. During the years ended December 31, 2024 and 2023, forfeiture non-vested accounts totaled \$741,543 and \$112,703, respectively, which were transferred to a forfeiture account. For the years ended December 31, 2024 and 2023, forfeiture accounts had a balance of \$619,327 and \$22,328, respectively. These accounts are to be used to pay Plan expenses. Any remaining forfeitures shall be allocated to the participant accounts in the same proportion as the account bears to the accounts of all participants. During each of the years ended December 31, 2024 and 2023, forfeitures totaling \$145,884 and \$124,746 were used to pay administrative expenses, respectively.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Reclassifications - Certain prior year amounts have been reclassified to be in conformity with the current year presentation. These reclassifications did not change the total net assets or change in net assets from the totals previously reported.

NOTE 3. PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, the Trustees have the right to terminate the Plan subject to the provisions of ERISA. Upon termination, each affected participant would become 100% vested in their account.

NOTE 4. TAX STATUS

The Plan obtained its latest determination letter on May 19, 2011, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and was, therefore, exempt from federal income taxes under the provisions of Section 501(a). The Plan has been amended since receiving the latest exemption letter. The Plan’s administrator and the Plan’s counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

NOTE 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

For the years ended December 31, 2024 and 2023, there were no transfers in or out of levels 1, 2 or 3.

NOTE 6. RELATED PARTY TRANSACTIONS**Identification of Related Organizations**

The Plan has the following related entities with which it has transactions:

- United Workers Health Fund (Health Fund)
- United Workers of America (UWA)

The Plan reimburses the Health Fund for certain administrative expenses. As of December 31, 2024 and 2023, the Plan owed the Health Fund \$2,636 and \$733, respectively, for its share of insurance expense.

Certain plan investments are shares of short-term investments managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is a Trustee, as defined by the Plan, and, therefore, transactions of these investments qualify as party-in-interest transactions. These investments have been denoted as such on the supplemental Schedule of Assets Held at End of Year

NOTE 7. RISKS AND UNCERTAINTIES

Financial instruments that subject the Plan to concentrations of credit risk include cash, investments and employer's contributions. The Plan maintains accounts at high quality financial institutions. While the Plan attempts to limit its financial exposure, its deposit balances may, at times, exceed federally insured limits. The Plan has not experienced any losses on such accounts.

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, sector and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Contributions from two employers represented 22% of the employer contributions for the year ended December 31, 2023. Two and three employers represented 28% and 42% of employer contributions receivable at December 31, 2024 and 2023, respectively.

NOTE 8. NONEXEMPT TRANSACTIONS

Certain contributing employers failed to remit employee deferrals for participant contributions totaling \$867,604 and \$544,611 for the years ended December 31, 2024 and 2023, respectively, within the time frame required by the Department of Labor (DOL). By DOL regulation an employer is required to segregate employee contributions from its general assets as soon as practicable but no later than fifteen business days after the end of the month in which amounts contributed by employees are withheld from their wages. Any remittances beyond that time are considered to be nonexempt or prohibited transactions by regulation. These transactions are denoted in the supplemental schedule of delinquent participant contributions.

NOTE 9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
