## **Independent Auditors' Report**

### **1. Description of Plan**

The following description of the 401(k) Profit Sharing Plan for Employees of the Westchester Care at Home, Inc. (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan established by Westchester Care at Home, Inc. (the "Plan Sponsor" or "Employer") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### ***Plan Administration***

The Plan Sponsor has contracted with Mutual of America Life Insurance Company ("Mutual of America") to act as the Plan's recordkeeper. The Plan is administered by the Plan Sponsor; however, Mutual of America processes and maintains the records of participant data.

#### ***Eligibility***

All employees, except independent contractors, are eligible to participate in the Plan. There is no minimum age requirement to make employee contributions to the Plan; however, the employees must have completed one year of service, defined as a 12-consecutive-month period (beginning on the date they first perform an hour of service for the employer) during which they complete at least 1,000 hours of service. Employees become eligible for employer matching contributions at age 21, provided they have completed one year of service.

#### ***Participant Accounts***

The Plan maintains individual accounts for each Plan participant. Each participant's account is credited with an allocation of the Employer's contributions and, as applicable, the participant's contribution, rollover contributions, and an allocation of Plan earnings (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

#### ***Contributions***

Eligible employees, who elect to enter into a salary reduction agreement, may contribute their includable income, up to the lesser of the Internal Revenue Code ("IRC") annual limit or the participant's compensation for the year, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

***Contributions (continued)***

Additionally, the Employer may make discretionary matching contributions to all eligible employees who have completed one year of service and have attained the age of 21. During the year ended December 31, 2024, the maximum allocation that a participant can receive is the lesser of the participant's contribution or 3% of the participant's compensation. For the year ended December 31, 2024, the Employer made a \$32,999 matching contribution.

***Vesting***

Participants are fully and immediately vested from the date of their participation in the Plan on the value of their individual account attributable to their own contributions plus actual earnings thereon. Employees become vested in accordance with the following schedule for their individual account attributable to Employer contributions:

However, employees hired before January 1, 2008 are fully vested in the value of their individual account attributable to employer contributions.

***Payment of Benefits***

Participants may elect to retire and receive retirement benefits any time on or after the date the participant reaches age 55 or delays such payments until April 1 of the calendar year following the year in which the participant attains age 73. The benefits payable are based on the vested amounts in the participant's account. Employees may elect to receive their benefits under several payment options, including life annuity, full cash refund annuity, period certain and continuous annuity, joint and survivor annuities and lump-sum distribution. The Plan also provides for death benefits payable to the employee's designated beneficiary, should the employee die before retirement.

***Administrative Expenses***

Certain administrative fees are charged directly against participant accounts by Mutual of America on a monthly basis for services provided. All other significant administrative costs of the Plan are absorbed by the Plan Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation in value of investments.

### **1. Description of Plan *(continued)***

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions in to one or a combination of investment options offered by Mutual of America. Participants may transfer money from one investment alternative to another, or change the allocation of future contributions, by contacting Mutual of America.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable, which are secured by the participants' vested balances, bear interest at a rate based on rates available for similar notes receivable in the Plan's geographic locale and are repaid through payroll withholding deductions. Notes receivable have various repayment terms limited to five years, except in limited circumstances, such as for the purchase of a primary residence, which allows for a repayment term of up to ten years.

#### ***Forfeitures***

If a participant terminates employment and is less than 100% vested in their Employer contributions, the participant will forfeit the non-vested portion of their account. Forfeited non-vested amounts are used to reduce future Employer discretionary matching contributions. At December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$1,175 and \$11,288. During 2024, \$11,288 of forfeitures were used to reduce Employer contributions.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data.

**2. Summary of Significant Accounting Policies (continued)**

***Fair Value Measurements***

Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

***Investment Valuation and Income Recognition***

All of the Plan's investment are stated at fair value. Separate accounts are reported at fair value as reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The investment in the insurance company general account is reported at fair value, which is based on the contract value as reported by the insurance company. Contract value represents contributions made under the contract, plus interest credited, less benefits paid and expenses. Because the investment is not actively traded and relies on valuation inputs provided by the insurance company, it is considered an estimate of fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan may be paid by the Employer and are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

***Reclassifications***

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation. Such reclassifications had no impact on the Plan's net assets or changes in net assets.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024, and net appreciation in fair value of investments, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America a qualified institution.

**Insurance Company General Account**

Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America Life Insurance Company ("Mutual of America"). Mutual of America guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of the general account at a rate of at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners ("NAIC") standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.50% or more than 3.00% in any event.

#### ***Insurance Company General Account (continued)***

Mutual of America determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America Life Insurance Company's sole discretion, they may credit a higher rate of interest to a participant's contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The Mutual of America Interest Accumulation Account is not a fully benefit-responsive investment contract and may be subject to withdrawal or transfer restrictions under certain plan or contract provisions. The Mutual of America Interest Accumulation Account represents approximately 15% of the net assets available for benefits as of December 31, 2024 and 2023.

#### **Separate Accounts**

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund. The Plan's separate accounts include various asset classes which are: equity funds, fixed income funds, growth funds, money market funds, balanced funds, bond funds, asset allocation funds, and retirement funds.

### 5. Plan Termination

Although it has not expressed any interest to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

### 6. Tax Status

The Internal Revenue Service has determined and informed the plan document preparer by a letter dated November 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

**7. Party-in-Interest Transactions**

The Plan's investments are managed by Mutual of America Life Insurance Company, the asset holder and record-keeper of the Plan. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA. During the Plan year ended December 31, 2024 fees in the amount of \$1,226 were paid to Mutual of America for Plan related services.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals and no costs are charged to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
