NOTE 1. DESCRIPTION OF THE PLAN

The following description of L.P. Industries, Inc. DBA Sykes Ace Hardware 401(k) Profit Sharing Plan (the Plan) provides only general information. For more complete information, participants should refer to the Plan instrument, a copy of which is on file in the office of the Plan sponsor.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan covering all eligible employees of L.P. Industries, Inc. DBA Sykes Ace Hardware (the Company and Plan sponsor) and any affiliate that has adopted the Plan. The Company is the Plan sponsor, with the following participating employers: Dixie Hardgoods Co. LLC, Brickell Hardgoods Company, South Beach Hardgoods Company, Aventura Hardgoods Company, and Harbor Hardgoods Company. The Plan commenced on January 1, 1993 and was restated effective January 1, 2021. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

In order to be eligible to participate in the Plan, an employee must be at least 21 years old and have one year of service. Entry dates are on the first day of each quarter of the Plan year.

Contributions

Each year participants may contribute up to 100% of pretax annual compensation as defined in the Plan. According to Internal Revenue Service (IRS) rules, the deferral may not exceed \$23,000 in 2024. Participants who have reached at least age 50 may contribute an additional catch-up yearly contribution of \$7,500 during 2024. Eligible participants may also contribute amounts representing distributions from other qualified benefit or contribution plans.

The employer matches 100% of the participant's contribution not to exceed 3% of compensation. Highly compensated employees are not eligible for the safe harbor match contributions. Contributions are subject to certain limitations.

The employer may also make, at its sole discretion, profit-sharing contributions to the Plan. The profit-sharing contributions would be allocated to each eligible participant in pro rata shares.

Additionally, the employer may make qualified non-elective contributions for the benefit of such participants determined at the discretion of the Company. In order to share in the allocation of any non-elective contributions, participants are required to be employed by the employer on the last day of the Plan year.

Participant Accounts

Each participant's account is credited with 1) participant contributions, 2) the employer's matching contribution and 3) a ratable portion of investment gain or loss, net of Plan expenses. Each participant's account is charged with any distributions made to that participant.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon as well as the employer's safe harbor contribution. Vesting in the profit-sharing contribution and discretionary contribution portion of their accounts will occur after three years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set based on market rates, as defined in the Plan. Principal and interest are paid ratably through payroll deductions.

Investment Options

Upon enrollment in the Plan, and any time subsequently, a participant may direct contributions to be allocated among a selection of securities provided by the Plan (see Note 3).

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or beneficiary may receive a lump-sum amount equal to the value of the participant's vested interest in their account or partial payments thereon. Upon retirement or separation of service with an account balance less than \$5,000, the Plan administrator will distribute payment in the form of a lump-sum. If the vested portion of the account balance exceeds \$5,000 (disregarding any rollover contributions), the Plan permits the participant to elect distribution as a lump-sum installment or partial withdrawals or installments but only with respect to minimum required distributions, over a period of not more than your assumed life expectancy. In-service distributions are available to participants who have reached age 59½ and are 100% vested in their account balances.

Forfeitures

Forfeitures may first be used for restoration of participant forfeitures, then to offset Plan expenses, or to reduce employer's matching contributions. The forfeiture balance available for use was \$38,488 and \$34,710 as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce employer's matching contributions.

Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in all contributions and earnings.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan to make estimates and assumptions that affect the reported amounts of net assets available for benefit and disclosure of contingent net assets available for benefit as of the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies, which are in accordance with U.S. GAAP. See Note 4 for discussion of fair value measurements.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, as the notes are collateralized by the participant's vested account balance.

As of December 31, 2024, the interest rates on notes receivable from participants ranged from 8.00% to 8.50%. Notes receivable from participants were \$54,026 and \$64,291 as of December 31, 2024 and 2023, respectively, and mature at various dates through September 2029.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan allows for administrative expenses to be paid by the Plan Sponsor or the Plan. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3. UNAUDITED INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024, net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and investment information included in the footnotes and supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except comparing such information to the related information included in the financial statements and supplemental schedule.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by approximately \$644,000. This was reported as net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value, expands disclosures about fair value measurements, and establishes a fair value hierarchy, which prioritizes the inputs used in measuring fair value summarized as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value.

Pooled-separate account (PSA): The fair value of investments in the pooled separate account is determined by the fund custodian based on the fair value of the underlying securities within the fund, which represents the net asset value of the shares held by the Plan at year-end.

NOTE 5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's contract with Voya included the option to allocate contributions to a guaranteed investment contract, referred to as the Voya Stable Value Option, which is fully benefit-responsive. Participant contributions to the guaranteed investment contract were held in the Voya general account. The contract is reported at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

As of December 31, 2024, the contract value of the Voya Stable Value Option was approximately \$1,143,000.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
- Premature termination of the contracts;
- Plan termination or merger;
- Changes to the Plan's prohibition on competing investment options; or
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6. RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

Some of the Plan's investments are shares of funds managed by VOYA and Nationwide. Fees incurred by the Plan for investment management services are considered party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Contract administration fees paid for the year ended December 31, 2024 were \$8,801 included as administrative expenses in the accompanying statement of changes in net assets available for benefits. Additionally, the Plan's sponsor and participating employer absorbs virtually all of the Plan's administrative expenses.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8. TAX STATUS

The Plan obtained its latest determination letter dated June 30, 2020, in which the IRS stated that the prototype plan document of the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9. SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for the Plan through October 15, 2025, the date the financial statements were available to be issued.
