## INDEPENDENT AUDITOR'S REPORT

To the Participants, Management, and Plan  
Committee of the Rural King 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of Rural King 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Rural King 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

### NOTES TO FINANCIAL STATEMENTS

#### 1. PLAN DESCRIPTION

The following description of the Rural King 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan with a 401(k) feature covering all full-time employees of Rural King Administrative Services, LLC (the “Company”), who have completed two months of service and are age eighteen or older. Entry dates are the first day of the first, fourth, seventh, and tenth month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is governed by the Company’s Board of Directors. John Hancock Life Insurance Company (U.S.A.) serves as the Plan custodian.

##### Contributions

Each year, participants may contribute up to the maximum limitation set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct the investment of their contributions among any or all of the investment options offered by the Plan.

The Company makes safe harbor matching contributions equal to the sum of 100% of the amount of the first 3% of the applicable active participant's compensation contributed to the Plan and 50% of the next 2% of the applicable active participant's compensation contributed to the Plan. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. Such contributions, if any, and forfeitures are allocated on the basis of the ratio of participant’s compensation to all participants’ compensation.

##### Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, as well as allocations of the Company’s profit sharing contribution and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## RURAL KING 401(K) PLAN

### NOTES TO FINANCIAL STATEMENTS

#### 1. PLAN DESCRIPTION (Continued)

##### Vesting

Participants are vested immediately in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's other contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. The loans are secured by the participant's vested account balance. The loan interest rate, as determined by the Plan Administrator, is set at 2 percent above the prime rate, as defined. Loan terms generally range from three to five years, but may be extended for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

##### Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period of time, not exceeding a participant's life expectancy or the joint life expectancy of a participant and participant's designated beneficiary. An eligible rollover distribution is also permitted. If the value of a participant's account is less than \$5,000, a lump sum distribution will be made without regard to the consent of the participant as soon as administratively feasible.

##### Forfeited Accounts

Forfeitures are used to reduce employer matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$95,117 and \$12,854, respectively. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions by \$160,697 and \$256,573, respectively.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in fair value of investments includes reinvested dividend and interest income, and the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### Payment of Benefits

Benefits are recorded when paid.

##### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution and loan fees are charged to the individual participant's account incurring the distribution or loan and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

##### Subsequent Events

The Plan has evaluated subsequent events through October 17, 2025, the date the financial statements were available to be issued.

#### 3. INFORMATION CERTIFIED BY THE CUSTODIAN

John Hancock Life Insurance Company (U.S.A.), (the "Custodian") has certified the completeness and accuracy of certain information which management used in preparing the financial statements, supplemental schedule and accompanying notes. The following is a summary of the information certified by the Custodian:

- a. Investments as reported in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b. All items of income and expense related to Plan investments and all transactions for the year ended December 31, 2024.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate investment accounts:* Each account owns shares of an underlying fund. John Hancock values each account in terms of "units", the value of which is determined on a daily basis. The share price, or Net Asset Value, of the underlying fund is used to calculate the unit value. To determine the unit value, the market value is reduced by applicable fees and then divided by the number of units. The pooled separate investment accounts have no restrictions on redemptions and have no unfunded commitments. Redemption can occur daily and there are no redemption periods required.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The financial statements do not present investments within the fair value hierarchy because ASU 2015-07 eliminated the requirement to categorize investments that use the practical expedient to measure net assets value. As of December 31, 2024 and 2023, all of the Plan's investments were pooled separate accounts that use the practical expedient to measure net asset value.

#### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### 6. TAX STATUS

The Internal Revenue Service has determined and informed the pre-approved plan provider, by a letter dated June 30, 2020, that the Plan, as then designed, is in accordance with the applicable requirements of the Internal Revenue Code (IRC). The pre-approved plan provider has informed the Plan's administrator that the Plan was restated since receiving the determination letter. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **8. PARTY-IN-INTEREST TRANSACTIONS**

The plan paid certain expenses related to general administration and record keeping to various service providers. These transactions are party-in-interest transactions under ERISA. In addition, the Plan Sponsor pays a portion of these expenses and certain accounting and auditing fees relating to the Plan.


Dear Sir or Madam:

## INDEPENDENT AUDITOR'S REPORT

To the Participants, Management, and Plan  
Committee of the Rural King 401(k) Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of Rural King 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### 1. PLAN DESCRIPTION

The following description of the Rural King 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan with a 401(k) feature covering all full-time employees of Rural King Administrative Services, LLC (the “Company”), who have completed two months of service and are age eighteen or older. Entry dates are the first day of the first, fourth, seventh, and tenth month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is governed by the Company’s Board of Directors. John Hancock Life Insurance Company (U.S.A.) serves as the Plan custodian.

##### Contributions

Each year, participants may contribute up to the maximum limitation set by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants may direct the investment of their contributions among any or all of the investment options offered by the Plan.

The Company makes safe harbor matching contributions equal to the sum of 100% of the amount of the first 3% of the applicable active participant's compensation contributed to the Plan and 50% of the next 2% of the applicable active participant's compensation contributed to the Plan. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. Such contributions, if any, and forfeitures are allocated on the basis of the ratio of participant’s compensation to all participants’ compensation.

##### Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s matching contributions, as well as allocations of the Company’s profit sharing contribution and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

## RURAL KING 401(K) PLAN

### NOTES TO FINANCIAL STATEMENTS

#### 1. PLAN DESCRIPTION (Continued)

##### Vesting

Participants are vested immediately in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's other contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. The loans are secured by the participant's vested account balance. The loan interest rate, as determined by the Plan Administrator, is set at 2 percent above the prime rate, as defined. Loan terms generally range from three to five years, but may be extended for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

##### Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period of time, not exceeding a participant's life expectancy or the joint life expectancy of a participant and participant's designated beneficiary. An eligible rollover distribution is also permitted. If the value of a participant's account is less than \$5,000, a lump sum distribution will be made without regard to the consent of the participant as soon as administratively feasible.

##### Forfeited Accounts

Forfeitures are used to reduce employer matching contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$95,117 and \$12,854, respectively. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions by \$160,697 and \$256,573, respectively.

#### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian and investment advisors. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) in fair value of investments includes reinvested dividend and interest income, and the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### Payment of Benefits

Benefits are recorded when paid.

##### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution and loan fees are charged to the individual participant's account incurring the distribution or loan and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

##### Subsequent Events

The Plan has evaluated subsequent events through October 17, 2025, the date the financial statements were available to be issued.

#### 3. INFORMATION CERTIFIED BY THE CUSTODIAN

John Hancock Life Insurance Company (U.S.A.), (the "Custodian") has certified the completeness and accuracy of certain information which management used in preparing the financial statements, supplemental schedule and accompanying notes. The following is a summary of the information certified by the Custodian:

- a. Investments as reported in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b. All items of income and expense related to Plan investments and all transactions for the year ended December 31, 2024.
- c. Investments as reported in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

To determine the unit value, the market value is reduced by applicable fees and then divided by the number of units. The pooled separate investment accounts have no restrictions on redemptions and have no unfunded commitments. Redemption can occur daily and there are no redemption periods required.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The financial statements do not present investments within the fair value hierarchy because ASU 2015-07 eliminated the requirement to categorize investments that use the practical expedient to measure net assets value. As of December 31, 2024 and 2023, all of the Plan's investments were pooled separate accounts that use the practical expedient to measure net asset value.

#### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### 6. TAX STATUS

The Internal Revenue Service has determined and informed the pre-approved plan provider, by a letter dated June 30, 2020, that the Plan, as then designed, is in accordance with the applicable requirements of the Internal Revenue Code (IRC). The pre-approved plan provider has informed the Plan's administrator that the Plan was restated since receiving the determination letter. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **8. PARTY-IN-INTEREST TRANSACTIONS**

The plan paid certain expenses related to general administration and record keeping to various service providers. These transactions are party-in-interest transactions under ERISA. In addition, the Plan Sponsor pays a portion of these expenses and certain accounting and auditing fees relating to the Plan.
