To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Jackpocket LLC Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statement comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for period from February 16, 2024 to December 31, 2024, and the related notes to the financial statement.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statement performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As discussed in Note 10 to the financial statements, effective April, 2025, the Plan was merged into another defined contribution plan, for which the plan sponsor is a participating employer. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable cause for late filing:

The Jackpocket 401(k) Form 5500 is two days late in filing this year due to unforeseen circumstances out of our control. DraftKings acquired Jackpocket in 2024, but Jackpocket's 401k was left in place until it was terminated in December of 2024 and merged into the DraftKings 401k in April of 2025. Due to this, the payroll system and funding were done in a separate system through 2024. Unfortunately, the personnel responsible for this left the company in early 2025. Additionally, gathering information for the filing was extremely difficult due to lack of cooperation from the former payroll processor.

We were finally able to gather the necessary information, literally by the October 15, 2025 deadline, however, the person at DraftKings (myself) lost access to internet due to a computer update that disallows utilizing hotel WiFi, and I was in the middle of travel Wednesday evening and Thursday, October 15-16.

We can show, based on the auditors report, that we did make every attempt to gather the needed information and did try very hard to file on time.
