The plan sponsor, Charter Health Holdings, Inc. filed a voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code on January 26, 2024. The Office of the United States Trustee appointed David W. Carickhoff to serve as the Chapter 7 trustee in the bankruptcy case.

Due to the Chapter 7 bankruptcy filed by the plan sponsor, information/documentation that would have been provided by the plan sponsor to the auditor was unavailable and neither the plan sponsor nor the plan assets were available to pay the cost of meeting the requirement to obtain the opinion of an independent qualified public accountant. The plan sponsor, Charter Health Holdings, Inc. filed a voluntary petition for relief under Chapter 7 of the United States Bankruptcy Code on January 26, 2024. The Office of the United States Trustee appointed a Chapter 7 Bankruptcy Trustee in the bankruptcy case.

The Chapter 7 Bankruptcy Trustee, solely in his capacity as the Chapter 7 Bankruptcy Trustee, is filing the 2024 Final Form 5500 due for the Charter Health Holdings, Inc. for the short plan year ending April 30, 2024. The plan's record keeper, ADP Retirement Services, was unable to electronically provide the filing-ready copy of the 2024 Final Form 5500 to the Chapter 7 Bankruptcy Trustee until October 17, 2025. Therefore, the 2024 Final Form 5500 was not filed by the original extended due date of February 18, 2025. The Chapter 7 Bankruptcy Trustee acted as quickly as administratively possible to electronically file the 2024 Final Form 5500 upon receipt from ADP Retirement Services.
