### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Johnson, O'Hare Company 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Johnson, O'Hare Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of Plan**

The following description of the Johnson, O'Hare Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***General***

The Plan is a defined contribution plan established to provide eligible employees of Johnson, O'Hare Company and its affiliates (collectively the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Effective September 2, 2021, the Plan was amended and restated to bring the Plan into compliance with the legislative and regulatory changes set forth in the six-year pre-approved plan restatement cycle.

### ***Eligibility***

Employees are eligible to participate in the Plan if they have attained the age of 21. Employees must have completed six consecutive months of service, during which they completed at least 1,000 hours of service. Employees covered by a collective bargaining agreement and nonresident aliens are not eligible to participate in the Plan.

The Plan allows for an automatic enrollment provision. Therefore, when an employee becomes eligible to be a participant in the Plan, the Company automatically, on behalf of those participants, defers 3% of the participants' eligible compensation (as defined). The Plan provides for automatic increases in participants' deferrals by 1% a year up to a maximum of 6% of compensation. These deferrals are invested in a Fidelity Retirement Fund based on the participant's age at the time of enrollment. Participants may cancel, modify, or otherwise change any of the automatic elections.

### ***Participant Contributions***

Eligible participants may make voluntary pre-tax contributions and Roth contributions through salary reductions from 1% to 90% of their eligible annual compensation, as defined by the Plan, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional "catch up" contribution (\$7,500 in 2024). The Plan also allows rollover contributions from other qualified plans as defined in the Plan document. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants.

### ***Employer Contributions***

The Company may make a discretionary contribution as determined each year by the Board of Directors. There were no discretionary contributions for the year ended December 31, 2024.

Effective January 1, 2024, the Plan was amended to add employer matching contributions. Participants with at least six months of service will be eligible to receive a matching contribution on the first day of the Plan year as well as the first day of the fourth, seventh, and tenth months of the Plan year. The matching contribution is a flat percentage equal to 100% of employee contributions, limited to no more than 2% of employee contributions.

### ***Participant Accounts***

Each participant's account is credited with its respective contributions and its allocation of (a) employer contributions and (b) investment earnings or losses.

***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions, and actual earnings or losses therein. Participants vest in Company contributions through a five-year graduated formula as defined in the Plan document. In the event of death, disability, termination of the Plan, or attainment of retirement age, as defined, participants' accounts become fully vested.

***Payment of Benefits***

Upon termination of employment, retirement, death, or disability, the participant or the participant's beneficiary is entitled to receive the vested portion of the participant's account in a single lump-sum. Further, withdrawals from the Plan before leaving the Company are available for special "hardship" reasons (as defined) or after attaining the age of 59½. Distributions to participants are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a minimum of \$1,000 and a maximum of \$50,000. Loans are subject to approval by the plan administrator and bear interest at a reasonable annual percentage interest rate determined by the plan administrator. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Loans are secured by the balance in the participant's account. Principal and interest is paid ratably through payroll deductions.

***Forfeitures***

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will be used to pay the Plan's administrative expenses as they occur. Any remaining forfeitures will serve to reduce future Company contributions. At December 31, 2024 and 2023, the net forfeiture balance was \$23,621 and \$10,559, respectively. No forfeitures were used to pay administrative expenses in 2024.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Company.

***Other Income***

Certain mutual fund expenses that are charged by the mutual fund companies to the individual participants are recaptured by the Plan and held in a reserve account. These funds are then used to pay for expenses of the Plan that benefit the Plan participants, approved by the IRS, Department of Labor, and ERISA, such as administration and audit fees. As of December 31, 2024 and 2023, the balance in this fund amounted to \$11,752 and \$10,321, respectively. During the year ended December 31, 2024, the Plan recaptured \$874, which is included as other income in the accompanying statement of changes in net assets available for benefits.

**Note 2. Summary of Significant Accounting Policies**

The following is a summary of significant accounting policies followed by the Plan.

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

***Subsequent Events***

The Plan has evaluated subsequent events through October 17, 2025, which is the date the financial statements were available to be issued.

**Note 3. Financial Information Certified by the Plan's Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more or such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds and a money market fund managed by Fidelity. Fidelity is the trustee, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules, as defined by ERISA.

The Plan paid \$101,627 of record-keeping fees and \$98,534 of investment advisory fees to Fidelity during the year ended December 31, 2024.

**Note 5. Tax Status**

The Plan operates under a non-standardized pre-approved plan which has received a favorable opinion letter from the IRS, dated June 30, 2020, indicating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Further, the plan administrator believes and represents that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Financial Accounting Standards Board has issued a standard regarding the accounting and recognition of income tax positions taken by the Plan. The plan administrator assesses the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all accounts will be valued as of the termination date, participants will become 100% vested in their accounts and the account balances will be distributed in full to the participants.

**Note 7. Risks and Uncertainties**

The Plan provides for a range of investment options in accounts which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could, in the near term, materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Note 8. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Money market fund*: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

This Form 5500 is being filed three days after the extended due date of October 15, 2025.

This retirement plan has been in continuous existence for over 25 years and has never had a prior late or deficient filing. We have always filed timely and in full compliance with IRS and Department of Labor requirements.

For this plan year, while the Form 5500 itself was fully prepared and ready for submission by October 15, we were awaiting the final Accountant's Opinion, audited financial statements, and Schedule of Assets from our independent CPA firm. That firm has undergone multiple ownership transitions over the past two years (merger, then acquisition), resulting in a significantly extended audit review process this year. We were first informed after the close of business on October 15 that the audit was still under final review and would not be released that day.

Because the filing cannot be considered complete without the CPA's Accountant's Opinion and schedules, we could not in good faith attest to the return's completeness on October 15. We filed immediately upon receiving the finalized audit deliverables and are submitting the complete return at the earliest possible opportunity.

This brief delay was not due to willful neglect, but the result of an unexpected audit delay outside our control — and in the context of a perfect multi-decade filing history.

We respectfully request that no penalties be assessed based on this reasonable cause.
