Notes to Financial Statements

Note 1: Description of Plan

The following description of the Regency Terrace South 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Regency Terrace South, Inc. d/b/a Hales Corners Care Center covering all eligible employees of Hales Corners Care Center and Care-Age of Brookfield, a related organization (collectively the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility and Participation

Substantially all employees become eligible to participate in the Plan upon attaining the age of 21. To qualify for matching and profit sharing contributions, the employee must have made elective contributions during the year, completed 1,000 of hours of service within the Plan year, complete one year of service, and be employed by the Company on the last day of the Plan year.

Contributions

Participants may elect to defer up to 100% of compensation, as defined in the Plan, not to exceed the limits of the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Company may make discretionary matching and profit sharing contributions to the Plan. In 2024, the Company matched 50% of participant contributions, not to exceed 4% of the participant's eligible compensation. In 2023, the Company matched 25% of participant contributions, not to exceed 4% of the participant's eligible compensation. There were no profit sharing contributions made for the year ended December 31, 2024.

Investment Options

Participants direct how their and the Company's contributions are invested among several options that cover a wide range of fund objectives, risks, and returns. All investments are participant directed.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earning (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of a participant's account is based on the number of years of service.

Company contributions vest according to the following schedule:

<i>Years of Service</i>	<i>Vesting %</i>
1 year or less	0 %
2 years	20 %
3 years	40 %
4 years	60 %
5 years	80 %
6 or more years	100 %

Upon a participant's death, total disability, or attainment of normal retirement age 65, a participant's accrued benefit is 100% vested.

Forfeitures

Employees who terminate employment before they are 100% vested forfeit all or a portion of their Company contributions depending on their years of service. These forfeitures are used to pay administrative expenses or reduce Company contributions. Forfeitures of \$5,900 were used to pay administrative expenses or reduce Company contributions in 2024. Unallocated forfeitures totaled \$12,218 and \$13,794 as of December 31, 2024 and 2023, respectively.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or monthly installments for a period not to exceed the joint life expectancy of the participant and their beneficiary. Participants may receive distributions at retirement, or if the balance in the account exceeds \$7,000, they may defer payment. Participant accounts with values of less than \$1,000 will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment. If the participant account is greater than \$1,000, but is less than \$7,000, and the participant has not elected a rollover into an eligible retirement plan or a cash distribution, the Plan Administrator will distribute the balance into an individual retirement account as soon as administratively feasible after termination of employment. Under certain circumstances participants may qualify to receive a hardship distribution.

SECURE 2.0

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Note 2: Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Certain administrative and investment advisor expenses of the Plan are paid by the Plan. Other administrative expenses of the Plan are paid by the Company and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

As of May 2025, the Company assets were acquired by Complete Care. As a result of the transaction the Sponsor of the Plan was changed to Complete Care.

Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds Held in Pooled Separate Accounts: Fair value is estimated using the net asset value (NAV) per unit by the issuer of the pooled separate accounts. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Fully Benefit-Responsive Investment Contracts (FBRICs)

The Plan invests in FBRICs with Voya Retirement Insurance and Annuity Company (Voya) in the form of a guaranteed investment contract (GIC). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Voya is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but minimum guaranteed interest rate may vary by participant based on the date that they elect to participate in the fund. The guaranteed minimum floor rate may change after the defined period, but will never be lower than the minimum guaranteed interest rate.

Certain events limit the Plan's ability to transact at contract value with Voya including plan termination and other events as specified in the GIC. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Voya to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Trustees

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, including investments held, cash and cash equivalents, and FBRICs at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Voya and Advisor Trust, Inc., collectively the Trustee's of the Plan.

Note 6: Income Tax Status

The IRS has determined and informed the Plan by a letter dated January 25, 2021, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax exempt from federal and state income taxes.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Party-in-Interest Transactions

Certain Plan investments are managed by Voya, and Advisor Trust, Inc. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations.

Note 9: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
