### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matters – Plan Termination and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, Evergreen North America Industrial Services approved a plan liquidation on December 31, 2023 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting used in presenting the 2024 and 2023 financial statements. Also as described in Note 1, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of October 17, 2024. Our opinion is not modified with respect to these matters.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.



**NOTE 1 – DESCRIPTION OF PLAN**

Evergreen North America Industrial Services 401(k) Plan (the Plan) is a 401(k) plan adopted by Evergreen North America Industrial Services (Evergreen), to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally effective on April 1, 2005, and most recently amended effective January 1, 2021. The Plan allowed other employers to adopt its provisions. As of December 31, 2023, the following companies were participating employers in the Plan: GEM Mobile Treatment Services, Inc.; Western Relief, LLC; Targhee, Inc.; North American Services Group, LLC; North American Field Services, LLC; NAES Northeast, LLC; Mussop, Inc.; and North American Industrial Services, Inc. Evergreen North America Industrial Services and the participating employers are hereinafter collectively referred to as the Company. The Plan was administered by the Company and was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Plan Termination: Effective December 31, 2023 (Termination Date), Evergreen made the decision to terminate the Plan. Upon Termination Date, no further contributions were made to the Plan and all amounts credited to participant accounts were 100% vested. Evergreen directed the distribution of participant accounts in a manner permitted by the Plan. In conjunction with the termination of the Plan, all assets were fully distributed from the Plan as of October 17, 2024.

Eligibility: Prior to the Termination Date, all non-excluded employees of the Company and adopting employers who had completed six months of service and attained the age of 21 were eligible to participate in the Plan. The Plan's entry date was the first day of the Plan year quarter coinciding with or next following the date an employee satisfied the eligibility requirements.

Contributions: Prior to the Termination Date, participants could elect to defer up to 100% of their eligible compensation into the Plan as a pre-tax 401(k) or Roth 401(k) deferral, not to exceed the dollar limit set by law. Participants who were age 50 or over could also defer an additional amount called a catch-up contribution. Participants could revoke their salary deferral election at any time during the Plan year. Participants could be permitted to deposit into the Plan distributions they had received from other retirement plans and certain IRAs.

During 2024, the Company matched 100% of the participants' elective deferrals up to 4% of eligible compensation.

Prior to the Termination Date, the Company could make a discretionary matching contribution equal to a uniform percentage of participants' salary deferrals. Each year, the Company would determine the amount of the discretionary percentage. During 2024, the Company did not make a discretionary employer matching contribution. The Company could also make a discretionary profit-sharing contribution to the Plan. The profit-sharing contribution would be allocated or divided among participants eligible to share in the contribution for the Plan year. For 2024, the Company did not make a discretionary profit-sharing contribution.

Participant Accounts: Each participant's account was credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeiture of employer discretionary matching contributions and was charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Each participant directed the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant was entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants were always 100% vested in their deferral contributions, including catch-up contributions and rollover contributions, safe harbor matching contributions, plus any earnings thereon. Vesting in discretionary employer matching contributions and profit sharing contributions was based on years of vesting service. Participants would become 100% vested after six years of service and all participants became 100% vested upon the Plan Termination date.

Payment of Benefits: Participants could receive a distribution of the vested portion of some or all of their accounts in the Plan upon termination of employment, normal retirement, disability, or death. If a participant's vested account balance did not exceed \$5,000, then the participant's vested account balance could only be distributed in a single lump-sum payment. If a participant's vested account balance exceeded \$5,000, the participant had to consent to any distribution before it could be made.

Participants who had attained age 59½ could receive an in-service distribution from their vested accounts. Hardship distributions could also be made to satisfy certain immediate and heavy financial needs that a participant may have had.

Notes Receivable from Participants: Participants could borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date of the new loan over the participant's current outstanding balance of loans as of the date of the new loan. Loans were secured by the balance in a participant's account. All loans would bear a reasonable rate of interest. Principal and interest were paid ratably through payroll deductions or payment by check. The term of the loan could not exceed five years unless it was for the purchase of a participant's principal residence.

Forfeitures: If a participant terminated employment before being fully vested, then the non-vested portion of the terminated participant's account balance remained in the Plan and was called a forfeiture. The Company could use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. At October 17, 2024 and December 31, 2023, the forfeited non-vested account totaled \$-0- and \$1,961, respectively. During 2024, the Plan used \$1,833 of forfeitures to reduce employer contributions and \$116 of forfeitures to pay Plan expenses.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment management related expenses were included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through August 28, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: Due to the Company terminating the Plan effective December 31, 2023; it was determined by Plan management that liquidation was imminent and therefore, the financial statements were prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP) for the period from January 1, 2024 to October 17, 2024 and year ended December 31, 2023. The adoption of the liquidation basis of accounting did not have a material effect on the financial statements.

Estimates: The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein. Actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments other than the fully benefit responsive investment contract are reported at fair value as further described in Notes 4 and 5. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plans gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risk, such as interest rate, market, credit, and risks resulting from global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets in liquidation as of October 17, 2024 and December 31, 2023.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at October 17, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 to October 17, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are defined as follows:

*Level 1* – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2* – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3* – Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

**Mutual Funds:** The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**Pooled Separate Accounts:** The fair values of participation units held in pooled separate accounts are based on the net asset values as reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption process that are determined by the fund’s net asset value per unit.

**Non-Benefit Responsive Investment Contract (NBRIC):** Upon termination of the Plan and the adoption of liquidation basis, the Plan’s investment in the guaranteed investment contract was determined to no longer be benefit responsive and valued at fair value as of the termination date. The fair value of the contract has been determined to approximate contract value, based upon its lack of contractual maturities, the frequency of the re-setting of contractual interest rates to market rates, participant transactions typically being executed at contract value, and the credit quality of the issuer (level 3 inputs). Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses.

\*Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statement of net assets in liquidation as of December 31, 2023.

**NOTE 5 – GUARANTEED INVESTMENT CONTRACT**

The Plan held a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by Principal and was reviewed for resetting.

Effective December 31, 2023, in conjunction with the Plan termination (Note 1) and the adoption of liquidation basis (Note 2), the guaranteed investment contract was determined to no longer be benefit-responsive as the plan termination limited the ability of the plan to transact at contract value. At December 31, 2023, the guaranteed investment contract was determined to be non-benefit responsive and was recorded at fair value (Note 4) and fair value of the guaranteed investment contract approximated contract value.

Contract value was the relevant measure for fully benefit-responsive investment contracts because this was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represented contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed investment contract did not contain provisions that permitted Principal to terminate the contract or settle at an amount less than contract value due to Plan termination or other employer-initiated events. Additionally, the Plan did not impose competing fund restrictions, equity wash provisions, or other transaction limitations that would affect participants' ability to transact at contract value.

The Plan's ability to receive amounts due was dependent on Principal's ability to meet its financial obligations. Principal's ability to meet its contractual obligations could be affected by future economic and regulatory developments.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds certain investments managed by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company who are service providers to the Plan and, therefore, these transactions and the Plan's payment of fees to the service providers qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated November 30, 2020, indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended and restated from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 17, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routing audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
