Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Continental Home Care Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Plan Description

The following description of the Continental Home Care Retirement Plan (Plan) provides general information only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

The Plan was established on January 1, 2020 and was amended and restated on May 23, 2022. The Plan is a defined contribution plan covering employees of Continental Home Care (Company) and is subject to the provisions of the *Employee Retirement and Income Security Act of 1974* (ERISA), as amended.

Eligibility

All employees of the Company who have met the eligibility requirements are covered by the Plan. The Plan covers all employees except union employees, nonresident aliens, highly compensated employees, and leased employees. Employees are eligible to participate in the Plan immediately upon their date of employment. Participation in the Plan is voluntary. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Contributions

The Plan provides each participant with an opportunity to make elective pre-tax and Roth contributions to the Plan, subject to limitations of the Internal Revenue Code. Participants may also contribute amounts representing eligible rollovers from other qualified plans, as defined in the plan document.

The Company is not required to make any matching contributions to the Plan. The Employer is required to make a "prevailing wage contribution" on behalf of each Participant who performs services subject to the *Service Contract Act*, *Davis-Bacon Act*, or similar federal, state, or municipal prevailing wage statutes. The "prevailing wage contribution" will be an amount equal to the remaining balance of the prevailing wage defined bona-fide fringe benefit amount, based on the Participant's employment classification as designated on the appropriate prevailing wage determination, after the application of other prevailing wage defined bona-fide fringe payments. The "prevailing wage contribution" is considered a qualified nonelective contribution and is required on a pay-period basis. The participants can elect to opt-out on a pay-period basis to instead receive the employer contribution as gross wages.

Starting July 1, 2024, the Company offered its participants the option to elect to have the "prevailing wage contribution" as additional income as an alternative to a qualified nonelective contribution.

Participant Investment Account Options

The Plan provides for contributions to be invested by the participants among any of the various investment options in accordance with participant investment elections and the provisions of the trust agreement. Participants should refer to the plan document for additional fund information.

Participants Accounts

Each participant's account is credited with the participant's contribution and allocation of: (a) the Company's contribution and (b) Plan's earnings and is charged with an allocation of administrative expenses for investments with the trustee. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately and fully vested in their contributions and the Company's contributions plus earnings thereon.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance incurred during the 12-month period ending on the day before the date on which the loan was made or 50% of their vested account balance. A participant may have one loan outstanding at a time. Loan repayment terms are not to exceed 5 years; or 30 years if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Notes receivable from participants are repaid through payroll deductions and monitored by the plan administrator. Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. As of December 31, 2024, the interest rate on all outstanding notes receivable from participants ranged from 4.25% to 9.50%. Loans that are in default are accounted for as a reduction of net assets available for benefits in the year the default occurs and are treated as a deemed distribution. As of December 31, 2024 there was no balance of defaulted loans.

Payment of Benefits

A participants' vested interest in the Plan's assets are distributable generally upon termination, disability, retirement, or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the Plan document.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of the Plan's assets, liabilities, and changes therein, and disclosure of contingent asset and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

All transaction fees for loan and distribution requests are paid from participants' accounts. Substantially all other administrative expenses are paid from participants' accounts (see Note 6), otherwise they are to be paid by the Company.

Note 3. Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liabilities; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Common collective trust fund: The fair value of the common collective trust is determined by the trustee of the common collective trust funds based on the underlying assets, which represent the net asset value of the units held by the Plan. Participant-directed redemptions can be made on any business day and do not have a redemption notice period. There are no unfunded commitments.

Mutual funds: Stated at fair value based on unadjusted quoted prices in an active market at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Risks and Uncertainties

The Plan's investments are concentrated in mutual funds and common collective trusts. Such securities are subject to various risks, such as interest, credit, and market risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the statements of net assets available for benefits.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

ADP Retirement Services (ADP) is the record keeper for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to ADP for administrative services amounted to \$139,305 for the year ended December 31, 2024. Services rendered by the investment advisor also qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$305.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to amend, alter, or terminate the Plan subject to provisions of the ERISA. In the event of the Plan's termination, all participants are entitled to receive their entire interest in the Plan. No Plan assets may revert to the Company.

Note 9. Tax Status

On October 6, 2020, the Internal Revenue Service (IRS) stated that the nonstandardized defined contribution pre-approved prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Subsequent Events

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
