Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Aero Metals, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1. Plan Description

The following brief description of the Aero Metals, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: The Plan is a defined contribution plan covering all eligible employees of Aero Metals, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees of the Company become eligible to enter the Plan and to make elective deferrals when they have completed two months of service and are age 18 or older. Employees become eligible to receive employer contributions when they have completed 12 consecutive months of service during which at least 1,000 hours of service are completed and are age 18 or older. Under the terms of the Plan, the following employees are considered excluded and may not participate in the Plan: union employees, nonresident aliens, leased employees, and residents of Puerto Rico.

Contributions: Each year, participants may contribute up to 75% of their pretax annual compensation to the Plan subject to Internal Revenue Service (IRS) and ERISA limitations. The Plan allows elective deferral contributions to be made as Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from another qualified defined benefit or contribution plan (rollovers). The Company, at the option of its board of directors, contributes an amount from their net profit or accumulated (retained) earnings. These amounts are determined at the sole discretion of the employer. For 2024 and 2023, the Company contributed \$0 and \$110,000, respectively, allocated to matching contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's own contribution and an allocation of the Company's contribution and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions plus earnings thereon is based on years of service, as defined by the Plan. A participant is fully vested after 6 years of credited service.

Forfeitures: Forfeitures of account balances of terminated participants attributable to Company contributions other than matching contributions are allocated to remaining participants' accounts. At December 31, 2024 and 2023, forfeited account balances were not material.

Investment options: Upon enrollment in the Plan, a participant may direct employee contributions in various investment options.

Payment of benefits: Upon termination due to death, disability or retirement, a participant may elect to receive the value of his or her account in a lump-sum amount, rollover to a qualified plan, or installments. Upon any other type of termination or upon normal retirement age, a participant shall be entitled to a lump-sum benefit equal to his or her vested interest in the Plan. If, after termination, no election is made and the participant's vested account balance is \$5,000 or less it will be distributed in a lump-sum payment. In-service distributions are permitted for certain financial hardships and upon attaining age 59½.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Notes receivable participants: The Plan provides that participants can borrow funds against their account balances limited to the lesser of 50% of their vested account balance, or \$50,000. The notes bear interest at rates ranging from 4.25% to 9.50% which are commensurate with prevailing rates at the time the loan was issued.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Contributions: Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results may differ from these estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair value measurements: Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Note 2. Significant Accounting Policies (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

Shares of registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust: Valued at the net asset value (NAV) of the units held by the Plan at year-end. The value is supported by the information reported by the investment advisor using the audited financial statements of the fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Plan.

Subsequent events: Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Note 5. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 16, 2020, stating that the form of the preapproved plan documents was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Party-in-Interest Transactions

During 2024, administrative fees of approximately \$23,000, were paid to ADP, the trustee of the Plan, and \$24,000, to Merrill Lynch Brokerage firm for investment services related to the Plan assets, which qualifies as a party-in-interest transaction.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
