- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Danos, LLC 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule H, Line 4i- Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1) Description of plan

The following description of Danos, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering substantially all employees of Danos, LLC (the Company or Employer) who are 18 years of age and who have 2 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan sponsor may make matching contributions equal to a discretionary percentage of the participants elective deferrals, which is determined by the Employer. For the period January 1, 2023 through December 31, 2023, the Employer match was 25% of employee elected deferral not to exceed 15% of their compensation, exclusive of any performance bonuses. This match formula was revised through plan amendment as of January 1, 2024. Beginning January 1, 2024, the Plan will fund two different matching contribution formulas. The Plan will fund a matching contribution of 50% on the first 6% of employee elected deferrals applied to employees under payroll code 9VR for departments 10-Shelf, 11-Deepwater, 12-Land, and 14-12MS. The Plan will also fund a matching contribution of 25% on the first 15% of employee elected deferrals funded to all other eligible employees. Matching contributions were \$827,433 and \$1,167,137 for the Plan years ended December 31, 2024 and 2023, respectively. Each year, the Plan sponsor may make profit sharing contributions as determined by the Plan sponsor's board of directors. Qualified non-elective contributions (QNECs) and qualified matching contributions (QMACs) may be made by the Plan sponsor to satisfy special nondiscrimination rules that apply to the Plan. These QNECs and QMACs are fully vested when made. Contributions are subject to certain IRS limitations. There were no profit sharing contributions made in 2024 and 2023.

(c) Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Forfeitures

Forfeitures of terminated participants' non-vested accounts are used first to pay Plan expenses and then used to reduce Employer contributions. Plan expenses and Employer contributions were reduced by \$1,155,642 and \$-0- from forfeited non-vested accounts for the years ended December 31, 2024 and 2023, respectively. Cumulative forfeited non-vested accounts total \$56,373 and \$819,952 at December 31, 2024 and 2023, respectively.

(e) Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A year of service is defined as the completion of 1,000 hours of service within a 12-consecutive month computation period. A participant becomes 100% vested after three years of credited service. All contributions are 100% vested upon attaining the normal retirement age, death, or disability.

1) Description of plan (continued)

(f) Payment of benefits

Upon termination of employment due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of his or her account. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Balances under \$5,000 may be paid out at the discretion of the Company, as defined in the Plan documents. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(f) Note receivable - participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest, which is equal to the prime rate as printed in the Wall Street Journal at the time of the loan, plus 1%.

2) Summary of accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the plan but not yet paid as of December 31, 2024 and 2023.

(d) Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Notes receivable – participant loans

Notes receivable from participants are measured at their unpaid balance plus unpaid accrued interest. Defaulted loans are deemed distributed and recorded as benefits paid to participants in the statements of changes in net assets available for benefits. During 2024 and 2023, \$107,074 and \$40,023, respectively in deemed distributions were recorded.

(f) Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan assets, unless otherwise paid by the Company. Administrative expenses recorded in the Plan represent custodian fees, audit fees, and other record keeping fees that are deducted from participant's accounts and paid directly to the trustee. Loan fees and distribution fees are charged directly to the participant's account. These fees qualify as party-in-interest transactions.

(g) Net transfers from other plans

In conjunction with Danos, LLC's business acquisition activities, plan assets have been transferred into and out of the Plan, respectively. When an acquired company's plan is terminated, those participants are given the option to roll over their accounts into the Plan. Such rollovers are included in the Rollover line item of the accompanying statements of changes in net assets for benefits. Mergers of acquired company plans which result in plan assets transferred into the plan or divestitures which result in transfers out of the plan are included in the Transfers from/to other qualified plans line item of the accompanying statements of changes in net assets available for benefits. The following table summarizes such plan transfers for the year ended December 31, 2024:

3) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

4) Investments

During the years ended December 31, 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$7,414,216 and \$7,696,310, respectively.

5) Risks and uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

6) Tax status

The Plan is based on a prototype plan, which received an opinion letter from the Internal Revenue Service dated October 6, 2020, stating that the prototype plan was designed in accordance with the provisions of the Internal Revenue Code. The Plan has been amended since receiving the letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6) Tax status (continued)

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that would likely not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to tax examinations by tax authorities for a period of three years from the filing of those returns.

7) Information certified by the Plan's trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

8) Fair value measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different measurement at the reporting date.

11) Secure Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. While of the significant provisions became effective in 2024 and thereafter, there was no material impact to the Plan's 2024 or 2023 financial statements.

12) Subsequent events

The Plan has evaluated subsequent events through the date of the auditor's report, the date which the financial statements were available to be issued.

The Plan changed the trustee to ADP Retirement Trust Services, LLC and adopted a new plan document that supplements and amends the Plan, effective January 1, 2025. The Company has not yet requested or received a determination letter for the new Plan document. The Company believes that the provisions under the new plan document are on compliance with the applicable requirements of the IRC.

Effective July 1, 2025, retained former employees of Wood Group PSN, Inc. as of March 13, 2023 shall be immediately 100% vested in their matching contributions, and retained employees of Wood PLC's Onshore Oil and Gas Labor Supply shall be immediately 100% vested in all Employer matching contributions. For vesting purposes, participants years of service with Shamrock Management, LLC, Shamrock Energy Solutions, LLC, Wood Group PSN, Inc. will be counted.
