## Independent Auditors' Report

To the Plan Participants and Plan Administrator  
Hampton University Tax Deferred Annuity Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Hampton University Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical



requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

#### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The following description of the Hampton University Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

The Plan is a defined contribution plan established by Hampton University (Plan Sponsor) under the provisions of Section 403(b) of the Internal Revenue Code (IRC). Employees are eligible to participate in the Plan upon date of hire.

The Plan Sponsor's designated plan administrator is responsible for the general administration of the Plan. Teachers Insurance and Annuity Association (TIAA), College Retirement Equities Fund (CREF), and TIAA Trust, N.A. are custodians and recordkeepers of the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**(b) Contributions**

Each year, participants may make tax-deferred elective contributions to the Plan as soon as administratively feasible after their hire date, subject to the limitations of the IRC, which was \$23,000 for 2024. Participants age 50 or older or who attain age 50 during the plan year may make "catch-up" contributions as defined by the IRC, which were limited to \$7,500 in 2024. In addition, participants having 15 years of service are permitted to make a "special 15-year catch up" contribution as defined by the IRC. The Plan Sponsor does not make contributions to the Plan.

**(c) Vesting**

Participants are fully and immediately vested in their contributions plus actual earnings thereon made under the Plan.

**(d) Participant Accounts**

Each participant's account is credited with the participant's contributions and account earnings or losses, less withdrawals, based on the direction of the participant.

**(e) Payments of Benefits**

Participants may receive all or a portion of their vested account balance resulting from participant elective contributions upon termination of employment, upon becoming disabled, upon reaching 59½ years of age, upon reaching 65 years of age, or due to hardship (see note 1(f)).

Benefits are payable upon participant's request of distribution under the following options: (1) a lump-sum distribution equal to the value of the participant's vested interest in his or her account; (2) partial payments; (3) installment payments; or (4) an annuity contract or conversion to an income option.

Participants who terminate employment prior to retirement may elect to have their balance distributed in a lump sum or transferred to an individual retirement account or another employer's qualified plan. Death benefits are paid according to the benefits election in effect at the time of death.

**(f) Hardship Withdrawals**

Under certain conditions, participants, while still employed by the Plan Sponsor, are permitted to withdraw their account balance in a single sum. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of education tuition and related expenses, the payment of burial or funeral costs of immediate family members, the payment to repair the participant's principal residence that would qualify for a casualty loss deduction, or to prevent eviction or foreclosure from the participant's principal residence.

**(g) Loans to Participants**

Generally, participants may borrow a minimum of \$1,000 up to a maximum of \$50,000, subject to certain restrictions. Loans used to purchase a primary residence may be repaid over 10 years. Loans for all other purposes must be repaid within 5 years.

*Participant loans* – loans that are issued directly from the participant's account and are reported in the statements of net assets available for benefits, with related income and activity reported in the statement of changes in net assets available for benefits. The interest rate for participant loans is fixed at the time of issuance at the prime rate plus 1%. Interest rates on outstanding participant loans ranged from 4.25% to 9.50% in 2024 and 2023. The repayments for participant loans are reinvested based on the participant's investment elections in place at the time of repayment.

*Plan loans* – prior to December 31, 2021, loans were issued directly from the funds owned by TIAA and loan proceeds were not removed from a participant's account balance. A portion of a participant's account balance is reserved, or held in collateral, to cover 110% of the outstanding loan balance in case of default. The collateral is held in the TIAA Traditional Annuity as either part of a GSRA contract or as a separate Retirement Loan contract. TIAA stopped issuing plan loans as of January 1, 2022.

The loan interest rate for these plan loans may be fixed or variable, and the initial rate is determined by the terms of the controlling contract, as are the rate adjustment details and frequency. Interest rates on outstanding plan loans ranged from 4.04% to 5.33% in 2024 and 2023. For loans that have collateral held in a GSRA contract, principal repayments increase the amount of TIAA Traditional Annuity funds available for the participant's use. For Retirement Loan contracts, principal repayments are transferred to the investment options chosen under the terms of the plan. For all plan loans, interest is paid directly to TIAA. Additionally, plan loans are specifically permitted by Section 4975(d)(1) of the Internal Revenue Code. Participants had outstanding loan balances due to TIAA of \$2,852 and \$13,197 as of December 31, 2024, and 2023, respectively. During 2024 and 2023, no funds were used to satisfy plan loan defaults.

Both types of loans meet the requirements from ERISA's prohibited transaction rules pursuant to the statutory exemption for loans under ERISA section 408(b)(1).

**(h) Administrative Expenses**

Administrative expenses of the Plan are indirect expenses that are charged to individual investment funds and reflected in the return on each investment of the Plan. See note 7 for more information. In addition, the Plan Sponsor also pays certain expenses of the Plan. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

**(2) Summary of Significant Accounting Policies**

**(a) Basis of Accounting**

The accompanying financial statements are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**(b) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

**(c) Investment Valuation and Income Recognition**

The Plan's investments are recorded at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments represents the change in fair value of assets from one period to the next and includes realized and unrealized gains and losses.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

**(d) Payment of Benefits**

Benefits are recorded when paid.

**(3) Investments**

The plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, as permitted under such election, the information certified by the Plan's custodians is not audited by the Plan's independent auditors except for comparing such information to the related information included in the accompanying financial statements and Supplemental Schedule H, line 4i. TIAA and CREF certify the plan investments and notes receivable from participants and related activity for the Plan's investments issued by TIAA and/or CREF, respectively. This certification

also extends to those investments which TIAA Trust, N.A., a national trust bank, held as a directed trustee or custodian that were record kept by TIAA. **(4) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement* are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan uses valuation techniques that maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in methodologies used at December 31, 2024 or 2023.

- Registered Investment Companies:
  - TIAA-CREF funds invest principally in equity securities, fixed-income instruments, other mutual funds, and short-term instruments in accordance with each fund's investment objectives. Fund holdings are valued using market quotations and determined in active markets. Each fund determines its share price or net asset value each day. Shares of TIAA-CREF funds are available for transactions at the closing net asset value on any business day. In an effort to reduce market timing and excessive trading, shareholders will be locked out of a fund for 90 days if a purchase, sale, and repurchase within that fund is made within a 60-day period.
  - CREF variable annuities invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. Annuity investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments, including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost, which approximates fair value. Accumulation units in CREF variable annuities are available for transactions at the closing accumulation unit value on any business day and are deemed to be actively traded. In an effort to reduce market timing and excessive trading, shareholders will be locked out of a fund for 90 days if a purchase, sale, and repurchase within that fund is made within a 60-day period, other than for the CREF Money Market Account.
- The TIAA Real Estate Account is a pooled separate account investing mainly in real estate and real-estate-related investments. The Plan's unit value is principally derived from the market value of the underlying real estate holdings of other real-estate-related investments. Unit values are calculated daily and are available to Plan Administrators and client investors on TIAA-CREF's website, as well as NASDAQ. Underlying holdings are primarily valued using independent appraisals or independent pricing sources.
- The TIAA Traditional Annuity is not fully benefit responsive and therefore, is reported at fair value, which approximates contract value. As this investment is contract based, observable prices for identical or similar investments do not exist, and accordingly, this investment is valued using a discounted cash flow model with unobservable inputs. The contract value equals the accumulated cash contributions

and interest credited to the contract, less any withdrawals. Liquidity restrictions apply that could impact the value realized upon exiting the contract.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) TIAA Traditional Annuity Contracts**

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA), Group Retirement

Annuities (GRA), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement. At December 31, 2024 and 2023, there were no GRA contracts outstanding.

The RA contracts are not considered fully benefit-responsive due to liquidity restrictions and are measured at fair value. The RA contract does not allow lump-sum cash withdrawals and transfers may spread over 10 annual installments. All other withdrawals and transfers from RA contracts must be spread over 10 annual installments (5 annual installments for withdrawals after termination of employment).

The SRA and GSRA contracts provide for full participant directed liquidity, and as a result qualify as fully benefit-responsive investment contracts and are carried at contract value. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions may purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's board of trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA contracts, the crediting interest rates was 5.38% and 6.25% as of December 2024 and 2023, respectively. For accumulating SRA and GSRA contracts, the crediting interest rates were 4.63% and 5.51% as of December 2024 and 2023, respectively.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**(7) Related-Party Transactions and Party in Interest Transactions**

All plan investments are managed by the custodians and, therefore, qualify as exempt party-in-interest transactions. The investments have asset-based fees that compensate the custodians. These fees were \$34,510 for the year ended December 31, 2024, which are included in net appreciation in fair value of investments within the statement of changes in net assets available for benefits.

**(8) Risk and Uncertainties**

The Plan invests in various investments. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(9) Tax Status**

The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan was adopted using a pre-approved plan document, which was issued a favorable opinion letter by the IRS on August 7, 2017. This opinion letter provides assurance that the form of the plan document complies with the requirements of IRC Section 403(b) as provided in Rev. Proc. 2013-22, however the opinion letter does not guarantee that the Plan is qualified under the IRC in operation. The Plan is required to operate in conformity with IRC to maintain the tax exempt status for plan participants under Section 403(b). Management believes that the Plan has operated in compliance with the Plan document and in accordance with ERISA

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**(10) Nonexempt Transactions**

For the plan year ended December 31, 2024, and 2023, the employee withholdings in the amount of \$441 and \$15,789 respectively were remitted to the Plan beyond the appropriate time period established by the Plan. These transactions constitute prohibited transactions as defined by ERISA. The Recordkeeper calculated total lost earnings and the Plan Sponsor will remit to the Plan \$2 related to the 2024 late remittances in 2025. The Plan Sponsor remitted to the Plan \$48 related to the 2023 late remittances.
