NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Golding Farms Foods, Inc. 401(k) Profit Sharing Plan (the “Plan”), sponsored by Golding Farms Foods, Inc. (the “Company”), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution profit sharing plan and trust with a deferred 401(k) arrangement, established by the Company as of January 1, 1996. Participation in the Plan’s 401(k) arrangement is discretionary for all employees attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions - Eligible participants who elect to participate can make pre-tax contributions to the Plan in an amount not to exceed the maximum amount allowable under the Internal Revenue Code.

The Company makes safe harbor matching contributions on a dollar for dollar basis up to the first 3% and 50% on the next 2% of annual compensation contributed by participants. Additionally, the Company can make a discretionary profit-sharing contribution and a discretionary matching contribution. No profit-sharing contribution or discretionary matching contribution was made in 2024.

Participant Accounts - Each participant's account is credited with the participant's contribution and Company safe harbor matching contributions as well as allocations of (a) the Company’s profit-sharing contribution, if any, and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Employee contributions are immediately fully vested, plus actual earnings thereon, as well as any safe harbor matching contributions. Employer discretionary matching contributions and employer profit-sharing contributions are both subject to a six-year graded vesting schedule.

Payment of Benefits - Participants or their beneficiaries are entitled to receive the entire amount of their interest in the Plan upon retirement, death, disability, employment termination, reaching age 59 ½ or qualifying for a “Hardship Distribution” as defined in the Plan. Upon termination of service, a participant may elect in writing to defer benefit payments until a date no later than his/her normal retirement date. A terminated employee may elect to receive the balance in his/her account in the form of a single lump-sum payment or a direct rollover.

Hardship Withdrawals - The Plan allows for “hardship” withdrawals in accordance with the Internal Revenue Service regulations as specified within the Plan.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Investment Options - Upon enrollment in the Plan, a participant may elect a number of various investment options consisting of mutual funds and a common collective trust. All investment transactions are participant directed. As such, participants may make transfers among investment funds at their discretion in whole percentages. In addition, participants may elect to change their investment options daily.

Notes Receivables from Participants - Participants may borrow from their fund accounts up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. The maximum payment term for any non-home loan is five years. The maximum payment term for any home loan is thirty years. The minimum loan is \$1,000. The loans bear interest at a rate of prime plus one percent. Participants may only have one loan outstanding from the Plan at a time.

Plan Expenses - All costs and expenses with regard to the purchase or sale of investments are paid by the Plan. The Company pays administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

Forfeitures - While participants are fully vested at all times in the safe harbor contributions, excess contributions may occur and these contributions are forfeited by the participant when identified by the Plan sponsor. At December 31, 2024 and 2023, forfeited non-vested accounts arising from excess contributions totaled \$203 and \$10, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value except for the fully benefit-responsive investment contract, which was reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits - Benefits are recognized when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Risks and Uncertainties - The Plan provides the participants with various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Fair Value Measurements - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

Disclosure of Subsequent Events - Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

NOTE 3 - SUMMARY OF CERTIFIED FINANCIAL DATA (UNAUDITED)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company and Voya Retirement Insurance and Annuity Company, the Custodians for the Plan, has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been certified to as complete and accurate by Reliance Trust Company and Voya Retirement Insurance and Annuity Company.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

During 2023, there were transactions involving the investment of Plan assets in accounts maintained by Voya Retirement Insurance and Annuity Company, a party-in-interest, as defined under Section 3(14) of ERISA.

NOTE 5 - FAIR VALUE MEASUREMENTS

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market

Level 2 (Continued) - data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust: The Invesco Stable Value Portfolio, held in a collective trust fund, primarily invests in investment contracts and security backed investment contracts. The objective of the stable value fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The investment is valued at NAV as a practical expedient to estimate fair value where NAV is based on the total assets of the fund, less its liabilities, divided by the number of units outstanding at the time of such computation. Participant transactions (purchases and sales) may occur daily. There are currently no redemption restrictions or unfunded commitments on this investment.

NOTE 6 - TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the employer non-discretionary contribution.

NOTE 7 - TAX STATUS

The Plan uses a prototype plan document sponsored by ADP, LLC. ADP, LLC obtained a favorable determination letter on October 6, 2020, in which the Internal Revenue Service stated that the prototype document satisfies the applicable requirements of the Code. The Plan itself has not received a determination letter from the IRS.

NOTE 7 - TAX STATUS (Continued)

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2021.
