NOTES TO FINANCIAL STATEMENTS

FROM JULY 1, 2024 TO APRIL 30, 2025 AND
YEAR ENDING JUNE 30, 2024

Note 1: Description of the Plan:

The following brief description of the Iron Workers Regional Shop Local 855 Welfare Trust (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description for more complete information.

General –

The Plan, a multiemployer health and welfare plan, was established on May 18, 1961, for the purpose of providing health care benefits to eligible participants and their dependents covered by the collective bargaining agreement between the Iron Workers Regional Shop Local 855 and individual employers signatory to the agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits –

The Plan provides health and welfare benefits for its non-bargaining participants including medical, dental, vision, prescription drug, hearing aid, life insurance, accidental death and dismemberment benefits, weekly accident and sickness and medical, prescription drug, hearing aid, and benefits for retirees. All prescription drug, vision, short-term disability and some medical (up to individual and aggregate stop loss limits) benefits are self-funded by the Plan. All dental, life insurance benefits (basic, supplemental and dependent), accidental death and dismemberment, mental health and some medical benefits are insured with premiums paid by the Plan.

The Plan management has entered into a stop-loss insurance arrangement in an effort to limit the Plan's exposure for self-funded medical benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Under the terms of the contract individual participant claims incurred in excess of \$350,000 are reimbursed to the Plan.

The Plan provides medical insurance for its bargaining participants with Kaiser Permanente.

Contribution and Eligibility –

Participating employers are required to pay an hourly contribution to the Plan for each compensable hour of employment worked by covered employees. Employer contributions on behalf of each participant are credited to a reserve (accumulated eligibility credits) maintained for the participant under the Plan. The principal hourly employer contribution rate in effect for the Plan is \$6.71 for the period ended April 30, 2025 and year ended June 30, 2024, respectively. Retiree participants contribute to the plan at rates determined by the board of trustees.

Participants become covered initially on the first day of the eligibility quarter immediately following a qualifying quarter during which they worked at least 345 hours for a contributing employer, which has made the required contribution on their behalf. Once the participant attains initial coverage the participant will continue to be eligible provided, they continue to work at

least 345 hours of covered employment for a contributing employer that makes the required contribution on his behalf during any qualifying quarter.

As a result of the eligibility provisions of the Plan, hours worked in March, April and May provide eligibility for July, August and September; hours worked in June, July and August provide eligibility for October, November and December; hours worked in September, October and November provide eligibility for January, February and March; and hours worked in December, January and February provide eligibility for April, May and June. For non-bargained employees, hours worked provide eligibility in the subsequent month.

Under certain conditions, participants are permitted to maintain Plan coverage by making self-payments. Retired participants are provided benefit coverage in accordance with eligibility provisions of the Plan.

Continuation of health care benefits to persons who could otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (COBRA), has been adopted by the Plan.

Priorities upon termination of the Plan –

Although the board of trustees has not expressed intent to discontinue the Plan. They may do so at any time, subject to the provisions of ERISA and the terms of the collective bargaining agreement. In the event of the termination of the Plan, the assets of the Plan would continue to be used to pay reasonable administrative expenses and to distribute and apply remaining surplus as the trustees so determine, until no assets remain.

Note 2: Summary of Significant Accounting Policies:

Basis of Accounting –

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates –

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Employer Contributions and Contributions Receivable –

Employer contributions reported in the financial statements include amounts relating to hours worked by covered employees through June 30, plus material delinquent contributions.

The Plan has an employer payroll audit system in place in which the employers are audited to verify that they are contributing in accordance with their signed agreement. Delinquencies may arise due to these payroll audits, but due to the uncertainty of collections, no estimates of the contributions will be accrued.

Payment of Benefits –

HMO insurance premiums paid by the Plan are recorded as insured benefits in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid to the third-party claims' processor. These payments are recorded as self-funded benefits in the accompanying statements of changes in net assets available for benefits.

Investment Valuation and Income Recognition –

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statement of changes in the net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Stop Loss premiums –

Premiums for stop loss insurance are included in insured benefits in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$246,262 and \$2,228,324 for the period ended April 30, 2025 and year ended June 30, 2024, respectively, have been netted with self-funded benefits in the accompanying statements of changes in net assets. As of April 30, 2025 and June 30, 2024 stop loss refunds receivable were \$ - and \$3,037,418, respectively.

Refunds and Rebates –

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$37,900 and \$116,952 for the period ended April 30, 2025 and year ended June 30, 2024, respectively, have been netted with self-funded benefits in the accompanying statements of changes in net assets available for benefits.

Current Benefits Obligations –

Plan obligations on June 30, 2024 for claims incurred by participants but not reported at that date are estimated based on an analysis of claims paid subsequent to the Plan year end. Such estimated amounts are included in the accompanying statements of Plan's benefit obligations.

Claims and premiums reported through September 30, 2024 total \$2,300,000, respectively. These amounts have been estimated on the basis of statistical lag analysis and have not been included in the amounts currently payable on the statement of benefits obligations. The estimated liability for future benefits (insurance premiums) is based on the accumulated months of eligibility at plan year end, multiplies by effective premium rate for insured benefits and by per capita cost. This liability is recorded as other obligations, net of amounts currently payable on the statement of benefit obligations.

Deferred Contributions –

Deferred contributions consist of employer contribution payments for non-bargaining participants received in June for July benefit coverage. Total amount of deferred contributions on June 30, 2024 was \$271,288.

Concentration of Risk –

The Plan maintains its cash balances at high credit quality financial institutions. Accounts at these institutions are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, these cash balances may be in excess of the insurance limit. The Trust has not experienced any credit losses on its cash and cash equivalents to date as it relates to FDIC insurance limits.

Trust operating and administrative expenses –

The Plan's expenses are paid by the Plan as provided in the Plan Document. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events –

The Plan management has evaluated subsequent events through October 4, 2025, the date which the financial statements were available to be issued. The trust has determined that there are no material events that would require recognition in or disclosure in the Trust's financial statements through this date.

Note 3: Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at April 30, 2025 and June 30, 2024.

Mutual funds (including money market mutual funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7: Related Party and Parties-in-Interest Transactions:
As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

The Iron Workers Regional Shop Local 855 Pension Plan, Welfare Plan, and Individual Account Retirement Plan share the same Board of Trustees and are therefore considered related parties.

The Iron Workers Regional Shop Local 855 Pension Trust collects contributions on behalf of the Local 855 Trust Funds. These contributions are transferred monthly to the respective Trust. At June 30, 2024, \$216,196 were due to the Plan for employer contributions, respectively. In addition, the Iron Workers Regional Shop Local 855 Welfare and Individual Account Retirement Plans wire funds to the Iron Workers Regional Shop Local 855 Pension Plan to pay for the operating expenses incurred by the individual Funds on their behalf. Common administrative expenses are allocated to each trust on a percentage basis. There were no amounts due to the Iron Workers Regional Shop Local 855 Pension Plan on April 30, 2025 and June 30, 2024 for expenses. Total expenses allocated to the Plan for the period ending April 30, 2025 and year ending June 30, 2024 were \$298,362 and \$291,604, respectively.

Note 8: Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimated liability for benefit obligations is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Note 9: Plan and trust amendments:

On August 31, 2024, the Board of Trustees amended the Summary Plan Description and Plan Rules to bring the plan in conformity with the Consolidated Appropriation Act of 2021.

On August 31, 2024, the Trust Agreement was amended by the Board of Trustees to officially change the name of the Trust from "Shop Ironworkers Local 790 Welfare Plan" to "Iron Workers Regional Shop local 855 Welfare Plan" effective July 1, 2024.

Effective September 1, 2024, the language in the notice to all participants is updated to reflect the termination of the comprehensive medical and prescription drug plan and the implementation of the Kaiser Permanente HMO Plan for active bargained employees.

On September 8, 2024, the Board of Trustees adopted the "No Surprise Act" which protects patients who receive Emergency Services at a Hospital or an Independent Freestanding Emergency Department. This amendment protects patients who receive non-emergency services From a Non-Blue Cross Provider as a participating facility.

On March 13, 2025, the Board of Trustees adopted an amendment to terminate the trust as of April 30, 2025 and merge the Plan with another group health plan effective May 1, 2025.

Note 10: Termination of the Plan:

The Board of Trustees of the Welfare Plan expressly reserves the right to amend, modify, revoke, or terminate the Plan, in whole or in part, at any time. Benefits provided under this Plan are not vested. The Board of Trustees expressly reserves the right, in its sole discretion, to:

- a) terminate or amend either the amount or condition with respect to any benefit even though such termination or amendment affects claims which have already accrued; and
- b) alter or postpone the method of payment of any benefit; and
- c) amend, terminate or rescind any provision of the Plan; and
- d) merge the Plan with other plans, including the transfer of assets.

The authority to make any such changes to the Plan rests solely with the Board of Trustees. Any amendment, modification, revocation, or termination of the Plan is made by a resolution adopted by the Board of Trustees. In the event the Plan is terminated, all assets remaining in the Plan, after payment of expenses, will be used to continue the benefits provided by the then-existing benefit plans, until such assets have been exhausted. No individual Trustee, Union representative, or Employer representative is authorized to interpret this Plan on behalf of the Board of Trustees, or to act as an agent of the Board of Trustees. The provisions of the Plan are subject to and controlled by provisions of the Trust Agreement, and in the event of any conflict between provisions of the Plan and provisions of the Trust Agreement, provisions of the Trust Agreement shall prevail.

Note 11: Tax Status:

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated March 29, 1963, stating that the trust is tax-exempt under the provisions of Section 501(c) (9) of the Internal Revenue Code (IRC). In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 12: Merger of trust assets:

On May 1, 2025, the Welfare plan merged with the Ironworkers Regional Health and Welfare Plan (IW Regional H&W Plan).

As of the transfer date, the Welfare plan assigned and transferred its assets and liabilities to the IW Regional H&W Plan. The trustees of the IW Regional H&W Plan will assume obligations that will include but not limited to audit, actuarial, consulting administrative, legal and other fees incurred by the Shop Welfare plan. Current eligibility of active members that was maintained by the Shop Welfare plan will continue under the terms of the new plan agreement. The obligations also included all claims, including stop loss and subrogation rights, received by participants and dependents prior to the transfer date. All investments were sold prior to the plan merger. At May 1, 2025, \$6,935,154 was transferred to the IW Regional H&W Plan.
