### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Access Healthcare LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits as of December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

### ***Basis for Opinion***

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern over the twelve months from the report date.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## **Notes to Financial Statements December 31, 2024 and 2023**

---

### **Note 1: Description of Plan**

The following description of Access Healthcare LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan, initially effective January 1, 2020 and amended on May 20, 2022, is a defined contribution plan covering substantially all employees of Access Healthcare LLC (the Company or the Plan Sponsor), except, union employees governed by the terms of a collective bargaining agreement, and nonresident aliens, and any employees who become employees due to an asset or stock acquisition, merger, or similar transaction. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility of Participation**

Employees become eligible to participate in the Plan immediately upon reaching the age of 21 and after completing three consecutive months of eligibility service beginning on the employee's date of hire.

#### **Contributions**

Participants may make pre-tax and Roth 401(k) contributions to the Plan through payroll deductions up to 92% of their Plan compensation, as defined by the Plan Document, subject to the statutory limit set by the Internal Revenue Code (IRC). The limit for 2024 was \$23,000. Participants who have attained at least age 50 are eligible to defer additional amounts (catch-up contributions). The maximum catch-up contribution was \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Company provides matching contributions of 50% of the first 4% of compensation deferred by each employee.

In addition to matching contributions, the Plan Sponsor may make discretionary profit-sharing contributions. In general, the participant must have completed at least 500 hours of service during the plan year or be an employee of the Plan Sponsor on the last day of the plan year to share in the allocation of discretionary profit-sharing. Such additional discretionary profit-sharing contributions are subject to limitations under the IRC and allocated to employees pro rata based on the ratio that each participant's compensation bears to the total compensation of all qualified participants of the Plan year. There were no discretionary profit-sharing contributions in 2024.

#### **Administration**

The Company serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. The Company engaged PayChex, Inc. (PayChex) to assist in the administration of the Plan.

PayChex is the Custodian of the Plan and Mid Atlantic Trust Company (Mid Atlantic or Trustee) is the Trustee of the Plan pursuant to the Plan Document. The Trustee holds Plan assets, pays benefits to participants as directed by the Plan Administrator and is responsible for the administration of investments for the benefit of the participants and their beneficiaries.

### **Participant Accounts**

Each participant's account is credited with pre-tax, Roth and rollover contributions made by the participant and the participant's portion of Plan Sponsor discretionary matching contributions, discretionary profit-sharing contributions and actual Plan earnings thereon. The participant's account is also charged with withdrawals, applicable allocations of investment gains/losses and administrative expenses. Allocations are based on the participant's Plan compensation, account balances or specific participant transactions, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

### **Vesting**

Participants are immediately 100% vested in their contributions, rollover balances, and investment performance thereon. Participants become 100% vested in matching and discretionary profit-sharing contributions and investment performance thereon after three years of service.

### **Investment Options**

Participants are required to make participant-directed allocations of their accounts in increments totaling 100%, among various investment options offered by the Custodian and selected by the Plan Administrator. Participants may change their investment options daily.

### **Payment of Benefits**

In general, participants may receive an in-service distribution of their vested account balance after attaining age 59 ½. Hardship withdrawals are not permitted within this Plan.

Upon normal retirement (age 59 ½), disability or death, a participant or beneficiary may receive the value of the account through a lump sum distribution or partial distributions, when applicable. Terminated employees that defer distribution of their benefits are required to pay all fees incurred by the Plan to administer the participant's deferral payment.

Participants withdrawing from the Plan due to termination of employment, other than due to retirement, death, or disability, may receive the value of their vested account by transfer to another qualified plan or individual retirement account or through a lump sum distribution. In general, if the participant's account balance, as defined in the Plan Document, is less than \$5,000, distributions will be made as soon as administratively feasible following the severance of employment and do not require participant consent. If the participant's account balance, as defined in the Plan Document, is greater than \$5,000, distributions are to be made in a uniform and nondiscriminatory manner established by the Plan Sponsor and require participant consent.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service (IRS) penalties unless the distribution is transferred to another qualified plan or individual retirement account.

## **Note 2: Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### **Cash and Cash Equivalents**

Cash and cash equivalents consist of deposits with financial institutions. At times, deposit balances may exceed the Federal Deposit Insurance Corporation issued limit. The Company believes it mitigates any risks by depositing cash and cash equivalents with major financial institutions.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of investments, including gains and losses, are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net depreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

### **Risks and Uncertainties**

The Plan's invested assets are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

### **Forfeited Accounts**

Forfeitures of terminated employees' nonvested accounts are used to reduce Plan Sponsor contributions, as defined in the Plan Document. The outstanding forfeiture balance totaled \$81,685 and \$23,498 as of December 31, 2024 and 2023, respectively.

### **Payments of Benefits**

Benefit payments are recorded when paid by the Plan.

### **Administrative Expenses**

Administrative expenses of the Plan are liabilities of the Plan but may be paid by the Plan Sponsor. These expenses include, but are not limited to, legal, accounting and recordkeeping fees, and investment expenses. For administrative expenses not paid by the Plan Sponsor, a proportionate share of fees and expenses paid by the Plan is charged to each participant's account.

### Note 3: Information Certified by Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental information:

### Note 4: Fair Value Measurements

The accounting standard for fair value measurements provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in non-active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The money market fund's carrying value approximates fair value.

Mutual funds are valued at quoted market prices as provided by the Custodian.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5: Income Tax Status**

The Plan Sponsor entered into a standard adoption agreement with Paychex, Inc. (the Prototype Plan). The Prototype Plan received a favorable opinion letter from the IRS dated August 31, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

The Plan Administrator believes the Plan is designed and currently operating in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax exempt as of December 31, 2024.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6: Party-in-Interest Transactions**

Paychex and their affiliates perform services for, sold products to, and managed and maintained certain investments of the Plan for which fees are charged to the Plan. Transactions with these providers qualify as party-in-interest transactions.

Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**Note 7: Reconciliation to Form 5500**

The financial information of the Plan, as reported on Form 5500, does not include all amounts necessary for reporting on the accrual basis of accounting. A reconciliation of the amounts appearing on the 2024 Form 5500 to the accompanying financial statements follows:

**Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subjected to the provisions of ERISA. In event of partial or full termination of the Plan, affected participants will become 100% vested in their accounts.

**Note 9: Prohibited Transactions**

The Plan Sponsor deducted \$65,941 during 2022 from participants’ gross wages that was not remitted in a timely manner to the Plan in accordance with DOL Rules and Regulations. In 2024, the Plan Sponsor filed Form 5330 with the IRS, paid the required excise tax, and made restoration contributions to the Plan to restore earnings. There were no prohibited transactions for the years ended December 31, 2024 and 2023.

**Note 10: Subsequent Events**

The Plan Sponsor has evaluated subsequent events between December 31, 2024, the date of the statements of net assets available for benefits, and the report date, which is the date these financial statements were available for issuance and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
