Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of West Tennessee Bancshares, Inc. 401(k) Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the West Tennessee Bancshares, Inc. 401(k) Employee Stock Ownership Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 10 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the West Tennessee Bancshares, Inc. 401(k) Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

General

West Tennessee Bancshares, Inc. (the “Plan Sponsor”) established the West Tennessee Bancshares Stock Ownership Plan effective January 1, 1990. The Plan operates as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by a third-party administrator appointed by the Trustees of the Plan. Merger of the West Tennessee Bancshares, Inc. 401(k) Plan into the West Tennessee Bancshares, Inc. Stock Ownership Plan formed the West Tennessee Bancshares, Inc. 401(k) Employee Stock Ownership Plan (KSOP), effective April 1, 2014.

Participation and Contributions

An employee becomes eligible to make voluntary pre-tax contributions into the plan on the first day of the calendar quarter after hired. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Effective October 21, 2021, participants may make tax deferred voluntary contributions or Roth (non-tax deferred) voluntary contributions.

Employees are eligible to receive employer contributions and participate in the employee stock option portion of the plan when they have reached age 20-1/2, six months of service, and worked 1,000 hours or more during the Plan year. Participants who are not employed on the last day of the Plan year are not eligible for an allocation of Plan Sponsor contributions to the Plan for such year.

There were no 401(k) employer matching contributions during 2024. For the employee stock ownership component of the Plan, employer contributions are made annually to fund terminated participant accounts and those terminated participant shares are reallocated to remaining participants. For the year ended December 31, 2024, employer contributions totaled \$148,713. Contributions are subject to certain IRS limitations.

Investment Options

The Plan currently offers diversified investment options for participant directed investments through a pooled separate account, except for Company stock. Upon enrollment in the Plan, a participant may designate their contributions in any increment in any one or more of the investment accounts. Participants may change their investment options and transfer previously contributed amounts between these investment accounts at any time.

Notes Receivable from Participants

The Plan includes a loan feature, which allows a participant to borrow the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the balance in the participant's vested account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The interest rate established at the time of the loan remains consistent during the entire term of the loan. Principal and interest is repaid ratably through payroll deductions. As of December 31, 2024 and 2023, there were \$12,526 and \$0 of outstanding loans, respectively.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of service as follows:

Participants are 100% vested after normal retirement, death, disability, plan termination, or 7 years of credited service for employer contributions.

Forfeited non-vested accounts can be used to reduce future employer contributions, pay plan administrative expenses, or ESOP forfeitures are allocated to participants. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. For the year ended December 31, 2024 and 2023, \$2,252 and \$6,837 of forfeitures were allocated to participant accounts.

Payment of Benefits

Upon termination of employment, a participant is entitled to a distribution of a Plan interest in an amount equal to the participant's vested benefit as of the last day of the Plan year in which employment is terminated. If the participant's vested balance is \$5,000 or less, they will receive a lump-sum payment upon termination. If the participant's vested balance is greater than \$5,000, they can elect to receive payment in annual installments or one lump-sum payment equal to vested interest in the account.

Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon attainment of 59 ½.

Effective January 1, 2020, any participant, active or terminated, who reaches age 72 must begin withdrawal payments no later than April 1 of the next Plan year. Benefits may be paid in cash or Company common stock with cash for fractional shares.

Voting Rights

The Trustee votes all shares held by it as part of the Plan assets. However, each participant is entitled to exercise voting rights attributable to the shares allocated to their account with respect to certain corporate matters identified in the Plan document.

Put Option

Under Federal income tax regulations, the Plan Sponsor stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Plan Sponsor buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to redeem such shares for cash.

Participant Accounts

Each participant's account is credited as of the last day of the Plan year with an allocation of shares of the Plan Sponsor's common stock released by the Trustee from the unallocated account, an allocable share of any employer matching, if any, and forfeitures of terminated participants' non-vested accounts. Allocations are based on a participant's eligible compensation relative to total eligible compensation of all participants. Plan earnings are allocated to each participant's account based on the ratio of the participant's end of the year account balance to all participants' end of the year account balances before the allocation of employer contributions and forfeitures for the current valuation period.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Plan Sponsor stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less the number of any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution to direct at their discretion.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. The Plan permits the payment of other Plan expenses to be made from the Plan's assets. Certain Plan expenses are paid by the Plan Sponsor.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

The Plan's investments are stated at fair market value, as defined by generally accepted accounting principles. See Note 3 for disclosure of fair value measurement.

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Purchases and sales of the Company's stock are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of investment income, realized gains (losses), and the unrealized appreciation (depreciation) on investments.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Contributions receivable is recorded at the estimated net realizable value. An allowance for credit losses is recorded based upon management's estimate of expected credit losses, determined by using subsequent collections. Management has determined that an allowance for credit losses is not considered necessary as of December 31, 2024.

Benefits are recorded when paid.

The Plan's financial instruments that are exposed to concentrations of credit risk consist primarily of cash equivalents. The Plan's cash equivalents are placed with a federally insured financial institution.

Date of Management's Review

The Plan sponsor has evaluated its December 31, 2024 financial statements for subsequent events through October 10, 2025, the date the financial statements were available to be issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE 3 – FAIR VALUE INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under generally accepted accounting principles are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value of shares held by the Plan at year end.

Company common stock: Valued at the per share price from an independent outside business appraisal. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. Plan management reviews the appraisal prior to its completion. This appraisal was based upon a combination of income and market valuation techniques consistent with prior years.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – ADMINISTRATION OF PLAN ASSETS

Shares of Plan Sponsor common stock and cash are held by the Bank of Bartlett, a wholly-owned subsidiary of the Plan Sponsor.

Certain administrative functions are performed by officers or employees of the Plan Sponsor subsidiaries at no compensation from the Plan.

The stated fair value of \$20.75 per share utilized at December 31, 2024 and \$20 per share utilized at December 31, 2023 is based on independent valuations using financial information through December of each year. It is reasonably possible that changes in the value of the stock will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, including the Company's common stock. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of certain investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, the rights of all affected participants to benefits accrued to the date of such termination, to the extent then funded, are nonforfeitable. The Trustees shall direct the distribution of the assets of the trust fund to participants in accordance with the Plan provisions and the IRC.

NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under United States Department of Labor Regulations as any party providing fiduciary services for the Plan, any party rendering service to the Plan, the employer and certain others. Certain Plan investments are managed by John Hancock Life Insurance Company, the custodian of the Plan and, therefore, those transactions qualify as party-in-interest. The Plan incurs expenses related to general administration and recordkeeping. Certain expenses and professional fees are paid by the Plan Sponsor.

Additionally, investments in Plan Sponsor common stock are considered to be party-in-interest investments. These transactions are exempt from the prohibited transaction provision of ERISA and the Internal Revenue Code.

NOTE 9 – FEDERAL INCOME TAX STATUS

The Internal Revenue Service issued a determination letter dated February 20, 2014 stating that the Plan, as restated, qualifies under Section 1.401-1(b)(3) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.

NOTE 10 – SUMMARY OF INFORMATION CERTIFIED BY PLAN CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the plan custodian, has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment activity for investments at fair value, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- John Hancock Life Insurance Company investments reflected in schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.
