Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Center for Human Development, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Center for Human Development, Inc. (“Company”) Retirement Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General The Plan is a defined contribution plan covering all full-time employees of the Company who have completed at least one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employee Contributions Each year, participants may contribute up to \$23,000 of pretax annual compensation calendar year 2024. (\$30,500 for participants aged 50) as defined in the Plan. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.

Participant Accounts Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to options offered by the Plan. The Plan currently offers investment options through Principal Financial Group.

Company Contributions The Company made contributions to the Plan of \$790,747 during the year ended December 31, 2024. The Company pays the accounting and legal fees incurred by the Plan, which totaled \$12,751 for the year ended December 31, 2024.

Vesting Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in qualified nonelective and matching employer contributions. Vesting in other employer contributions is based on years of continuous service. A participant is 25% vested after two years of service and receives an additional 25% of vesting in the Company’s contributions for each year of service. Participants are 100% vested after five years of credited service.

Participant Loans The plan allows loans to participants through Principal Life Insurance, subject to certain limitations. Plan loans are issued directly from the Vested funds of the participant and loan proceeds are treated as a participant directed investment of their account so loan interest income is treated as income of the participant’s account. The maximum loan amount is \$50,000.

At December 31, 2024 participants had outstanding plan loan balances due to Principal of \$169,884.

Payment of Benefits On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or an elective transfer to another qualified deferral plan.

Forfeited Accounts At December 31, 2024, forfeited non-vested accounts totaled \$7,832. Forfeitures of non-vested accounts can be used to pay administrative expenses or reduce Employer contributions and allocated among remaining plan participants in the same manner as the Employer's contributions from which the forfeiture occurred.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The trust maintains its records in accordance with generally accepted accounting principles. Income is recognized when earned and expenses are recognized when incurred. Net unrealized gains and losses are recognized as defined below.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions which affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Actual results could differ from those estimates.

Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Fair Value Measurements

Financial Accounting Standards Board ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

- *Common stocks, corporate bonds and U.S. government securities:* Valued at the closing price reported on the active market on which the individual securities are traded.
- *Mutual funds and Pooled Accounts:* Valued at the net asset value ("NAV") of shares held by the plan at year end using market quotations. Each fund determines its share price or net asset value (NAV) daily. See Note 3 for a further discussion of these accounts
- *Guaranteed investment contract:* See Note 7 for the valuation methodology of this account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Credit Risk

The trust is exposed to a concentration of credit risk. All funds are presently invested and managed by The Principal Financial Group. Participants have the ability to choose from various funds. Investment funds available carry varying degrees of investment risk. In addition the Plan is dependent on the Company's ability to fund employer contributions.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 – INVESTED ASSETS PREPARED AND CERTIFIED BY THE PRINCIPAL LIFE INSURANCE COMPANY

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified as complete and accurate by Principal Financial Group, the trustee of the plan.

These assets and related transactions were not subject to the auditing procedures performed on the remainder of the financial statements. These investments represent all of the Plan's net assets, other than contributions receivable. Plan Participants can direct where their individual accounts are invested among several investment options offered by Principal Financial Group.

Those investment options are listed in the supplemental information accompanying these financial statements. Investments representing 5% or more of the Plan assets are also listed on the supplemental information schedule.

NOTE 4—RELATED PARTY TRANSACTIONS

The Plan has contracted with the Principal Financial Group to be the trustee of the plan assets. Principal Financial Group manages plan assets, receives participant and employer contributions, offers investment options to plan participants through Pooled Accounts, allocates plan earnings, accounts for each participant account, and disburses benefit payments or transfers plan assets. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Trust for the investment management services of Principal Financial Group amounted to \$12,751 for the year ended December 31, 2024.

NOTE 5—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6—TAX STATUS

The Internal Revenue Service has determined and informed the Company that the Plan and related trust were in accordance with applicable sections of the Internal Revenue Code (IRC) when originally established. In a letter dated March 31, 2014 the Internal

Revenue Service confirmed that the form of the Plan is acceptable under section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Subsequent to the most recent IRS letter, amendments have been made effective November 20, 2018. Although a determination has not been made by the IRS following these most recent amendments, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 7—INVESTMENT CONTRACT WITH PRINCIPAL FINANCIAL GROUP

The Plan has entered into an investment contract with Principal Financial Group. Principal Financial Group maintains contributions in pooled accounts. The accounts are credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses charged by Principal Financial Group. The contract is included in the financial statements at fair value because it does not meet the criteria to be considered fully benefit-responsive. There are no reserves against contract value for credit risk of Principal Financial Group or otherwise. The fair value of the investment contract at December 31, 2024 was \$26,938. The average yield and crediting interest rates are approximately 1.0%. The crediting interest rate is based on an agreed-upon formula with Principal Financial Group, but cannot be less than zero.

NOTE 8 -- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – RECONCILIATION TO FORM 5500, SCHEDULE H

There are no differences between net assets available for benefits per the financial statements and Schedule H of Form 5500.
