INDEPENDENT AUDITOR'S REPORT

To the Retirement Committee
Weather Group, LLC 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Weather Group, LLC 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1: DESCRIPTION OF PLAN

The following description of the Weather Group, LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time or part-time employees of Weather Group, LLC, Allen Media Digital, LLC and CF Entertainment, Inc. (AKA Entertainment Studios). The Weather Group, LLC was acquired on March 22, 2018, by Entertainment Studios (the Company or the Plan Sponsor). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Vanguard Fiduciary Trust Company (Vanguard), the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Retirement Committee and provides certain recordkeeping services and annual ERISA compliance testing.

Eligibility

Employees may become a participant of the Plan when they have completed one month of service and are age twenty-one or older. An eligible employee may enter the Plan immediately after all entry requirements have been met.

Contributions

Each year, participants may make contributions to the Plan of not less than 0.5% or not more than 50% of their eligible compensation (base salary, overtime, commissions and bonuses). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. Full-time participants are auto-enrolled to make contributions of 3% of eligible compensation which auto-escalates by 1% annually up to a maximum of 6% of eligible compensation unless they affirmatively elect not to participate in the Plan and their contributions are invested into a default fund selected by the Plan Sponsor until changed by the participant. Participants can elect to make post tax deferrals into a Roth 401(k) account. Participants are eligible for distributions from their Roth contribution account upon reaching age 59½, subject to vesting requirements. Participants who have attained age 50 before the end of the participant's taxable year are eligible to make catch-up contributions to the Plan. Prior to June 1, 2024, the Company contributed to participant accounts an amount equal to 100% of the participant's payroll deferral contribution up to 1% of wages, plus 50% of payroll deferral contributions on the next 5% of wages. The Plan was amended effective June 1, 2024 to no longer provide for these safe harbor contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Weather Group, LLC 401(k) Savings Plan Notes to Financial Statements

Note 1: DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's safe harbor contributions (prior to the June 1, 2024 amendment) and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and earnings thereon. Company safe harbor contributions vest 100% after the completion of two years of vesting service as defined by the Plan document. Participants become 100% vested in Company safe harbor contributions, regardless of the length of vesting service, if while employed by the Company, they attain the age of 65, become permanently disabled, or die.

Notes Receivable from Participants

The Plan allows participants to obtain loans from their individual accounts. Participants may borrow up to 50% of their vested account balance, subject to a minimum of \$1,000 and a maximum of \$50,000, reduced by the highest outstanding loan balance during the preceding 12 months. Loans must be fully repaid within five years from date of issuance, except those loans used to purchase the principal residence of a participant, which must be fully repaid prior to normal retirement date or a period of years, not to exceed 25, from date of loan. The notes receivable are collateralized by the balance in the participant's account and bear interest at rates established by the Company, which are generally commensurate with the prime rate plus 1%. The range of interest rates on notes receivable at December 31, 2024, is 4.25% to 9.25%. Principal and interest is repaid ratably through payroll deductions.

Benefit Payments

Participants or beneficiaries are entitled to receive the vested balance of their account upon termination of employment, retirement, death, or permanent and total disability. The Plan will pay to the participant or beneficiary the benefit owed as follows:

- a) If the vested account balance is \$1,000 or less, the benefit will be paid in a lump sum.
- b) If the vested account balance is greater than \$1,000 but less than \$5,000, the participant may elect to roll-over the benefit into another employer's qualified plan, an already established IRA, or if no election is made, into a Vanguard IRA automatically established on behalf of the participant.
- c) If the vested account balance exceeds \$5,000, the participant may choose to defer payment until the earlier of when they reach age 70½ or elect to take a lump sum distribution.
- d) In the event of death, if the beneficiary is the spouse of the participant, the spouse must elect the form of payment of the balance. Further, as beneficiary, the spouse may elect to defer payment until the date the participant would have reached age 70½. If the beneficiary is not the surviving spouse, the beneficiary will be paid the vested balance in a lump-sum payment.

Forfeitures

Any amounts forfeited by participants are used by the Company to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$260,914 and \$133,151, respectively. For the year ended December 31, 2024, forfeitures of \$19,426 were used to reduce employer contributions.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. At December 31, 2024, there were no participant loans which were deemed benefit payments.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued October 14, 2025. See Note 8 for the relevant disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard, the qualified institution:

- a) Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- c) Investment income information and interest income on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- d) All amounts included in Note 4, *Fair Value Measurements*.
- e) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 4: FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common collective trusts (CCT): The Plan's CCTs are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, this NAV based investments have been excluded from the fair value hierarchy leveling.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

Note 5: TAX STATUS

The plan is a prototype plan, which has received its most recent favorable opinion letter from the IRS, dated June 30, 2020, stating that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the prototype plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 5: TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of registered investment companies managed by an affiliate of the Trustee, Vanguard. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. In addition, loans to participants qualify as party-in-interest transactions, which are also exempt from the prohibited transaction rules. During 2024, the Plan paid administrative expenses of \$147,898 to Vanguard and \$92,121 to the Plan's investment advisors.

Note 7: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8: SUBSEQUENT EVENT

Subsequent to year end, the Plan sponsor indicated its intention to transition the Plan's trustee service provider from Vanguard to Empower Trust Company, LLC in 2026.
