### **Independent Auditor's Report**

**Note 1: Description of the Plan**

The following description of the Redwood Trading, LLC 401(K) Plan (the Plan) provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering the employees of Redwood Trading, LLC (the Company). Eligibility is 250 hours of service in the first three months after employment or completion of 1,000 hours of service in the first year of employment. An employee becomes eligible to enroll in the Plan on the first day of the Plan quarter following eligibility. Collective bargaining employees and non-resident aliens are excluded from being eligible for the Plan. Part-time employees are eligible to contribute to the Plan, if they meet the 250/1,000 hours of service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and later amendments.

Effective January 1, 2023, the Participation agreement was modified to add Stricks Ag, LLC to the existing plan.

**Participant Contributions - Self Directed**

Participating employees may elect to enter into a contribution reduction agreement to reduce compensation up to the maximum allowable (100%) not to exceed IRS limits, which will be contributed to the Plan in their name. Participants are eligible to make after tax (Roth) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a pooled separate fund as investment options for participants.

The Plan may accept a proper rollover from another qualified plan. Roth rollovers are allowed.

**Employer Contributions**

The Company will make a safe harbor nonelective contribution of 3% of a participant's compensation.

At the end of the Plan year, the Company, at the discretion of the Company's Board of Directors, also may make a profit sharing contribution, as defined in the Plan document. For December 31, 2024 and 2023, the Company did not elect to make a profit sharing contribution. Both contributions are invested in the participant directed accounts in the same manner as the employee deferrals.

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. All costs, fees, and expenses associated with the participant's account maybe charged or deducted from the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Any other employer contributions, such as profit sharing contributions, are based on years of service and subject to a six year vesting schedule. An employee who becomes disabled, dies, reaches age 59 1/2 or passes the 5th anniversary of the first day of the Plan year in which the participant commenced participation in the Plan will become 100% vested in employer's contributions.

**Note 1: Description of the Plan (Continued)**

**Benefits**

On termination of service due to death, disability, retirement, or termination of employment, the participant may receive a lump-sum amount or a direct rollover distribution equal to the value of the participant's vested interest in his or her account. Under the current Plan, distributions for terminated participants will be made immediately with participant consent required if the balance exceeds \$5,000. For automatic distributions of participant account balances greater than \$1,000 up to \$5,000, the accounts are rolled directly to individual retirement accounts. The Plan also allows for in-service and hardship distributions subject to Plan provisions.

**Forfeitures**

Employer contributions, other than safe harbor contributions, are subject to a 6-year vesting period. Forfeitures can be used to reduce all types of employer match or reduce plan expenses. For the Plan years ending December 31, 2024 and 2023, forfeitures totaled \$0 and \$0 respectively. For the Plan years ending December 31, 2024 and 2023, no forfeitures were used to reduce employer contributions. The balances of the forfeitures accounts were \$0 and \$0 for the years ending December 31, 2024 and 2023, respectively.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Other expense are included in administrative expenses. Investment related expenses are included in the net appreciation of the fair value of investments.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the Board of Directors. Contributions from employees are accrued when withholding is made from employee's payroll.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are presented at fair value, as determined and certified by Principal Life Insurance Company (the Custodian) as of the Plan year-end. Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Net appreciation (depreciation) includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid. As of December 31, 2024, the Plan had three pending distributions totaling \$11,494. As of December 31, 2023, the Plan had no pending distributions.

**Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts**

Valued at fair market value. If there is no readily available market, then the account's value is the fair value of the underlying investments held in such separate account as determined by the Custodian using generally accepted accounting practices and applicable law. The Plan's separate account market value at any given date is equal to the Plan's units of participation multiplied by the unit value for the rate level chosen by the Plan Administrator.

**Note 4: Related Party and Party in Interest Transactions**

The Plan Sponsor absorbs some administrative expenses of the Plan, cost of audit fees, the TPA fees, and the cost of fiduciary bonds. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements.

Administrative functions are performed by officers or employees of the Company. Additional party-in interest transactions include audit fees paid to Varney & Associates, CPAs, LLC, EIP Corp, the third party administrator, and investment fees paid to the Custodian. These transactions qualify as exempt party-in-interest transactions.

**Note 5: Plan Termination**

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time subject to the provisions of ERISA. In the event of termination, each participant will have a non-forfeitable interest in his/her entire individual account.

**Note 6: Tax Status**

The Company adopted a non-standardized prototype plan document. The Internal Revenue Service issued an opinion letter, dated November 30, 2020, on the prototype plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

**Note 7: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 8: Information Prepared and Certified by Custodian (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and loans to participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

**Note 10: Subsequent Events**

Management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued.

The Plan plans to change Custodians in late 2025.

In 2025, Redwood Trading, LLC plans to remove the two participating entities from their plan. Participants from Stricks Ag, LLC and Lathrop FSG, LLC will cease to be active participants after this removal.

The impact of the change has been evaluated and it is determined that it does not constitute a partial plan termination under Internal Revenue Code Section 411(d)(3), as the reduction in participants did not result in a significant percentage of workforce turnover attributable to employer-initiated actions.
