As disclosed in Note 1 to the financial statements, on January 2, 2025, Northway Financial, Inc., the parent company of Northway Bank (the Plan Sponsor) merged with and into Camden National Corporation (Camden). Coinciding with the merger, the Plan was terminated and the remaining Plan assets were transferred to Camden's plan on March 31, 2025. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

### 1. Description of Plan

The following brief description of the Northway Bank 401(k) and Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

#### General

The Plan is a defined contribution plan that is available to all employees of Northway Financial, Inc. (the Company) and Northway Bank (the Bank) who have completed six months of service and are age 21 or older. The original effective date of the Plan was January 1, 1987. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Company is the holding company of the Bank. Fidelity Management Trust Company is the trustee of the Plan.

The Plan operates as a non-standardized pre-approved form of a plan sponsored by Fidelity Investments, Inc., whereby Fidelity Workplace Services, LLC provides administrative services for the Plan. Under the agreement, participants are provided investment options, including mutual funds and collective investment trusts. Participants should refer to the prospectus of each investment for further information.

On January 2, 2025, Northway Financial, Inc., parent company of the Plan Sponsor, merged with and into Camden National Corporation (Camden). Coinciding with the merger, the Plan was terminated and the remaining assets were transferred to Camden's plan on March 31, 2025.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, employer matching and the participant's portion of non-elective employer contributions, and Plan earnings and expenses. Forfeitures of terminated participants' non-vested accounts may be used for restoration of participants' forfeitures, if any, then to reduce Plan expenses, if any, and then to reduce future employer contributions. There were no forfeiture amounts as of March 31, 2025. Forfeiture balances as of December 31, 2024 and 2023 were not significant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Benefits

The Plan provides benefits to participants upon death, disability, retirement or termination of employment. Participants may elect to receive the benefit as a lump-sum payment, partial withdrawal, in installment payments or by rollover to another qualifying plan.

Participants are permitted to make hardship withdrawals and early withdrawals from their account provided they meet certain criteria.

#### Contributions

A participant may authorize the employer to withhold a percentage of their salary up to 100% of their compensation, subject to the maximum allowed by the Internal Revenue Service (IRS). Participants may contribute on a pre-tax or Roth basis to the Plan.

### 1. Description of Plan (Continued)

The Plan has an automatic enrollment feature. Employees are enrolled at a deferral rate of 3%, unless affirmative action is made to opt out. The Plan also includes an auto-escalation provision increasing deferral percentages by 1% each Plan year until the participant's deferral reaches 8%. Employees may also make an affirmative election to continue to increase their contributions automatically beyond 8%.

The Plan also allows for employer matching and non-elective employer contributions. The employer matching contribution shall be determined by the employer with respect to each Plan year. The employer shall have the right to make a non-elective contribution to be allocated to each participant in proportion to their eligible compensation for the Plan year while a participant. There were no employer non-elective contributions in 2025. The 2024 and 2023 employer non-elective contributions were \$197,000 and \$385,000, respectively, representing 1.5% and 3%, respectively, of eligible compensation.

For the period ended March 31, 2025 and the years ended December 31, 2024 and 2023, the employer matching contribution is calculated as 100% of the first 3% of employee contributions and 50% of the next 2% of employee contributions.

#### Vesting

Any elective deferrals or rollover contributions, plus or minus any earnings or losses, are 100% vested at all times.

Employer contributions and the earnings or losses thereon will vest in accordance with the following schedule:

Participants are automatically fully vested, regardless of the vesting table, upon attainment of normal retirement age (65), upon retirement due to disability, upon death, or upon termination of the Plan.

#### Administrative Expenses

Administrative costs are paid by the Plan to the extent that they are not paid by the employer. Participant accounts are assessed fees on a pro-rata basis to cover the administrative costs of the Plan, including transaction processing, recordkeeping, and Plan administration. Certain costs incurred by the Plan for investment management are included in the net (depreciation) appreciation in fair value of investments on the statements of changes in net assets available for benefits.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for a discussion of fair value measurements.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected to the extent that the income covers the cost of administrative fees. Consequently, a portion of management fees and operating expenses are reflected as a reduction of investment return for such investments.

Contributions are recorded in the period in which payroll deductions are made; employer matching contributions are recorded in the same period as corresponding participant contributions. Employer discretionary non-elective profit-sharing contributions are recorded in the year to which the contributions relate.

#### Benefit Payments

Benefits are recorded when paid.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for various investment options which invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

### 3. **Investments**

The Plan's investments, related investment (loss) income and investment transactions, including net (depreciation) appreciation of investments, were certified by Fidelity Management Trust Company (Fidelity), the trustee of the Plan. Plan Management has determined that Fidelity meets the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan Administrator and as allowed under Section 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to generally accepted auditing procedures by the Plan's independent public accountants.

At December 31, 2024 and 2023, the Plan's collective investment trust funds consist of investments in Schwab Managed Retirement Funds (SMRT Funds) and the Galliard Stable Return Fund (Stable Value Fund).

The SMRT Funds are designed to be a comprehensive investment option and seek to provide total return for investors retiring approximately at or near the target retirement date in the respective fund name, i.e., SMRT Fund 2010, 2015, 2020, 2025, etc. SMRT Income Fund seeks to provide return for investors near or in retirement.

The assets in the SMRT Funds are diversified across a variety of asset classes including, but not limited to, large cap equities, mid cap equities, international equities, fixed income, global real estate (REITs), commodities, intermediate-term bond, short-term bond, cash equivalents and inflation-protected bond (U.S. TIPS). Assets are allocated to a combination of underlying Schwab Institutional Trust Funds and non-proprietary unitized accounts and collective trust and mutual funds.

The SMRT Funds are valued each business day at their net asset values (NAV) that are calculated daily by Charles Schwab Trust Bank, the investment sponsor of the funds. The values of SMRT Funds will fluctuate up to and after the target retirement dates.

Per the Declaration of Trust, there is a 30-day notice requirement for a complete liquidation of a fund from the Plan.

The Stable Value Fund is a collective investment trust that seeks to provide investors with stability of principal and consistency of returns with minimal volatility.

### 3. **Investments (Continued)**

The Stable Value Fund invests in financial instruments that seek to provide participants with a stable crediting rate and safety of principal plus accrued interest. These include guaranteed investment contracts (GICs), security-backed contracts (GIC Alternatives), and separate account GICs. Underlying the security-backed contracts and separate account GICs are fixed income (bond) portfolios. The fixed income portfolios may include, but are not limited to, investments in U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, asset-backed securities, and bond funds. All bonds in the underlying portfolios are rated investment grade by one of the major rating agencies at the time of purchase. The fund may also invest in cash or cash equivalents.

The Stable Value Fund is valued each business day at its NAV calculated daily by SEI Trust Company, the trustee and investment sponsor of the fund.

Per the Declaration of Trust, there is a 12-month notice requirement for a complete liquidation of the fund from the Plan.

There are no unfunded commitments to the collective investment trust funds. The Plan may purchase units of the funds daily. The Plan may redeem units of the funds for payment of a benefit to a participant in accordance with Plan provisions, honoring an employee-directed transfer of the employee's interest in the Plan to another investment election that is a noncompeting investment, or paying trustee fees.

### 4. **Fair Value Measurements**

#### *Valuation Hierarchy*

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). For disclosures, a fair value hierarchy has been established that prioritizes the input to valuation techniques used to measure fair value into three levels:

Level 1 – Unadjusted quoted prices in active markets for identical assets.

Level 2 – Inputs other than quoted prices within Level 1 that are observable for the asset, either directly or indirectly.

Level 3 – Significant unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and December 31, 2024 and 2023.

Mutual funds: Valued daily at the quoted price reported in the active market in which the security is traded.

Collective investment trusts: Valued at fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

### 5. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

The Plan operates under a non-standardized pre-approved form of a plan, effective February 8, 2022. The Plan received an opinion letter from the IRS, dated June 30, 2020, as to its qualified status. The Plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan has continued to operate within the applicable sections of the Internal Revenue Code upon which the favorable opinion was based.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

#### 5. Tax Status (Continued)

Administrative fees consist of investment management, transaction processing fees, recordkeeping, and Plan administration paid to Fidelity Management Trust Company and its affiliates. These transactions qualify as party-in-interest transactions.

#### 6. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares in mutual funds managed by Fidelity Management Trust Company, the current Plan trustee. Therefore, these transactions qualify as party-in-interest transactions.
