Note 1. Description of the Plan

The following description of Frankston Packaging Company 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator. Prior to February 1, 2022, the Plan was named Deferred Profit Sharing Plan for Employees of Custom Labels, Inc.

General

The Plan is a defined-contribution plan sponsored by Custom Labels, Inc. (Company) established for the benefit of its employees who have at least two months of service and who are age 21 or older. Frankston Packaging Company, LLC and CLIVA, Inc. are participating employers of the Plan. Effective October 4, 2023, Custom Labels, Inc. was sold and Frankston Packaging Company, LLC became the Plan sponsor. Employees can begin participation on the beginning of the next quarter upon meeting eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company and Principal Life Insurance Company (Principal) serve as Plan custodian and the recordkeeper of the Plan. A member of Company management serves as the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to the maximum allowed by law. Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make a discretionary flexible matching contribution up to 4% of eligible compensation determined annually for those actively employed at July 31st. For the years ended July 31, 2024 and 2023, no matching contribution was elected to be made. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of credited service. Participants are 100% vested in Company contributions after six years of credited service based on an annual 20% vesting schedule starting in the participant's second year of service. The non-vested balance is forfeited upon termination of service. Forfeitures are used to reduce Company contributions or pay Plan administrative expenses.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance in the previous 12 months or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. There are no allowance for credit losses. The notes are collateralized by the participants' account balances. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of his/her account. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. Certain in-service withdrawals have a minimum withdrawal balance of \$500.

Forfeited Accounts

At July 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,156 and \$1,096, respectively. During 2024 and 2023, no forfeitures were used.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Plan Tax Status

Plan operates under a nonstandardized adoption agreement in connection with a prototype profit-sharing plan and trust/custodial document sponsored by Heard McElroy & Vestal, LLC. The Plan has not submitted to the Internal Revenue Service (IRS) for an individual determination letter as the prototype document has received a favorable opinion letter from the IRS. The Plan has been amended since the prototype received its favorable opinion letter, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of net assets available for benefits attributable to the fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at estimated fair value as provided by Principal.

The Plan's interest in the collective investment trusts is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end.

The fully benefit-responsive investment contract is valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Prefunded Contributions

As of July 31, 2024 and 2023, there were excess participant contributions funded to the Plan which will be applied to the funding of any Company matching contributions elected to be made to the Plan.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company and Principal Life Insurance Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits and related disclosures as of July 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended July 31, 2024
- Investment information included in the accompanying schedule of assets held at year end as of July 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended July 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 investments held include the pooled separate accounts and the common collective trust. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 investments held by the Plan.

Note 5. Investment Contract With Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Principal represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of Principal or other Principal events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed minimum interest rate will not be less than 1% or greater than 3%.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the Plan custodian. The Plan paid \$6,047 and \$4,853 of administrative fees to Principal during the years ended July 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

The Plan has an ERISA Budget Account in which \$16,748 and \$15,680 of credits were received and used to pay advisory fees to Kestra Advisory Services, LLC for the years ended July 31, 2024 and 2023, respectively.

Note 7. Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets.

Participant contributions and loan repayments of \$511 were not remitted within the required time period for the year ended July 31, 2024 and have not been remitted to the Plan.

Participant contributions and loan repayments of \$24,789 were not remitted within the required time period for the year ended July 31, 2023. Participant contributions and loan repayments of \$5,704 were not remitted to the Plan as of July 31, 2023 and have not been remitted to the Plan as of July 31, 2024.

Participant contributions of \$2,255 were not remitted within the required time period for the year ended July 31, 2022. A deposit of \$2,255 was made during the July 31, 2023 year end.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

In June 2025, the Plan was amended to change the Plan sponsor to Frankston Packaging Company, LLC (84-3421357), effective October 4, 2023, with the closure of Custom Labels, Inc.

Effective August 1, 2025, the Plan was amended to provide immediate eligibility to participate upon hire and monthly entry after hire date. The Plan was also amended to add an automatic deferral feature whereas all employees hired after August 1, 2025, and those actively employed without an election on file, are treated as electing to defer 1% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual 1% increase in the percentage deferred, each August 1st, and is ultimately capped at 5%.

Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were available to be issued.





