**NOTE 1 – DESCRIPTION OF PLAN**

Employees 401(k) Plan of Coburn Supply Company, Inc. (the Plan) is a defined contribution plan adopted by Coburn Supply Company, Inc. (the Company) effective as of April 1, 1994 and was amended and restated effective September 21, 2021. The plan was most recently amended May 31, 2024. The Plan is designed to encourage and assist eligible employees in adopting a regular savings program and provide additional tax-advantaged security for their retirement. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Significant provisions of the Plan are summarized below. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

Eligibility: Employees who are not covered by a collective bargaining agreement are eligible to participate in the Plan when they have attained age 21 and completed at least six months of service. Nonresident aliens who do not receive U.S.-source income from the Company are excluded from eligibility. The entry date will be the first day of each month they have satisfied the eligibility requirements.

Contributions: A participant may elect to contribute, on a pre-tax basis, up to 60% of the participant's compensation to the Plan. The maximum employee contribution cannot exceed the limits on pre-tax elective deferrals and annual additions permitted by the Internal Revenue Code (IRC) of 1986, as amended. Participants who have attained or will attain age 50 by the end of the calendar year may make additional catch-up contributions. The Plan also contains an automatic enrollment feature. If a participant is subject to automatic enrollment, a contribution of 6% will be automatically deducted from their compensation. Participants who are subject to automatic enrollment are notified approximately 35 days prior to the first deferral. Effective May 31, 2024, participants may elect to make Roth 401(k) contributions on an after-tax basis. These contributions are included in the participant's taxable income when made but may be distributed tax-free if certain conditions are met. Roth contributions are subject to the same deferral limits as pre-tax deferrals.

The Company contributes 100% of the first 6% of eligible compensation that a participant contributes to the Plan. The Company matching contribution is invested based on the participant's investment allocation. This contribution is intended to satisfy a safe harbor contribution formula permitted by the Internal Revenue Service (IRS) regulations.

The Company may also make matching contributions equal to 50% up to a maximum of 6% of the employee's deferral. Additional discretionary profit-sharing contributions may be made on behalf of eligible active participants at the option of the Company's Board of Directors. Contributions are subject to certain limitations. For 2024, the Company did not make any additional matching or discretionary profit-sharing contributions to the Plan.

The Plan accepts rollover contributions from eligible retirement plans, including Roth 401(k) contributions, provided they meet the IRS definition of an eligible rollover distribution.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's safe harbor contributions (b) Plan earnings or losses, and (c) forfeitures of matching and discretionary profit-sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are always 100% vested in their salary deferrals, catchup contributions, safe harbor contributions, and rollover contributions. Vesting in Company matching contributions and profit-sharing contributions, plus any earnings thereon, is based on vesting years of service. Participants will become 100% vested in Company matching contributions and profit-sharing contributions after completing three years of service, in accordance with the Plan's three-year cliff vesting schedule.

Investment Options: Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual funds and a collective trust fund as investment options for participants. Participants may redirect future contributions or exchange existing balances among available investment securities at any time.

Notes Receivable from Participants: Loans are available to participants on a reasonably equivalent basis. Participants may borrow from their vested account balance not less than \$1,000 up to a maximum of the lesser of \$50,000 reduced by the excess, if any, of their highest outstanding balance of loans from the Plan during the prior one-year period, or one-half of their vested interest in the Plan. All loans are adequately secured and charged a reasonable rate of interest. Loan refinancing is not permitted. Principal and interest payments are paid ratably through payroll deductions over a term not to exceed five years, unless the loan is obtained to purchase a principal residence, for which the Company may permit a longer repayment term. The maximum number of loans a participant may have outstanding at any one time is one.

Payment of Benefits: Upon termination of service before normal retirement age, a participant may elect to receive a single lump-sum payment in cash equal to the value of the participant's vested account balance, or to rollover the distribution directly to another qualified plan under section 401 of the IRC. If a participant's vested account balance does not exceed \$1,000 upon termination of employment, it will be automatically distributed in a lump-sum cash payment. If the vested account balance exceeds \$1,000 but is \$5,000 or less, it will be automatically rolled over to an individual retirement account (IRA) designated by the Plan, unless the participant elects otherwise. Upon normal retirement, disability, or death, the participant or beneficiary is entitled to receive the amount credited to their account. Benefits may be paid to the participant in a single lump-sum payment in cash or a direct rollover to another qualified plan. If the participant or their beneficiary is required to take minimum distributions, benefits may be paid in a series of payments as required by the IRC. Participants may take in-service distributions while still employed with the Company if they are age 59½ or older at the time of the distribution. If a participant has a financial hardship due to immediate and heavy financial need, they may withdraw from the vested balance of their deferral contributions subaccount, as permitted under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability. The Plan defines normal retirement age as 62. Participants who remain employed after reaching normal retirement age are entitled to receive benefits at any time and are 100% vested. A participant is considered disabled if they qualify for Social Security disability benefits or are certified as disabled by a physician, in accordance with Plan provisions.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant's accounts will become 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Forfeited Accounts: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account remains in the Plan and is called a forfeiture. The Company may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. Forfeited non-vested accounts totaled \$5,711 and \$1,647, respectively, at December 31, 2024 and 2023.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 10, 2025, which is the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit, and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: Valued using the market approach based on quoted market prices in active markets obtained from nationally recognized securities exchanges. These are classified as Level 1 measurements within the fair value hierarchy as they are based on unadjusted quoted prices for identical assets.

Collective Trust: Valued using the net asset value (NAV) as a practical expedient, as reported by the fund manager. The NAV is based on the fair value of the underlying assets of the fund, less its liabilities, and divided by the number of units outstanding. The fund permits daily redemptions with no notice requirement and is not subject to redemption restrictions. This investment is not classified within the fair value hierarchy.

There were no changes in valuation techniques or inputs during the years presented. The Plan recognizes transfers between levels at the end of the reporting period in which the event causing the transfer occurred. Investments measured at fair value on a recurring basis are summarized below:

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Fidelity Management Trust Company is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees qualify as party-in-interest transactions. Notes receivable from participants and investments issued by Fidelity Management Trust Company or one of its affiliates also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The IRS issued an opinion letter dated June 30, 2020, indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original non-standardized pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
