Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Action Property Management, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended January 31, 2025, and the related notes to the financial statements.

1. Description of Plan

The following description of the Action Property Management, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible full-time employees of Action Property Management, Inc. (the “Plan Sponsor” and “Plan Administrator”) and Action Property Group Holdings, Inc. The Plan was established by the Plan Sponsor on April 1, 1995 to provide retirement income for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”).

The Standard Insurance Company (“The Standard”) is responsible for, among other things, the custody and investing of the Plan’s assets and the payment of benefits to eligible participants. The Standard serves as the Custodian, the Trustee, and provides recordkeeping functions to the Plan.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act (“Secure 2.0 Act”) was passed by Congress. The Secure 2.0 Act contains numerous provisions that impact employee benefit plans. Generally, the deadline for formally adopting any required plan amendments made pursuant to the Secure 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective dates of each new provision. The Plan has administratively complied with and adopted all applicable provisions of the Secure 2.0 Act for the year ended January 31, 2025. Plan management expects the Plan to be formally amended prior to the Secure Act 2.0 deadline.

Eligibility

Employees of Action Property Management, Inc. that are 18 years of age and have been employed for 1 month are eligible to participate in the Plan. The Plan will cover all employees except non-resident aliens who receive no U.S. earned income and employees who are included in a unit of collective bargaining.

Contributions

The Plan is a contributory plan whereby participants may contribute up to a maximum of 100% of their annual compensation not to exceed the dollar limit set by law of \$23,000 for 2025. Participants age 50 or older may elect to defer up to an additional \$7,500 of “catch up” contributions to the Plan. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan Sponsor may make discretionary profit sharing and matching contributions to the Plan. The matching contribution is an amount equal to a discretionary percentage, to be determined annually by the Plan Sponsor, of the participants’ deferred compensation. The Plan Sponsor has elected to make a discretionary matching contribution of 20% of the participants’ deferral, up to 4% of the annual compensation and 4% of 100% of the participants’ deferral for the Millennium Tower Association division. The Plan Sponsor made matching contributions to the Plan of \$196,701 for the year ended January 31, 2025. There were no profit-sharing contributions made by the Plan Sponsor during the year ended January 31, 2025.

Participant Accounts

Each participant's individual account is credited with participant contributions, the Plan Sponsor's contributions, Plan investment earnings, and is reduced by Plan fees. Each participant's account is decreased by investment losses and depreciation in the value of investments, as well as withdrawals and distributions from their account. Participants may choose to have their account balance deposited in various investment programs. Allocation of Plan investment earnings is based on the participant's account balance, as defined.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer profit sharing and matching contributions is based on continuous service as follows:

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 maximum amount will be reduced by the participant's highest outstanding loan balance in the previous twelve months, even if amounts have been repaid. Loan terms range from 1 year to a maximum of 5 years, except for notes receivable used to purchase the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Sponsor. Interest rates on participant loans as of January 31, 2025 were 5.25 % to 10.50%. Principal and interest is paid ratably through payroll deductions or participant payments.

Corrective Distributions

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as corrective distributions. As of January 31, 2025 and 2024, corrective distributions amounted to \$10,716 and \$30,498, respectively.

Investment Options

The participants may self-direct employee and employer contributions into various investment options available for investment. The investment options include funds held in insurance company general accounts and pooled separate accounts that invest in a variety of underlying funds and mutual funds.

Payments of Benefits

Upon termination of service, a participant is entitled to receive, as benefits, a lump sum amount equal to the value of his/her account, distributed in accordance with the Plan. Benefits provided under this plan are neither, insured or guaranteed by the Plan Sponsor, by the Pension Benefit Guarantee Corporation a federal agency, nor under any state or federal law.

Forfeitures

Forfeited balances of terminated participating non-vested accounts may be used to pay Plan expenses or reduce Plan Sponsor contributions to the Plan. For the year ended January 31, 2025, \$98 was deposited into the forfeiture account. Forfeited non-vested accounts totaled \$98 and \$0 as of January 31, 2025 and 2024, respectively.

Administrative Expenses

Employees of the Plan Sponsor perform certain administrative functions. Neither the Plan Sponsor nor its employees receive compensation from the Plan. Administrative expenses including annual audit fees are paid by the Plan Sponsor. Investment service fees are paid by the Plan and are offset against the related investment income.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with generally accepted accounting principles in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. The Plan Sponsor believes that the estimates utilized in preparing these financial statements are reasonable and prudent. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are accrued on the ex-dividend date. Net depreciation includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

Units of the stable value fund are valued at contract value, which approximates fair value, as determined by the stable value fund trustee. Units of pooled separate accounts are valued at estimated fair values determined by the Custodian, which represent the net asset value of units held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is accrued on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable is recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant notes receivable is recorded when earned. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the loan balance is reduced and a benefit payment is recorded. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when incurred.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

3. Fair Value Measurements (Continued)

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: Quoted prices in active markets for identical assets or liabilities;
- Level 2: Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for financial instruments measured at fair value.

Pooled separate accounts ("PSA"): units held in pooled separate accounts are valued using net asset value ("NAV") as a practical expedient, provided by the administrator of the fund based on the valuation of the underlying investments.

4. Stable Value Fund

The Plan offers a fully benefit-responsive group annuity contract with The Standard by investing in The Standard Stable Value Fund. The Standard maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The Plan's investment contract specifies that generally there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value paid over time. There are not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value paid either within 90 days or over time. Currently, the Plan sponsor believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The crediting interest rate of the contract is based on an agreed-upon formula with The Standard, as defined in the contract agreement, but cannot be less than 1.0%. Such interest rates are reviewed on a quarterly basis. The resulting gain or loss in the fair value of the investment contract relative to its contract value, if any, is reflected in the Statement of Net Assets Available for Benefits as adjustment from fair value to contract value for fully benefit-responsive investment contracts. No adjustment amount is being reported as management has determined that there is no material difference between contract value and fair value of the contract as of January 31, 2025 and 2024.

5. Party-In-Interest Transactions

Certain Plan investments are managed by The Standard. The Plan allows participants to borrow from their vested balances. These transactions qualify as party-in-interest transactions. All of these transactions are exempt from prohibited transaction rules by ERISA.

6. Information Certified by the Custodian

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Standard, a qualified institution, has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate: investments in the statements of net assets available for benefits as of January 31, 2025 and 2024; net appreciation in value of investments and interest and dividends in the statement of changes in net assets available for benefits for the year ended January 31, 2025; and the investment information included in the supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of January 31, 2025.

7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9. Tax Status

The Plan is a volume submitter profit sharing plan. The plan received a favorable determination letter from the Internal Revenue Service on March 31, 2014 indicating that the specimen document was designed in accordance with applicable sections of the Internal Revenue Code (IRC). However, the determination did not constitute a determination of the qualification of an adopting plan sponsor. The Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Subsequent Events
