Thessalonika Family Services respectfully submits this letter to explain the circumstances surrounding the late filing of Form 5500-SF for the plan period ending December 31, 2022.

In January 2022, Thessalonika Family Services, a 501(c)(3) nonprofit organization, became a subsidiary of Rancho Community Reformed Church, a religious 501(c)(3) organization. During this transition, we were unaware that the former plan administrator had not filed the final Form 5500-SF for the retirement plan, which had effectively terminated on July 16, 2021. At the time of termination, there were no remaining plan participants and all plan assets had been properly distributed.

All plan-related communications were sent to the former administrator, who did not forward them to Thessalonika Family Services. As a result, we were not aware that the final filing had not been completed. Once this was discovered, we obtained the final Form 5500-SF from the former payroll company and are now prepared to submit it through the EFAST2 filing system.

We fully understand that this filing is now considered late and sincerely apologize for the error and misunderstanding. Since the plan was terminated prior to Thessalonika becoming a

subsidiary of Rancho Community Reformed Church, we respectfully request exemption from any penalties associated with the late filing.



