Notes to Financial Statements

Years Ended December 31, 2024 and 2023

1. Description of plan:

The following description of Savings Plan of ASARCO LLC and Participating Subsidiaries (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Effective July 1, 1980, ASARCO LLC (the Company) established the Plan. The Plan was most recently restated as of January 1, 2015. The Plan is administered by the Company's Administrative Committee appointed by the Board of Directors. The Plan is designed to provide a method for eligible employees to save for retirement.

General:

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides for employee pre-tax, employee Roth and matching employer contributions in accordance with Section 401(k) of the Internal Revenue Code ("IRC"). The Plan covers substantially all salaried employees upon completion of one month of service.

Contributions:

Participants may contribute a percentage of basic earnings, as defined by the Plan Document, subject to limits determined annually by the Internal Revenue Service ("IRS"). Contributions are stated in whole percentages of 1% to 75% of the participant's basic earnings. Participants may elect to increase, decrease or suspend their pre-tax or Roth contributions at any time. The Company matches the first 9% of a participant's contribution at the rate of 100% for participants employed by the Company on April 30, 2011. For participants employed or re-employed by the Company after April 30, 2011, the Company matches the first 6% of participants' contributions at the rate of 100%. Catch-up contributions, on a pre-tax basis up to the statutory maximum, are allowed for those participants 50 years and older.

The Plan automatically enrolls newly eligible employees at 3% of basic earnings and automatically increases the percentage by 1% each subsequent year until 6% of a participant's earnings is reached. The participant can opt out of the automatic enrollment or annual increase at any time.

The Company is not obligated to make a matching contribution during any period in which it has no accumulated retained earnings. The Company's contributions are subject to all legal restrictions which may apply, including Sections 401 and 425 of the IRC, which limit the annual contributions to a participant's account.

1. Description of plan (continued):

Rollover contributions or distributions:

Participants entering the Plan may roll over contributions from a trust, individual retirement account (IRA), or individual retirement annuity qualified under the IRC no later than the sixtieth day following the day on which the individual receives the distribution. Participants leaving the Plan may request rollover distributions to the qualified plan of another employer, an IRA account, or to an insurance company IRA annuity.

Participant accounts:

Each participant's account is credited with the participant's deferral contributions, rollover contributions, allocations of the employer's contributions and actual earnings thereon. Participant accounts are also credited/charged with an allocation of other income and expenses. Allocations are based on participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants hired before July 1, 2014 are 100% vested in both their contributions and Company matching contributions. Participants hired on or after July 1, 2014 are 100% vested in their contributions and become 100% vested in Company matching contributions after completing two years of service. A participant will also become fully vested upon retirement or death.

Notes receivable from participants:

The Plan provides for loans to participants who have participated in the Plan for at least one year, subject to certain limitations. The maximum loan allowed to each participant is limited to the lesser of 50% of the vested interest of the participant's accounts, or \$50,000, reduced by the outstanding balance of any plan loans to such participant.

A participant's loan is repayable within a maximum of five years or immediately upon termination of employment. Interest is currently accrued at the prime rate which was in existence on the first day of the month in which the loan was issued, plus 1%. The loans are secured by the balance in the participant's account and, excluding deemed distributed loans, bear interest at 3.25 to 9.5 percent. Principal and interest is paid ratably through payroll deductions. A participant may pre-pay a loan at any time without penalty.

Deemed distributions represent notes receivable from participants that are currently in default and are considered unlikely to be repaid as the participant is no longer an employee of the Company.

1. Description of plan (continued):

Payment of benefits:

Upon retirement or termination of employment (other than by death) prior to age 65, a participant must consent in writing to receive a distribution of account balances. If participants do not consent in writing, payment of a distribution is made upon the earlier of death or attainment of age 65. Participants who retire may elect to receive payments in annual cash installments over a period of up to 10 years. In the event of the death of a participant, his or her entire interest in the Plan will be paid to their designated beneficiary in either a single lump sum or annual cash installments not to exceed 10 years. Benefits are recorded when paid.

If the vested balance is less than \$1,000, it is paid out to the participant in one lump sum as soon as practicable following termination. If the vested balance is greater than \$1,000 and less than \$5,000, the Administrative Committee may elect to distribute the balance into an IRA established on behalf of the participant. If the vested balance is greater than \$5,000, the participant may leave the account in the Plan or withdraw all or part of the vested account after termination or upon retirement.

Hardship withdrawals:

A participant may withdraw any part of the vested portion of their individual account balance in the event of financial hardship due to an immediate and heavy financial need as defined in the Plan Document.

Forfeitures:

Forfeited balances of terminated participants' nonvested accounts are used to reduce employer contributions.

Plan transfers:

Participants from The 401(k) Savings Plan for Eligible Hourly-Rated Employees of ASARCO LLC regularly transfer into the Plan as they become salaried employees and vice versa. The related participant account balances represent transfers into or from that plan.

Administrative expenses:

Certain expenses of maintaining the Plan such as trust, recordkeeping, consulting, audit and legal fees are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Summary of significant accounting policies (continued):

Use of estimates in preparation of financial statements:

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make a number of estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for uncollectible loans has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document, and are included in the statements of changes in net assets available for benefits as deemed distributions. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when incurred.

Payment of benefits:

Benefits paid to participants are recorded when paid.

3. Federal income tax status:

The IRS has determined and informed the Company in a letter dated November 13, 2015 that the Plan, as restated as of January 1, 2015, meets the requirements of Section 401(k) of the IRC and is exempt from federal income tax. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's legal counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company (Vanguard).

5. Fair value measurements:

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

5. Fair value measurements (continued):

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Related party and party-in-interest transactions:

Exempt party in interest transaction:

Certain Plan investments are managed by Vanguard, the trustee of the Plan. The Plan paid certain expenses to Vanguard during 2024 related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Related party transactions:

Expenses that are paid directly by the Company are excluded from these financial statements. Employees of the Company perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

7. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested as to the amount credited to their account after deduction for estimated liquidation and distribution expenses.

8. Risks and uncertainties:

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent events:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through October 14, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.
