1. Description of the Plan

The following description of Mill Creek Renewables (the Company) 401(k) Profit Sharing Plan and Trust (the Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution plan covering most full-time employees of the Company who have reached age 18 and one month of service. Employees enter the Plan on the date of hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
- B. Contributions - Participants may contribute up to 90% of their eligible compensation for each year in which they are a participant in the Plan up to the maximum allowable contributions under the Internal Revenue Code (IRC). The Plan allows for pre-tax and Roth deferrals. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions subject to limitations imposed by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit plan or defined contributions plans. Employees are auto enrolled into the Plan at a 3% deferral rate, with annual escalation of 1% per year, up to a maximum of 10%, unless the participant elects otherwise. The Company provides safe harbor matching contributions on employee deferrals. The Company's safe harbor matching contributions are 100% of deferrals up to 4%. The Company may make additional discretionary profit sharing and matching contributions at the discretion of the Board of Directors. There are no allocation conditions to be eligible to share in these discretionary contributions. These contributions are to be credited to participants in an amount equal to a uniform percentage of each eligible individual's compensation. There were no discretionary profit sharing or matching contributions made during 2024. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.
- C. Participant Accounts - Each participant account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's safe harbor and discretionary profit sharing and matching contributions are based on years of service, as defined by the Plan. A participant is 100% vested after two years of service. A participant is 100% vested in the Company's discretionary profit sharing and matching contributions after two years of credited service. A participant is 100% vested upon death, termination due to permanent disability, or early retirement, or if the Plan is terminated or partially terminated.

- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 9.75% to 10.50%, which is commensurate with the prime rate as listed in The Wall Street Journal on the first business day of the month in which the loan is requested, plus 2%. The term of loans cannot exceed a period of 5 years. The maximum number of loans outstanding for a participant at any one time is two. Principal and interest are paid ratably through payroll deductions.
- F. Payment of Benefits – Upon termination of employment or termination of service due to death, disability, or retirement, a participant or their beneficiary, in the event of death, is entitled to the distribution of their vested account balance. A participant who has attained age 59 ½ and has been a participant for at least three years may elect to withdraw an amount equal to all or a specified portion of the value of his or her vested account.
- G. Forfeited Accounts – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$10, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$83,184 from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Information Prepared and Certified by Reliance Trust Company

The following information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee).

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for fully benefit-responsive investment contracts, which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values (NAV) of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The self-directed brokerage accounts consist primarily of mutual funds and other investments which are valued based on readily determinable market prices.

5. Related Party Transactions and Party-in-Interest Transactions

The Plan has a number of service providers. Such providers are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer contributions.

8. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

10. Nonexempt Transaction

During 2024, there were certain pay periods where employee withholdings and loan payments totaling \$63,964 were not timely remitted to the Plan by the Company. The Company made a contribution representing lost earnings to the Plan associated with the untimely remittance during 2025.

11. Asset Transfer

In conjunction with a change in recordkeepers and custodians, all plan investments were transferred from ADP to Ascensus. The transfer of the investments was initiated in December 2024 from ADP.

12. Subsequent Events

As discussed in Note 11, a transfer of all plan investments was initiated from ADP in December 2024. The transfer was received by the new custodian, Ascensus, in January 2025.

Effective January 1, 2025, the Plan implemented a new adoption agreement. Under the terms of the adoption agreement, the minimum age to participate in the Plan is 21 years. The minimum service to be eligible for all contribution types is 3 months, with the plan entry date being the first day of each month. The minimum loan amount was increased from \$500 to \$1,000.

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
