Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Artnet Worldwide Corporation, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1 Description of Plan

The following description of the Artnet Worldwide Corporation (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan adopted on January 1, 1999. The Plan covers employees of Artnet Worldwide Corporation (“the Company”) except for nonresident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Employees are eligible to participate in the Plan beginning on the first day of the month after the date of employment if they are at least the age of 21. Employees must be employed on the last day of the Plan year, unless they have reached normal retirement age, died, or become disabled, to receive the Company qualified matching contributions or Company nonelective contributions.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (“IRC”). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Eligible participants are permitted to make Roth deferrals to the Plan.

The Employer may, at its discretion, elect to make a qualified matching contribution or nonelective contribution to the Plan. For the years ended December 31, 2024 and 2023, the Company qualified matching contribution was 50% of employee deferral contribution up to 6% of eligible compensation. The Company did not make a qualified nonelective contribution for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit Individual Retirement Account (“IRA”). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s qualified matching contribution, an allocation of the Company’s nonelective contributions, as applicable, an allocation of Plan earnings or losses, and administrative expenses. Allocations are based on participant compensation, participant earnings, account balances, or specific transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant’s account.

Note 1 Description of Plan (continued)

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term of a loan may not exceed five years, unless used to acquire a principal residence of the participant. Principal and interest is paid ratably on a per pay period basis over the term of the loan. Loans bear interest at a rate of prime plus 1%. A portion of the participant's vested account balance, equal to the loan amount, is used as collateral for the loan.

Benefit Payments

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Benefit payments are made in the form of a lump sum cash distribution or periodic withdrawal. Participants may receive in-service distributions if they attain age 59½. Distributions on account of hardship are also permitted. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Note 2 Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the years.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain Plan administrative expenses are paid by the Company on behalf of the Plan. Fees related to the processing of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment advisor fees are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of the investments.

Note 3 Information Certified by the Plan's Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee of the Plan, Reliance Trust Company.

Note 4 Fair Value Measurement

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- quoted prices for similar assets or liabilities in active markets;
 - inputs other than quoted prices that are observable for the asset or liabilities;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 Fair Value Measurement (continued)

Common Collective Trust Funds: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6 Party-In-Interest Transactions

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 2, fees related to the administration of participant accounts and certain other administrative expenses are paid from Plan assets. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions. Reliance Trust Company is the Trustee and ADP Retirement Services is the recordkeeper, as defined by the Plan, and are therefore parties-in-interest.

Note 6 Party-In-Interest Transactions (continued)

The Plan makes loans to participants and therefore, these transactions qualify as a party-in-interest.

Note 7 Tax Status

The Plan is an adoption of the ADP, LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (Cash or Deferred Arrangement) Plan for which the Internal Revenue Service has determined and informed ADP, LLC by an opinion letter dated October 6, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 Nonexempt Transaction

During the year ended December 31, 2024, the Plan sponsor did not timely remit certain participant contributions and loan repayments for three pay periods totaling \$80,723. During the year ended December 31, 2022, the Plan sponsor did not timely remit certain participant contributions and loan repayments for four pay periods totaling \$109,122. The amounts were considered late as the time to fund the contributions was longer than the Plan's average remittance period. Lost earnings and interest will be calculated and restored to the Plan.

Note 10 Subsequent Events

The Plan has evaluated subsequent events through October 16, 2025, the date on which the financial statements were available to be issued. During July 2025, the Plan changed its recordkeeper and trustee to Fidelity Management Trust Company.
