**To the Officers and Directors of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Caldwell Medical Center, Inc. Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Caldwell Medical Center, Inc. Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Caldwell Medical Center, Inc. Tax Deferred Annuity Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

(1) DESCRIPTION OF PLAN

The following description of the Caldwell Medical Center, Inc. Tax Deferred Annuity Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all of the employees of Caldwell Medical Center, Inc. (the Hospital). Employees may make elective deferrals upon employment. Employees are eligible for employer matching contributions upon completion of 1,000 hours of service and the attainment of age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute a percentage of compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code. Participants may also contribute amounts from other qualified plans, i.e. rollovers, without benefit of the Hospital matching contributions. The employer makes matching contributions of 100 percent up to the first three percent of compensation that a participant contributes to the Plan.

Participant accounts

Each participant's account is credited with the participant's contribution and allocation of the Hospital's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Hospital contributions. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral account plus actual earnings thereon. Vesting in the employer contribution account is based on years of service. A participant is 100 percent vested after six years of credited service.

Investment options

Investment account options available include various mutual funds. Each participant has the option of directing his or her contributions into any of the funds offered by the Trustee and may change the allocation daily.

Payment of benefits

Upon termination, a participant may elect to receive a lump sum or certain annuity options equal to the value of the participant's account. In-service hardship withdrawals are permitted under the Plan document and limited to guidelines set forth by the Internal Revenue Code.

Forfeitures

At December 31, 2024, and 2023, forfeited nonvested accounts totaled \$17,370 and \$9,536, respectively. These accounts have been or will be used to reduce future employer matching contributions. In 2024 and 2023, employer contributions were reduced by \$7,159 and \$9,506, respectively, by forfeited nonvested accounts.

(1) DESCRIPTION OF PLAN (continued)

Compensation recapture account

The Plan carries a compensation recapture account used to cover plan costs. Administrative fees are collected from the Plan's investments and maintained in this account to pay recordkeeping and administrative fees. At December 31, 2024, there were 22,149 of fees paid from the account during the year.

Administrative expenses

Personnel within the plan sponsor perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are paid by the Hospital and not included as Plan expenses.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

FASB ASC 820-10 established a three tier hierarchy of inputs to establish a classification of fair value measurements for disclosure purposes. The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1

Inputs are unadjusted and represent quoted prices in active markets for identical assets or liabilities at the measurement date.

Level 2

Inputs (other than quoted prices included in Level 1) are either directly or indirectly observable for the asset or liability through correlation with market data at the measurement date and for the duration of the instrument's anticipated life.

Level 3

Inputs are unobservable and supported by little or no market activity.

The NAV is based on the value of the underlying investments owned by the fund minus its liabilities, divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified at Level 1.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers into Level 3.

(5) INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Hospital by a letter dated March 31, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(6) RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

CB&T is the trustee of the Plan and, therefore, administrative fees paid to them qualify as party-in-interest transactions. At December 31, 2024, the Plan made direct quarterly payments to outside parties of \$22,149 covered by revenue sharing out of the compensation recapture account. The Plan sponsor pays directly any other fees related to the Plan's operations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(7) RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

(8) EMPLOYER CORRECTION FOR MISSED DEFERRALS

During the plan year ended December 31, 2024, the Plan Sponsor identified certain administrative errors in which elective deferrals and related employer matching contributions were not made for eligible participants. To correct these errors, the Plan Sponsor made qualified nonelective contributions (QNECs) and corresponding corrective matching contributions in accordance with the correction principles of the Self-Correction Program (SCP) of the IRS Employee Plans Compliance Resolution System (EPCRS).

(9) SUBSEQUENT EVENTS

Management noted no additional transaction that would provide evidence about material conditions that did not exist at the balance sheet date but arose subsequently, through the date these financial statements were available to be issued, October 9, 2025.
