## INDEPENDENT AUDITOR'S REPORT

Board of Trustees of  
Radio Free Asia Tax Deferred Annuity Plan

### Opinion

We have audited the accompanying financial statements of Radio Free Asia Tax Deferred Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for plan benefits of Radio Free Asia Tax Deferred Annuity Plan as of December 31, 2024 and 2023, and the changes in its net assets available for plan benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.


### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.



Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

#### NOTE 1. PLAN DESCRIPTION

The following description of the Radio Free Asia Tax Deferred Annuity Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General** - The Plan is a tax deferred annuity plan covering all eligible employees of Radio Free Asia. The Plan was adopted as of July 1, 1996, and amended on January 1, 2009, November 15, 2011 and January 1, 2012, and qualifies under the Internal Revenue Code (IRC) as a Section 403(b) Pension Plan.

**Contributions** - The Plan offers employee elective pre-tax deferrals and employee elective Roth deferrals. Employee contributions up to 4% of annual compensation are credited to the employee's participant account in the Radio Free Asia Defined Contribution Retirement Plan. Deferrals in excess of 4% are credited to this plan. Employees are 100% vested in their contributions.

**Investment Options** - Contributions to the Plan are invested by TIAA-CREF, according to participant instructions. The Plan Administrator provides participants with current copies of the prospectus describing each investment option. All employee contributions and earnings thereon are immediately vested.

**Payment of Benefits** - Participants are entitled to receive a distribution of their vested account balance in the Plan upon termination of their employment, retirement, death or disability, and termination of the Plan without the establishment of a successor plan. A participant may elect to receive a lump sum amount equal to the value of his or her account balance or a series of cash payments in substantially equal installments.

**Plan Termination** - Although it has not expressed any intentions to do so, Radio Free Asia has the right to terminate the Plan subject to the provisions set forth in the Employee Retirement Income Security Act of 1974 (ERISA). In the event of Plan termination, participants become fully vested in their accrued benefits.



## NOTE 1. PLAN DESCRIPTION (CONTINUED)

**Plan Loans to Participants** - Plan loans may be obtained from funds owned by TIAA-CREF, the Trustee, and not directly from a participant's account. Adequate security is required, and a portion of the participant's account is reserved, or held in collateral, to cover 110 percent of the outstanding loan in case of default. The collateral is held in the TIAA Traditional Annuity as part of a Group Supplemental Retirement Annuity (GSRA) contract. The interest rate for Plan loans may be fixed or variable and the initial rate is determined by the terms of the controlling contract. For all Plan loans, interest is paid directly to TIAA-CREF. Participant accounts held as collateral on loans totaled \$242,962 and \$286,520 at December 31, 2024, and 2023, respectively.

**Participant Accounts** - Each participant's account is credited with (a) the employee's contribution and (b) the account earnings. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements are prepared on the accrual basis of accounting and in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC), *Plan Accounting Defined Contribution Pension Plans*.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Fair Value Measurements** - The Plan adopted the provisions of FASB ASC, *Fair Value Measurement*, which defines fair value, establishes a framework for measuring fair value, establishes a fair value hierarchy based on the quality of inputs (assumptions that market participants would use in pricing assets and liabilities, including assumptions about risk) used to measure fair value, and enhances disclosure requirements for fair value measurements. The Plan accounts for a significant portion of its financial instruments at fair value or considers fair value in their measurement.

**Administrative Expenses** - Administrative expenses of the Plan are paid by Plan participants.

**Payment of Benefits** - Benefits are recognized when paid.



### **NOTE 3. INCOME TAX STATUS**

The Plan was established as a qualified plan under Section 403(b) of the IRC. The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 4. INVESTMENTS VALUATION AND INCOME RECOGNITION**

Investments in fully benefit-responsive insurance contracts are stated at contract value. All other investments are stated at readily determinable fair values. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's Investment Policy Committee determines the Plan's valuation policies utilizing information provided by the Custodian. Purchases and sales of securities are reported on a trade date-basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. The net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Certain Plan assets are invested in pooled accounts. Under the pooled investment concept, the investment advisors account for the Plan's share of the total portfolio on a unit basis and are the custodians of the investments (at net asset value). The unallocated insurance contracts are reported at contract value, which approximates fair value.

### **NOTE 5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of annuities managed by TIAA-CREF; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.



## **NOTE 6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for plan benefits.

## **NOTE 7. UNALLOCATED INSURANCE CONTRACTS**

As of December 31, 2024 and 2023, the Plan offered a guaranteed fixed annuity, the TIAA Traditional Annuity. This annuity is offered to participants through a contract with TIAA, an insurance company. Participants who choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity make contributions that purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified rate of interest, generally 3% annually, is guaranteed by TIAA's claims-paying ability.

The TIAA Traditional Annuity also provides an opportunity for participants to receive additional amounts, which the TIAA Board of Trustees may declare on a year-by-year basis. These additional amounts, when declared, remain in effect for the 12-month "declaration year" that begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities; they are not guaranteed for future years. The contracts are backed by the assets of TIAA's General Account, which invests in a wide array of financial instruments.

The TIAA Traditional Annuity is reported at contract value and is segregated into nonbenefit-responsive and fully benefit-responsive categories. As of December 31, 2024 and 2023, the Plan offers only the fully benefit-responsive option.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Unallocated Insurance Contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.



## NOTE 8. FAIR VALUE MEASUREMENTS

In accordance with ASC, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of the hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument. Investments reported in the statements of net assets available for plan benefits are categorized based on the inputs to valuation techniques as follows:

Level 1 - These are investments whose values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

Level 2 - These are investments whose values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

Level 3 - These are investments whose inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies* - The fair value is equal to the reported net asset value of the fund, which is the price at which additional shares can be obtained.

*Pooled Separate Accounts (real estate)* - These accounts invest primarily in domestic stocks and mutual funds, the majority of which have observable Level 1 quoted pricing inputs and are used in determining the net asset values of the pooled separate accounts. Certain of these accounts invest mainly in international stocks, which have observable Level 1 or Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets; and are used in determining the net asset values of the pooled separate accounts. Net asset values of pooled separate accounts are not publicly quoted.
