Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Twelvestone Health Partners, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to the Financial Statements

December 31, 2024 and 2023

(1) Description of plan

The following description of the Twelvestone Health Partners, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan that provides retirement benefits for employees of Twelvestone Health Partners, Inc. (the "Plan Sponsor"). The Plan covers substantially all employees who are age 21 or older and have completed six months of service ("participants"). Employees who are not eligible to participate in the Plan include non-resident aliens and collective bargaining (union) employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Participants may voluntarily make qualified pre-tax retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants may also make after-tax Roth 401(k) contributions and may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants are permitted to contribute up to 100% of compensation, as defined in the plan agreement ("Plan Compensation"), subject to IRC limitations. All newly eligible non-participating employees are automatically enrolled in the Plan at a deferral rate of 2% of Plan Compensation. Employees may opt out of this provision at any time. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan allows for discretionary matching contributions at a rate determined by the Plan Sponsor. During 2024 and 2023, the Plan Sponsor made discretionary matching contributions equal to 30% of each participant's salary deferrals up to 4% of Plan Compensation.

The Plan also allows for discretionary profit sharing contributions in an amount determined annually by the Plan Sponsor. A participant must be employed at the end of the plan year or, if terminated, must have completed 500 service hours during the plan year in order to be eligible to receive discretionary profit sharing contributions. Participants who became terminated due to death or disability or were terminated after the normal retirement age of 65 are exempt from such requirements. No annual discretionary profit sharing contribution was made by the Plan Sponsor during 2024 or 2023.

Plan Sponsor contributions may not exceed the maximum amount allowable for federal income tax purposes.

Notes to the Financial Statements

December 31, 2024 and 2023

(c) Participant accounts

Each participant's account is credited or charged with the participant's contributions, allocations of Plan Sponsor contributions, investment earnings or losses, and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants are immediately vested in their elective salary deferrals plus actual earnings (losses) thereon. Vesting in Plan Sponsor contributions plus actual gains (losses) therein is based on years of service. Participants vest 20% after one year of service and an additional 20% each year until becoming fully vested after five years of service. Participants automatically become 100% vested in Plan Sponsor contributions upon attainment of the normal retirement age of 65.

(e) Payment of benefits

On termination of service due to death, permanent disability, retirement, or other reasons, a participant may elect to receive a lump-sum payment, subject to consent requirements. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution. Additionally, in-service withdrawals are permitted for participants who have not separated from service, provided they have attained age 59½.

(f) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures may be used to reduce the Plan Sponsor's contributions to the Plan or to pay plan expenses. Forfeited nonvested accounts totaled \$15,326 and \$18,673 as of December 31, 2024 and 2023, respectively.

(g) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance.

Notes to the Financial Statements

December 31, 2024 and 2023

(h) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from the accompanying financial statements. Fees incurred by the Plan for investment management services are netted within the net appreciation in fair value of the investments.

(i) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies were determined using information provided by American United Life Insurance Company ("OneAmerica"). See Notes 4 and 5 for discussion of investment valuation measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

Plan management has evaluated events and transactions that occurred between December 31, 2024 and October 15, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments presented and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair value and contract value of investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by OneAmerica.

(4) Investments measured at net asset value as a practical expedient

The Plan's investments in pooled separate accounts are measured at net asset value ("NAV") as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy. There are no participant redemption restrictions for these investments.

The Plan holds various pooled separate accounts that are not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date.

Notes to the Financial Statements

December 31, 2024 and 2023

(5) Investment contract with insurance company

The Plan maintains a fully benefit-responsive investment contract with OneAmerica in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the accompanying financial statements at contract value as reported to the Plan by OneAmerica.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value, which approximates fair value, of the investment contract of the investment contract was \$46,527 and \$41,554 as of December 31, 2024 and 2023, respectively. The earnings of the investment contract are based on the interest rate applied to each participant's outstanding balance. The interest rates are reviewed and are reset by the insurance company annually. The establishment of the guaranteed interest rate requires estimation of the future earnings rates, the rate at which existing investments mature, and future cash flow.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(6) Excess contributions

Contributions received from participants for 2024 and 2023 are net of contributions of \$5,999 and \$18,200, respectively, payable to certain active participants to return to them excess contributions, as required to satisfy the relevant nondiscrimination provisions of the Plan.

(7) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The pre-approved plan has been amended since receiving the opinion letter, and Plan itself has not received an opinion letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore qualified and exempt from taxation.

Notes to the Financial Statements

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Related party and party-in-interest transactions

Plan investments are managed by OneAmerica; therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid administrative expenses to various service providers which also qualify as party-in-interest transactions.

(9) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

(10) Subsequent event (unaudited)

Effective July 1, 2025, the Plan Sponsor changed the custodian and third-party administrator of the Plan.
