Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of D-J Engineering Inc. 401(K) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1: Description of the Plan

The following description of the D-J Engineering, Inc. 401(k) Retirement Plan, (the Plan), provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering the employees of D-J Engineering, Inc. (the Company). An employee becomes eligible to enroll in the Plan on the first day of employment. The Plan has an automatic contribution arrangement where employees are automatically enrolled at 3% upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and later amendments.

Plan investments were in the custody of Principal Trust Company (the Custodian). These assets consist primarily of shares in various mutual funds and pooled separate account funds.

Participant Contributions - Self Directed

Participating employees may elect to enter into a contribution reduction agreement to reduce compensation up to 75% of compensation not to exceed IRS limits, which will be contributed to the Plan in their name. Participants direct their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts, mutual funds, and a common collective trust fund as investment options for participants. The Plan also offers target date fund choices which are pre-determined allocations of the available funds.

The Plan may accept a proper rollover from another qualified plan.

Employer Contributions

The Company may make a discretionary match based on the participants compensation and deferral election. For 2024 and 2023, the Company has elected to match 25% up to 6% of a participants deferral.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings, and charged with an allocation of administrative expenses. All costs, fees, and expenses associated with the participant's account maybe charged or deducted from the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Employer matching contributions are subject to a modified vesting schedule where participants with less than 2 years of service are 0% vested, 2 years are 25% vested, 3 years are 50% vested, 4 years are 75% vested, and 5 or more years of service are 100% vested.

Participant Loans

Under the terms of the Plan, loans are permitted and are subject to approval by the Plan Administrator. The minimum loan is \$1,000 and the maximum loan is the lesser of 50% of the participant's vested account balance or \$50,000, reduced by the highest outstanding receivable balance in the participant's account during the prior 12-month period. These loans are secured by the participants' account balances and bear interest at a rate determined by the Plan Administrator. Loan repayments are made ratably through payroll deductions. For the years ending December 31, 2024 and 2023, interest rates on outstanding loans were 4.25% to 9.50%, respectively.

At December 31, 2024 and 2023, no participant loans were in default.

Benefits

Distributions are made upon death, disability, retirement or termination of employment. The participant may receive a lump-sum amount equal to the value of their vested interest or as an annuity payment. In-service distributions are permitted from the participant's account upon attaining age 59 1/2. Benefits are recorded when paid.

Forfeitures

Forfeitures represent the non-vested portion of participant account balances upon termination. Forfeitures can be used to reduce employer contributions or pay Plan expenses. For the Plan years ending December 31, 2024 and 2023, forfeitures totaled \$27,459 and \$21,089, respectively. For the Plan years ending December 31, 2024 and 2023, forfeitures were used to reduce employer contributions for 2024 for \$21,553 and in 2023 for \$18,337. Additionally, forfeitures were used to pay Plan expenses of \$5,895 in 2024 and \$2,779 in 2023. The balances of the forfeitures accounts were \$224 and \$0 for the years ending December 31, 2024 and 2023, respectively.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of the participants accounts or distributions are charged directly to the participant's account. Other expenses such as Principal administrative fees are included in administrative expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Contributions from the Company are accrued in the period in which they become an obligation of the employer by declaration of the President. Contributions from employees are accrued when withholding is made from employee's payroll.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are presented at fair value, as determined and certified by the Custodian as of the Plan year-end. Shares of mutual funds and pooled separate accounts are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Net appreciation (depreciation) includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, the Plan had no pending distributions.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

See Note 3 for further documentation on fair value measurements.

Note 3: Fair Value Measurements (Continued)

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The valuation methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds and Pooled Separate Account Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds

Valued at the NAV of units of the bank collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4: Related Party and Party in Interest Transactions

The Plan Sponsor absorbs some administrative expenses of the Plan, cost of audit fees and the cost of fiduciary bonds. As the Plan does not reimburse the Company for the cost of such services, they are not included in these financial statements.

Certain Plan investments are managed by the Custodian for which they are paid fees. Investment related expenses are included in the net appreciation of fair value of investments. These transactions qualify as exempt party-in-interest transactions.

The Company provides administrative services on behalf of the Plan. Additional party-in-interest transactions include fees paid to the third party administrators, EGPS and Show Me Pension, audit fees paid to Varney & Associates, CPAs, LLC, and investment fees paid to Edward Jones, Inc and UBS Financial. These transactions qualify as exempt party-in-interest transactions.

Note 5: Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time subject to the provisions of ERISA. In the event of termination, each participant will have a non-forfeitable interest in his/her entire individual account.

Note 6: Tax Status

The Company adopted a non-standardized prototype Plan document. The Internal Revenue Service issued an opinion letter, dated June 30, 2020, on the prototype Plan document, indicating the basic Plan document is acceptable under Code Section 401 of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8: Information Prepared and Certified by Custodian (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodian.

Note 9: Reconciliation of Financial Statements to Form 5500

Schedule H of Form 5500 reconciles to the financial statement amounts.

Note 10: Subsequent Events

Management has evaluated subsequent events through October 16, 2025, the date on which the financial statements were available to be issued.
