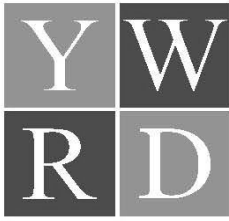

## INDEPENDENT AUDITOR'S REPORT

### Opinion

We have audited the accompanying financial statements of TLH Enterprises, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of March 31, 2024, the statement of net assets in liquidation available for benefits as of March 18, 2025, the statement of changes in net assets in liquidation available for benefits for the period from April 1, 2024 to March 18, 2025, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of March 31, 2024, and the net assets in liquidation available for benefits as of March 18, 2025, and the changes in net assets in liquidation available for benefits for the period from April 1, 2024 to March 18, 2025, in accordance with accounting principles generally accepted in the United States of America, including the application of the liquidation basis of accounting as described in Note C to the financial statements for the period ended March 18, 2025.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TLH Enterprises, Inc. As discussed in Note C to the financial statements, the Plan's governing body approved a plan of termination on January 21, 2025, and all assets were distributed as of March 18, 2025. Accordingly, the statement of net assets in liquidation available for benefits as of March 18, 2025, and the statement of changes in net assets in liquidation available for benefits for the period from April 1, 2024 to March 18, 2025, have been prepared using the liquidation basis of accounting, which is a basis of accounting other than the going concern basis. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, including the application of the liquidation basis of accounting for the statement of net assets in liquidation as of March 18, 2025, and the statement of changes in net assets in liquidation for the period from April 1, 2024 to March 18, 2025, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of the TLH Enterprises, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

The Plan was established April 1, 1995, with an effective date of April 1, 1995 for the benefit of all employees of TLH Enterprises, Inc. (the "Company"). The Plan is a non-contributory, Employee Stock Ownership Plan (ESOP), providing benefits to employees who meet the eligibility requirements indicated below.

The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan has filed for exemption from Federal Income Tax under the appropriate sections of the IRC. Under such an exemption, Company contributions to the Plan, as well as investment earnings are not taxable to the participants until distributed.

*Eligibility*

Each eligible Employee becomes a Participant in the Plan on the nearest April 1 or October 1 following completion of 1,000 hours within a twelve month period of employment. All Employees of TLH Enterprises, Inc. who met the eligibility requirements as of April 1, 1995 (the effective date of the Plan) became Participants of the Plan as of the effective date of the Plan. Participants are credited with one year of service for each twelve month period in which they complete at least 1,000 hours of service to the Company beginning April 1, 1995. If the Employee was an active participant in the Company's Profit Sharing 401(k) Plan on April 1, 1995, they were automatically a participant in this plan as of the effective date.

*Company Contributions*

Contributions to this Plan by the Company are discretionary and will be determined each year by the Board of Directors.

*Payment of Benefits*

Employees will be entitled to receive the value of their account in this ESOP at normal retirement age 65. If an active Employee dies, a death benefit equal to the full value of the employee's account balance will be paid to the designated beneficiary. Active Employees who become totally disabled prior to their normal retirement age also become fully vested in their account values.

**NOTE A - DESCRIPTION OF PLAN (continued)**

*Allocation of Company Contributions and Forfeitures*

Company contributions will be allocated as of each anniversary date among the accounts of participants who are employed on the last day of the plan year, or employees whose employment terminated during the year because of retirement or death, in the proportion that each such participant's covered compensation bears to the total covered compensation of all such participants for that year. Forfeitures shall be allocated in the same manner as Company contributions are allocated. Forfeitures reallocated at March 18, 2025 and March 31, 2024 totaled \$0 and \$0, respectively.

*Vesting*

Vesting in the Company's discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. The Plan provides for 20% vesting of benefits after two years of service, and increases by 20% for each year of service. A participant is 100% vested after six years of credited service.

*Put Option*

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

*Diversification*

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. Participants eligible to diversify make their election after year-end based on the number of shares of the employer's stock held in their account at year-end.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Date of Management's Review of Subsequent Events*

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The shares of Company common stock are valued at fair value. See Note D for discussion of fair value measurements.

*Operating Expenses*

All expenses of maintaining the Plan are paid by the Company.

**NOTE C - PLAN TERMINATION AND ADOPTION OF LIQUIDATION BASIS OF ACCOUNTING**

On January 21, 2025, the Board of Directors of TLH Enterprises, Inc. approved the termination of the Plan in accordance with the provisions of the Plan document and applicable law. As a result of this decision, the Plan adopted the liquidation basis of accounting effective December 31, 2024, as it was determined that the Plan would no longer continue as a going concern.

Under the liquidation basis of accounting, assets are stated at their estimated net realizable values and liabilities are stated at their estimated settlement amounts. The adoption of the liquidation basis of accounting was deemed appropriate as the Plan's termination was approved and the process of liquidating the Plan's assets and settling its obligations commenced.

All Plan assets were distributed to participants and beneficiaries as soon as administratively feasible following the termination. The final distribution of Plan assets occurred on March 18, 2025. A final Form 5500 will be filed for the short plan year ending on the date of final distribution, in accordance with Department of Labor and Internal Revenue Service requirements.

**NOTE D - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

*Level 3 Fair Value Measurements*

The fair value of the TLH Enterprises, Inc. common shares is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation methods consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, and market comparable. The following table provides further details of the Level 3 fair value measurements.

**NOTE E - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated March 26, 2015, that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan invests in Company common stock. This is a related party and party-in-interest transaction. As described in Notes B and F, the Company pays the expenses of the Plan. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.
