To the Administrator and Management of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Tenafly Pediatrics, P.A. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). ### 1. DESCRIPTION OF THE PLAN

The following brief description of the Tenafly Pediatrics, P.A. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a participant-directed defined contribution plan covering all eligible employees of Tenafly Pediatrics, P.A. (the “Company”), who have attained age eighteen and worked at least 1,000 hours during a 12 consecutive month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan administrator is responsible for oversight of the Plan, including the appropriations of the Plan’s investment offerings and monitoring investment performance. Reliance Trust Company (the “Trustee”) is the Plan’s trustee.

**Contributions** – Each year, participants may contribute up to the maximum percentage of eligible compensation allowable under the Internal Revenue Code (“IRC”). Participants in the Plan may elect to make contributions, through payroll deductions, up to 90% of their compensation. In accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 for 2024. Eligible participants may make an additional employee contribution known as a “catch-up” contribution in accordance with the Economic Growth and Tax Reconciliation Relief Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024.

The Company contributes to the Plan, on behalf of each participant, an amount equal to 3% of a participant’s total compensation (“safe harbor contributions”). The Company may also make Nonelective Employer Contributions (“NEC’s”) at its sole discretion, within the limits of the IRC. For the year ended December 31, 2024, the Company’s safe harbor contributions were \$452,031.

**Rollovers** – Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions.

**Participant Accounts** – A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution, the Company’s safe harbor contributions, NEC’s, and an allocation of the Plan’s earnings or losses. Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of expenses are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment Options** – Upon enrollment in the Plan, a participant may direct contributions to a variety of investment options. Participants may change their investment options every business day.

**Notes Receivable from Participants** – Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. No participant may have more than one loan outstanding at any one time and refinancing is not allowed. The loans are collateralized by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates. Loans are repaid via payroll withholding in equal installments, per pay period, representing a combination of interest and principal sufficient to amortize the loans over their terms. Generally, loans must be repaid within a five-year period unless used for the purchase of the participant’s principal residence (for which the repayment period may be extended). Notes receivable outstanding at December 31, 2024, have interest rates ranging from 4.25% to 9.50%, and mature on various dates through August 2029.

**Vesting** – Participants are fully vested in their personal contributions, employer safe harbor contributions, and related account earnings or losses immediately upon enrollment in the Plan.

**Benefit Payments** – On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount equal to the participant's vested interest in his or her account or a partial withdrawal. Participants are eligible for in-service distributions upon attaining the age of 59 ½ years and under terms of the Plan. Hardship withdrawals are permitted by the Plan.

Upon retirement, the full value of the participant's account balance is payable at the normal retirement date. The normal retirement age under this Plan is the attainment of age 65. The normal retirement date is the date the participant attains the normal retirement age.

**Forfeitures** – Forfeitures of nonvested discretionary employer contributions may be used to reduce any employer contributions. At December 31, 2024 and 2023, unallocated forfeitures totaled \$2,480 and \$14,389 respectively. For the year ended December 31, 2024, forfeitures of \$10,941 were utilized to reduce employer contributions.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates** – The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of asset and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Valuation of Investments and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for description of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan agreement.

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Expenses attributable to the administration or operation of the Plan are allocated pro rata on the basis of account balances of all participants. Investment related expenses are included in the net appreciation of fair value of investments.

**Payment of Benefits** – Benefit payments to participants are recorded when paid.

### 3. INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, except for comparing such information certified by the Trustee with information included in the Plan’s financial statements and supplemental schedule of Form 5500, Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds and Money Market Fund:** Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

**Common/collective trust:** The Plan invests in the T Rowe Price Stable Value Fund ("Stable Value") a stable value common collective trust fund. The Plan's interest in Stable Value is valued at the NAV practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported NAV. The underlying assets owned by Stable Value consist primarily of readily marketable fixed income securities. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year. Participant transactions (purchases and sales) may occur daily.

### 5. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks that may be impacted by external financial, business and other factors including economic downturns, natural disasters, geopolitical conflicts or pandemic illness. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. Additionally, the investments the Plan invests in may change their distribution or dividend policies, which could have an effect on the value of the investment securities.

The Plan's exposure to a concentration of credit risk is limited by the opportunity to diversify investments across multiple participant-directed fund elections including active and passively managed funds covering multiple asset classes. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments. The Plan's investment in Vanguard 500 Index Admiral totaling \$8,313,929 and \$6,618,890 as of December 31, 2024 and 2023, respectively, represented a concentration equal to or greater than 10% of the Plan's net assets available for benefits.

### 6. FEDERAL INCOME TAX STATUS

The Plan's administrator adopted a prototype non-standardized 401(k) plan with cash or deferral arrangement, which received a favorable opinion letter from the IRS on October 6, 2020, which states that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. FEDERAL INCOME TAX STATUS (continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

### 7. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

ADP LLC (“ADP”) is the record-keeper for the Plan. The Plan incurred administrative expenses with ADP amounting to \$11,916 for the year ended December 31, 2024. Loans to participants are secured by the balances in the respective participant accounts. The Plan incurred \$19,166 of investment advisor expenses. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

### 8. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the rights to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

### 9. PROHIBITED TRANSACTIONS

During 2023, the Company was delinquent in remitting to the trustee certain employee contributions totaling \$29,192 within the time period set forth in the Department of Labor’s (“DOL”) plan asset regulation at 2510.03-102. The Plan sponsor has computed the lost earnings on these deposits and subsequently remitted the deposits. The Plan sponsor will complete the appropriate forms to report such matter as required and takes full responsibility for any penalties and other potential issues associated with such untimely remittances in 2023.

### 10. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan administrator did not adopt any of the optional provisions for 2024 and accordingly, there was no material impact to the Plan's 2024 financial statements.

### 11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 1, 2025, the date which the financial statements were available to be issued. Based upon this evaluation, the Plan has determined that no subsequent events have occurred which would require disclosure in or adjustment to the financial statements.
