NOTE A – DESCRIPTION OF PLAN

The following description of Progressive Lighting, Inc. (the Company) 401(k) Salary Reduction Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering substantially all employees of the Company except those who are union, nonresident aliens, or leased as defined by the Plan. Employees are eligible to participate in the Plan if they are age twenty-one or older. The Plan provides eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Each year, participants may contribute up to the maximum amount allowable not to exceed the limits provided for by the Internal Revenue Service (IRS) Code. Participants may also contribute amounts representing distributions from other eligible retirement plans. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 for the year ended December 31, 2024. The Company may make matching contributions equal to a discretionary percentage determined by the Company. Additional profit sharing contributions are discretionary and determined by the Company. The Company did not make any profit sharing contributions for the year ended December 31, 2024. Participants may direct the investment of their employee and employer contributions into various investment options offered by the Plan. Rollover contributions are accepted by the Plan.

3. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may not have more than two loans outstanding at any one time. Interest and principal repayments must be made over a period not exceeding five years. The loans are secured by the balance in the participant's account and bear interest as determined at the date of the loan origination. Principal and interest are repaid through biweekly payroll deductions. The interest rate for notes receivable from participants is set at 1 percent above the prime rate, as defined.

5. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after two years of credited service.

6. Payment of Benefits

A participant may withdraw all or any portion of their account balance, as defined by the Plan, under an event of termination, attaining the normal retirement age, attaining the age of fifty-nine and one-half, disability, death, or severe financial hardship. Distributions are to be paid in lump sum or installment payments. The dollar threshold of \$5,000 is used in determining if a lump sum distribution will be made to participants who have vested account balances.

7. Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,422 and \$10,113, respectively. Forfeitures may be used to reduce any employer contributions or to pay administrative expenses of the Plan. Any remaining forfeitures will be allocated to all eligible participants in the same manner as employer contributions. For the year ended December 31, 2024, employer contributions of \$7,931 and administrative fees of \$2,187 were paid from forfeited nonvested accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

2. Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

4. Administration of Plan Assets

Pension Financial Services, Inc. is designated as the third-party administrator for the Plan.

5. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

5. **Investment Valuation and Income Recognition, continued**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

6. **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions. Excess contributions payable at December 31, 2024 and 2023 was \$181 and \$1,643, respectively. Excess contributions for the year ended December 31, 2024 was \$265.

7. **Payment of Benefits**

Benefits are recorded when paid.

8. **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The expenses charged to the Plan may be charged pro rata to each participant in relation to the size of each participant's account balance or may be charged equally to each participant. In addition, some types of expenses may be charged only to some participants based upon their use of a Plan feature or receipt of a Plan distribution or loan.

9. **Subsequent Events**

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/Collective Trusts – Valued by the fund's trustee based on the fair value of underlying securities within the fund, which represent net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds – Valued at net asset value (NAV) of shares held by the Plan at year-end.

NOTE D – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds and collective trust funds managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee and recordkeeper for the Plan. Therefore, these transactions qualify as party-in-interest transactions.

Certain other administrative expenses of the Plan are absorbed by the Plan's sponsor; therefore, these administrative expenses are not fully reflected in these financial statements.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G – TAX STATUS

The Plan has adopted the prototype non-standardized profit sharing plan with CODA from Principal Life Insurance Company. The IRS has determined and informed Principal Life Insurance Company by letter dated March 31, 2014 that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended from the adopted prototype plan since Principal received the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The following is a summary of the Plan's financial information, as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that is included in the financial statements based on information certified by Principal Life Insurance Company as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).
