1. Plan Description

The following description of the Cohere Beauty 401(k) Plan (formerly named the Marianna Industries, Inc. 401(k) Profit Sharing Plan and Trust) (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Marianna Industries, Inc. (the Company). Effective in April and May 2023, Cosmolara, Inc. was merged into the Plan and Contract Filing, Inc. was added as a participating employer in the Plan (see Note 8).

Effective January 1, 2024, the Plan name was changed from Marianna Industries, Inc. 401(k) Profit Sharing Plan and Trust to the Cohere Beauty 401(k) Plan. Also, the Company amended the Plan to be a safe harbor plan.

Effective January 1, 2024, employees are eligible to make salary deferral contributions and receive Company safe harbor matching contributions and discretionary profit-sharing contributions after attaining age 18 and completing thirty days of service. Prior to January 1, 2024, employees were eligible after attaining age 18 and completing three months of service and were eligible to receive Company discretionary matching contributions. Eligible employees may become participants on the first day of the month following the date on which entry requirements were fulfilled. Participants are eligible to receive Company discretionary profit sharing contributions after attaining age 18 and completing one year of service with at least 1,000 hours and if they were employed on the last day of the Plan year.

Contributions

Participants may contribute up to 90% of their pre-tax annual compensation up to the maximum dollar limits allowable by law. The Plan also allows participants to designate a portion or all of their elective deferral contributions as Roth after-tax contributions. Participants may also contribute amounts representing distributions from other qualified plans. A participant can elect not to contribute or may increase or decrease his or her deferral rate to any rate allowed under Plan provisions on a monthly basis. Effective January 1, 2024, the Company elected to be a safe harbor plan and provide a Company safe harbor matching contribution. Company safe harbor matching contributions are made in amounts equal to 100% of the participant's elective deferral that does not exceed 3% of the participant's eligible compensation plus 50% of the amount of the participant's elective deferral that exceeds 3%, but does not exceed 5%. The Plan may also provide for discretionary profit-sharing contributions based on a participant's eligible compensation. Prior to January 1, 2024, the Company could provide discretionary matching contributions. The Company's discretionary matching contributions were calculated on the participant's elected deferral up to a certain matching percentage as determined by the Company.

All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of a) the Company's safe harbor matching contributions (discretionary matching contributions prior to January 1, 2024) and discretionary profit sharing contributions and b) Plan earnings or losses. Company safe harbor matching contributions (and Company discretionary matching contributions prior to January 1, 2024) are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments directed by each participant. Investments are maintained in individual member accounts managed by Principal Trust Company (Principal).

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary profit sharing contributions is based on years of continuous service. A participant is 33% vested after one year of credited service and vesting increases 33% per year until a participant is 100% vested after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest payments must be made through payroll deductions for active participants. Participants pay a note origination fee which is charged to the participant's account.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may receive lump sum, partial, or installment payments equal to the value of the vested funds allocated to the participant's account. In the event the participant does not make an election, distribution payments between \$1,000 and \$5,000 will be directly rolled over to an individual retirement account designated by the plan administrator. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants may also receive in-service and hardship distributions, as permitted in the Plan document. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their discretionary contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to pay Plan expenses or to reduce discretionary contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,601 and \$18,352, respectively. During the years ended December 31, 2024 and 2023, \$51,771 and \$2,656 of forfeitures were used to reduce administrative expenses and reduce Company contributions, respectively.

Other

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related solely to a specific participant may be charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are Company adopting events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 10, 2025, noting no items requiring disclosure.

3. Information Certified by Principal

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their Net Asset Value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued at the NAV based on the market value of the underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to serve as an estimate of the fair value as a practical expedient as long as certain requirements are met. It is the Plan's assessment that this trust meets those requirements. The participants have the ability to redeem the trust at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Distribution to participants of the account balances would be made as soon as practicable after the termination date.
