Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kingspan Insulation LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kingspan Insulation LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE A – DESCRIPTION OF THE PLAN

The following description of the Kingspan Insulation LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan established and made effective October 1, 2014 covering substantially all employees of Kingspan Insulation LLC (the Sponsor). The Plan and the Trust of which it is a part of are intended to satisfy all of the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Sponsor. The Plan adopted the provisions of the CARES Act, the Secure Act, and the SECURE 2.0 Act and the Plan document will be formally amended by December 31, 2029 in accordance with legislation.

2. Eligibility

The Plan covers all eligible employees of the Sponsor, with the exception of employees covered by a collective bargaining agreement, leased employees or nonresident aliens. Each employee is eligible to make contributions to the Plan on the first day of the month coinciding with or next following the attainment of their eighteenth birthday and ninety days of service.

3. Contributions

Each year, participants may contribute up to 99% of pretax annual compensation, as defined in the Plan agreement, limited by the provisions of the Internal Revenue Code (IRC). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 % of eligible compensation with automatic annual increases of 1% up to a maximum of 10% of compensation and their contributions are invested in a designated target date fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Roth contributions are permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

The Plan provides for a safe harbor matching contribution at 100% up to the first 6% of base compensation that a participant contributes to the Plan. The Sponsor contribution is invested directly into the investment options selected by the participant. The Sponsor may make discretionary profit sharing contributions to the Plan to the extent allowable by the IRC. The Sponsor made a discretionary contribution of \$407,703 the year ended December 31, 2024.

NOTE A – DESCRIPTION OF THE PLAN – Continued

4. Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Sponsor's contribution, Plan earnings and losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Vesting

Participants are vested immediately in their contributions and employer contributions plus actual earnings thereon upon entering the Plan.

6. Payment of Benefits

When an employee is terminated due to lay-off, death, disability or retirement, a participant or his or her beneficiary will receive a lump-sum amount equal to the participant's vested interest in his or her account if the participant's vested interest is less than \$5,000. If the participant's vested interest is greater than \$5,000, the participant may elect to receive a distribution of the vested interest in either a single lump-sum or installments over a period of not more than the participant's assumed life expectancy. After attaining the age of 59 1/2, participants may be eligible to make a withdrawal of all or any part of their vested account. Participants are eligible to receive hardship withdrawals when certain conditions are met.

7. Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates of 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

8. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$75 and \$61, respectively. These accounts will be used to pay administrative expenses of the Plan and reduce future matching contributions. In 2024, employer contributions were reduced by \$6,264 from the use of forfeited nonvested accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Sponsor determines the Plan's valuation policies utilizing information provided by investment advisors and trustees. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

5. Contributions

Contributions from plan participants and the matching contributions from the employer are recorded in the year which the employee contributions are withheld from compensation.

6. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable for the years ending December 31, 2024 and 2023.

7. Payment of Benefits

Benefits are recorded when paid.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

8. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Certain fees related to the administration of participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

9. Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE D – FAIR VALUE MEASUREMENTS – Continued

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – PLAN TO PLAN TRANSFERS

During the year ended December 31, 2024, the account balances of two participants totaling \$420,875 were transferred from the Plan to Kingspan Holdings Panels US, Inc. 401(k) Plan and Tate Access Floors, Inc. Retirement Savings Plan, both of which are defined contribution plans sponsored by an affiliate within Kingspan controlled group. These transfers were completed in accordance with the terms of the respective plan documents and applicable regulatory requirements.

Additionally, the account balances of two participants totaling \$294,600 were transferred to the Plan from Kingspan Holdings Panels US, Inc. 401(k) Plan and Kingspan Light and Air Profit Sharing Plan, both of which are sponsored by an affiliated entity within Kingspan's controlled group. These incoming transfers were also conducted in accordance with the respective Plan documents and governing regulations.

NOTE E – PLAN TO PLAN TRANSFERS – Continued

These transfers had no effect on the net assets available for benefits of the controlled group as a whole and are not considered contributions or distributions for reporting purposes.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ADP, Inc. is the record-keeper as defined by the Plan, and, therefore, transactions with the Plan and ADP, Inc. qualify as party-in-interest transactions. The total paid by the Plan to ADP, Inc. for the year ended December 31, 2024 totaled \$47,923. The Plan also provided direct compensation to an investment advisor; transactions between the Plan and investment advisor also qualify as party-in-interest transactions. The amount paid by the Plan to the advisor for the year ended December 31, 2024 totaled \$35,000.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of employer contributions.

NOTE H – TAX STATUS

The Internal Revenue Service issued a standard prototype profit sharing opinion letter to ADP, Inc. dated October 6, 2020, stating that its prototype plan document was designed in accordance with applicable Internal Revenue Code requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since ADP, Inc. received a determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J – DELINQUENT CONTRIBUTIONS

During 2024, the Sponsor failed to remit in a timely manner certain employee deferrals and loan repayments to the Plan aggregating \$79,264. The Sponsor will compute the lost earnings on these deposits and will subsequently restore the lost earnings to the Plan in 2025.
