### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Central Bank 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Central Bank 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion on the Financial Statements***

**NOTE 1 DESCRIPTION OF THE PLAN**

The Central Bank 401(k) (the Plan) was established by Commercial Financial Corp. (the Company or Plan Sponsor) effective January 1, 1991. The Plan covers employees of the Company's subsidiary bank, Central Bank (the Bank). The Plan is a defined contribution plan with a plan year of January 1 to December 31.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**Participation**

All employees, with certain limited exceptions, are eligible immediately upon employment to participate in the Plan. Employees are eligible for the Company match the first day of the month following or coincident upon the completion of one year of service. The employee must complete 1,000 hours of service in that year of service and be employed on the final calendar day of the service year. The Plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute up to 90% of their annual compensation, as defined by the Plan, subject to the federal statutory limit of \$23,000 for 2024 and \$22,500 for 2023, respectively. The Plan allows Roth 401(k) after-tax contributions. Upon a qualified distribution, Roth after-tax account earnings are tax free. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as indexed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Employees with a date of hire after 2/1/2017, who are eligible to participate in the Plan, shall be automatically enrolled in the Plan with elective deferrals withheld in the amount of 3% of compensation or may exercise their right to opt out. Effective 7/1/2018, the deferrals increase annually by 1% up to a max of 10%. The Company's contribution could include matching and profit-sharing components. The Company's discretionary matching contribution is equal to the lesser of 2.5% of the employee's deferral wages or 50% of the participant's contribution. Profit sharing contributions are discretionary and determined by the board of directors of the Bank on an annual basis. There were no Company profit sharing contributions for the years ended December 31, 2024, and 2023. Participants direct all contributions into investments of their choice based upon options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting and Forfeitures**

Participants are vested immediately in their contributions, including rollover amounts, plus actual earnings thereon. Company contributions vest 20% per year after the first year and are fully vested after six years of service. Depending on the nature of the original contribution, forfeitures are allocated to pay plan expenses, pay profit sharing discretionary contributions or reduce matching contributions in the Plan year following the year in which the forfeiture occurs. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death or permanent disability. There were no forfeitures at December 31, 2024, and 2023. Forfeitures of \$29,541 and \$10,011 were used to reduce employer contributions in 2024 and 2023, respectively. Forfeitures were not used to pay plan expenses for the years ended December 31, 2024, and 2023.

**Payment of Benefits**

Participants or their beneficiaries become eligible for payment when the participant attains retirement (age 65), becomes disabled, dies, or terminates employment. The Plan will make a maximum mandatory distribution immediately following termination of employment of \$1,000. Based upon the election of the participants, vested account balances in excess of \$1,000 are distributed in a lump-sum or by rollover to a qualifying plan. Effective April 15, 2020, the Plan was amended to include installment payments and partial withdrawals as forms of distributions. It was also amended to include a distribution rollover into an IRA for participant balances between \$1,000 and \$5,000.

Participants may apply for an unlimited number of in-service hardship distributions in a Plan year. In addition, effective with the Plan restatement, at 59½ years of age, in-service withdrawals are allowed. The dollar limit for in-service distributions may not exceed the vested balance in the participant's account or, in the case of hardship withdrawals, those limits set by applicable law to meet the participant's "immediate and heavy financial need."

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions Receivable**

Contributions receivable represent the Company match, which was not yet remitted to the Plan prior to year-end. These receivables do not bear interest and were fully collected subsequent to year-end. Accordingly, no allowance for doubtful accounts has been established at December 31, 2024, and 2023.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

**Benefit Payments**

Benefits are recorded when paid.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Fidelity Management Trust Company, the trustee, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2024, and 2023, and net appreciation in fair value of the investments for the years ended December 31, 2024, and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024, and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of a bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participants' accounts will be 100% vested.

**NOTE 6 INCOME TAX STATUS**

The Plan is placing reliance on opinion letters received from the Internal Revenue Service (IRS) on the prototype plan, indicating the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan has not applied for its own determination letter. The plan administrator believes that the Plan is designed, and currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 TRANSACTIONS WITH PARTIES-IN-INTEREST**

Administrative fees were paid out of the general assets of the Company for maintenance of investment, contribution and distribution records and for the processing of related transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Certain Plan investments are managed by Fidelity Investments, the trustee, for the years ended December 31, 2024, and 2023. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee amounted to \$75,542 and \$66,031 for the years ended December 31, 2024, and 2023, respectively.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

No subsequent events were identified through August 27, 2025, the date these financial statements were issued.
