1. Description of Plan

The Cimpres USA Incorporated 401(k) Plan (the Plan) is a defined contribution plan which began on July 1, 2000 and covers all employees of Cimpres USA Incorporated, Cimpres Detroit Incorporated, Pixartprinting USA Incorporated, Vistaprint Corporate Solutions Incorporated, Cimpres USA Manufacturing Incorporated, Webs, Inc., and 99Designs Pty Ltd (collectively, the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Eligibility

The Plan states that employees of the Company who are regular full-time and part-time employees are eligible to participate in the Plan on the first day of the month subsequent to beginning employment. Interns and temporary employees are eligible to participate in the Plan on the first entry date after they have completed at least 1,000 hours of service during an eligibility computation period.

Contributions

Participants may defer pre-tax contributions to be made to the Plan through reduction of their compensation as defined in the Plan in amounts up to 80% of their eligible compensation, subject to the applicable Internal Revenue Service (IRS) limit. Participants who are projected to be age 50 or older by the end of the calendar year and who are making pre-tax contributions to the Plan may also make additional "catch up" pre-tax contributions subject to the applicable IRS limit. Rollovers from qualified plans are permitted as well as Roth deferral contributions.

Employees who do not complete a salary deferral agreement will be automatically enrolled in the Plan with a 6% deferral percentage. The automatic contributions will be invested in a default investment fund selected by the Plan.

Discretionary employer matching contributions may be made as determined by the Company. These matching contributions are allocated to any participant who is an employee and is making participant deferrals during the Plan year. Employer matching contributions for the year ended December 31, 2024 were equal to 50% of each participant's voluntary contributions, subject to a maximum employer contribution of 6% of the participant's eligible compensation. Employer contributions are subject to certain limits under the Internal Revenue Code (the Code) and are paid each payroll cycle.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings to account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective contributions plus cumulative earnings thereon. Participants vest in the Company's discretionary contributions and the cumulative earnings thereon as follows: less than one year of service, 0%; after one year of service, 25%; after two years of service, 50%; after three years of service, 75%; after four years of service, 100%. Upon death or disability, participants become 100% vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their accounts once during the Plan year a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms are up to five years (or longer for the purchase of a primary residence). The loans are collateralized by the participant's vested account balance and bear interest at a rate commensurate with local prevailing rates for similar types of loans, as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Any non-vested amounts attributable to Company matching contributions shall be forfeited after a participant terminates employment. The forfeiture will occur in the Plan year that the participant receives a distribution of their entire vested account, or after five consecutive one-year breaks in service. In accordance with Plan provisions, forfeitures are to be used to pay administrative expenses and reduce future Company contributions to the Plan. The balance of forfeited amounts outstanding at December 31, 2024 and 2023 was \$671,894 and \$645,862, respectively. During the year ended December 31, 2024, forfeited amounts of \$67,862 were used to pay such administrative expenses as investment monitoring and recordkeeping fees, and forfeited amounts of \$256,215 were used to reduce Company contributions to the Plan.

Transfers Out

In February 2024, the Plan transferred \$1,326,348 to another qualified plan due to five employees whose employment transitioned from the Company to National Pen Co. LLC (National Pen). National Pen is a subsidiary of the Company with its own separate 401(k) plan. The transfer was completed in accordance with applicable provisions of the Plan.

Payment of Benefits

Upon death, disability, retirement or termination of service, a participant (or their beneficiary) will receive a lump-sum amount equal to the value of the participant's vested balance in his or her account.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right, under the Plan agreement, to amend any or all provisions of the Plan as well as to discontinue contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of the termination of the Plan, each participant shall become fully vested in his or her account at that date.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

Investments are stated at fair value, except for fully benefit-responsive contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurement.

Contract value is the relevant measure for the fully benefit-responsive pooled separate account because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company provides certain administrative and accounting services to the Plan at no cost, including audit fees and legal fees. Administrative expenses incurred by the Plan include loan fees charged directly to the participants' accounts and investment management fees which are netted against investment returns.

Subsequent Events

Subsequent events have been evaluated between December 31, 2024 and October 20, 2025, which is the date the financial statements were available to be issued.

3. Information Prepared and Certified by Trustee

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from the information certified by Fidelity Management Trust Company, the trustee, as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits;
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, line 4i – Schedule of Assets (Held at End of Year).

4. Fair Value Measurements

The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The money market fund seeks to maintain a value of \$1 per share through investments in U.S. government securities.

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts are valued at NAV of shares held by the Plan at year end. NAV is used as a practical expedient, therefore the common collective trust is excluded from the fair value hierarchy below. Withdrawals from the common collective trust are generally permitted daily at book value. The common collective trust seeks to provide income while preventing price fluctuations. The trust invests in traditional guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions to guarantee against fluctuations in their share prices.

5. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with New York Life Insurance Company (NYL Insurance). NYL Insurance maintains the contributions in a pooled separate account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus interest and dividends credited, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has certain restrictions that impact the ability to collect the full contract value.

For example, withdrawals due to events initiated by the Company including, but not limited to, total or partial termination of the Plan, group lay-offs or early retirement incentives, may result in a penalty if these withdrawals exceed limitations defined in the contract. The Company believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

NYL Insurance may not terminate the contract at any amount less than contract value. NYL Insurance is contractually obligated to pay the principal and any interest and dividends that have been credited to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than zero percent. Such interest rates are reviewed not less frequently than quarterly nor more frequently than daily for resetting.

6. Party-in-Interest Transactions

Plan investments include shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest. In addition, notes receivable from participants also qualify as party-in-interest transactions.

7. Tax Status

The Plan was originally established, and all subsequent amendments have been made, under the provisions of the trustee prototype plan. The IRS has determined and informed the trustee by letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the trustee believes that the Plan is designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
