### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Merger***

As further discussed in Note A to the financial statements, effective January 1, 2025 participants were no longer eligible to contribute to the Plan. Effective February 24, 2025, the Plan merged into another plan and, accordingly, all remaining net assets amounting to \$9,715,968 were transferred into the successor plan.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements. In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter***

#### ***Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at year end) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE A - DESCRIPTION OF PLAN AND PLAN MERGER

The following description of the PumpMan Holdings LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective January 1, 2025 participants were no longer eligible to contribute to the Plan, and were instead eligible to contribute into the Harrington Industrial Plastics 401(k) Plan (the "Harrington Plan"). Effective February 24, 2025, the Plan merged into the Harrington Plan and, accordingly, all remaining net assets amounting to \$9,715,968 were transferred into the Harrington Plan.

#### [1] General:

The Plan was a defined contribution plan covering employees of PumpMan Holdings LLC and its subsidiaries (the "Company"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The trustee of the plan was Mid Atlantic Trust Company and the recordkeeper was Paychex Retirement Services ("Paychex").

#### [2] Contributions:

Participants were eligible to contribute up to 90% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions, not to exceed annual limits established in the Internal Revenue Code ("IRC"). Discretionary profit-sharing contributions may be made at the option of the Company's Board of Directors. To be eligible for discretionary profit-sharing contributions, a participant must have completed one year of service in the given Plan year and be employed on the last day of the Plan year. The Company made discretionary profit-sharing contributions in the amount of \$423,728 for 2024. Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

All employees 18 years of age or older, excluding union and non-resident aliens were eligible to participate in the Plan. An employee was eligible to participate in the Plan on the first day of the month coinciding with or on the next following date following the completion of two months of service for all contributions.

The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation.

#### [3] Participant accounts:

Each participant's account was credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings and may be charged with an allocation of administrative expenses paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

#### [4] Vesting:

Participants were immediately 100% vested in their contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions, plus earnings thereon, was as follows:

The Plan provided for 100% vesting of Company discretionary matching contributions and earnings thereon upon death, disability or attainment of normal retirement age of 65.

##### [5] Notes receivable from participants:

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$750, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bear interest at a rate of prime plus one percentage point, as defined. Interest rates on outstanding loan balances range from 4.25% to 9.5% at December 31, 2024 and 2023. Principal and interest were paid ratably through payroll deductions. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. Related fees were recorded as administrative expenses and were expensed when they were incurred.

##### [6] Payment of benefits:

On termination of service, death, disability, or retirement, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over the life of the participant or the joint lives of the participant and a designated beneficiary. In-service withdrawals under the Plan were allowed for hardship as defined in the IRC or the attainment of age 59½.

##### [7] Forfeitures:

Forfeited non-vested accounts were used to reduce future Company discretionary profit-sharing contributions and pay Plan expenses. During the year ended December 31, 2024, there were approximately \$7,800 of forfeitures used to pay Plan expenses. Forfeited non-vested accounts available at December 31, 2024 and 2023 were approximately \$-0- and \$50,400, respectively. There were no forfeitures available at February 24, 2025.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### [1] Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

##### [2] Subsequent events:

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

##### [3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### [4] Payment of benefits:

Benefits are recorded when paid.

##### [5] Plan expenses:

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid directly by the Company were excluded from these financial statements. Recordkeeping and investment advisory fees paid to third parties for services provided to the Plan and fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment-related expenses were included in the net depreciation of fair value of investments.

##### [6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required the Plan administrator to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Mid Atlantic Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of February 24, 2025, December 31, 2024 and December 31, 2023, the statements of changes in net assets available for benefits for the final period from January 1, 2025 to February 24, 2025 and for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification 820 ("ASC 820"), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-ended mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

*Money market fund*: Valued at the quoted net asset values of shares held by the Plan at year-end.

#### **NOTE E - TAX STATUS**

The Plan adopted a Prototype Non-standardized Profit Sharing Plan sponsored by Paychex. On August 31, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believed that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and February 24, 2025, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there were currently no examinations for any tax periods in progress.

#### **NOTE F - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments were managed by Mid Atlantic Trust Company. Mid Atlantic Trust Company was the Plan trustee; therefore, transactions related to these investments qualify as party-in-interest transactions. The Plan also pays a fee to another provider for investment management services. Fees paid by the Plan were approximately \$7,900 and \$28,100 for the final period from January 1, 2025 to February 24, 2025 and the year ended December 31, 2024, respectively.

#### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE H - MUTUAL FUND FEES**

Certain investments in mutual funds were subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees were ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees were used to pay for marketing and distribution costs of the funds. These fees were deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.
